Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements

We have performed an audit of the accompanying financial statements of **Seven Bridges Genomics 401(k) Profit Sharing Plan and Trust**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2023 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of **Seven Bridges Genomics 401(k) Profit Sharing Plan and Trust's** internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about **Seven Bridges Genomics 401(k) Profit Sharing Plan and Trust's** ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2023 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Report on Compiled 2022 Financial Statements

Plan management is responsible for the accompanying 2022 financial statements of the **Seven Bridges Genomics 401(k) Profit Sharing Plan and Trust**, which comprises the statement of net assets available for benefits – modified cash basis as of December 31, 2022, in accordance with the modified cash basis of accounting. We have performed a compilation engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the 2022 financial statements nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by Plan management. Accordingly, we do not express an opinion, a conclusion, or provide any form of assurance on the 2022 financial statements.

NOTE 1: DESCRIPTION OF PLAN

The following description of Seven Bridges Genomics 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was a defined-contribution plan established on September 1, 2013, to provide retirement and other related benefits to employees of Seven Bridges Genomics, Inc. and United Patient Network, Inc. (collectively, the "Company").

All employees of the Company, except excluded employees, were eligible for participation in the Plan immediately upon attainment of age twenty-one. Employees were excluded if they were leased employees, nonresident aliens, or covered by a collective bargaining agreement, unless the agreement required the employees to be included under the Plan. Interns were eligible for the Plan upon attainment of age twenty-one and completion of 1,000 hours of service. Plan entry was the first day of each month. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Merger: The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. On May 23, 2023, the Board of Directors of the Company voted to merge the assets of the Plan into a new 401(k) Plan named Velsera 401(k) Plan, effective January 1, 2024. The merger will also include the assets of another Plan, PierianDx 401(k) Plan, from which the Plan Sponsor has acquired. See Note 3 for discussion of partial plan termination.

Participant Contributions: Each year, participants could contribute an amount up to a certain percentage of their pretax annual compensation, as defined in the Plan. Participants could designate a portion, or all, of their deferred contributions as Roth contributions, which were includable in the participants' gross income. Participants who had attained the age of fifty before the end of the plan year were eligible to make catch-up contributions as prescribed by Treasury regulations. Participants, with the consent of the Plan Administrator, could deposit amounts received from any other retirement plan which satisfied the tax rules for rollovers.

The Plan provided for automatic enrollment for all newly eligible employees. Unless the employee elected otherwise, 6% of the employee's eligible compensation was deferred into the Plan subject to the annual contribution limits set by the Internal Revenue Code ("IRC").

Employer Contributions: In any Plan year, the Company could, at its discretion, make employer matching contributions on behalf of Plan participants. For the year ended December 31, 2023, the Company made matching contributions in an amount equal to 50% on the first 6% of eligible compensation that a participant contributed to the Plan.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Additionally, the Company could make a discretionary non-elective profit-sharing contribution allocated in the ratio that each participant’s compensation bore to the compensation of all eligible participants, provided that the participant completed 501 hours of service during the Plan year or was still employed on the last day of the year. There were no discretionary non-elective contributions made for the year ended December 31, 2023.

Participant Accounts: Each participant’s account was credited with the participant’s contributions, allocations of Company contributions and Plan earnings or losses and charged with an allocation of administrative expenses, if any. Allocations of participant earnings (losses) were based on account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account balance.

Forfeitures: At December 31, 2023 and 2022, forfeited non-vested amounts totaled \$0 and \$9,542, respectively. These accounts were used to reduce employer contributions or pay Plan expenses. During 2023, \$47,181 of forfeitures were utilized to reduce employer contributions. On December 29, 2023, \$63,691 was transferred to the Velsera 401(k) Plan.

Investment Options: Participants directed the investment of contributions into various investment options offered by the Plan.

Vesting: Participants were previously immediately 100% vested in their voluntary contributions, rollover contributions and any actual earnings thereon. Company discretionary matching and nonelective profit-sharing contributions and related earnings were subject to a vesting schedule based on the number of years of service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
After 1 Year of Service	50%
After 2 Years of Service	100%

Notes Receivable from Participants: Participants could borrow from their account balance a maximum equal to the lesser of \$50,000 of all loans outstanding or 50% of their vested account balances. Interest rates on outstanding loans were set at 1% above the prime rate, as defined (8.50% - 9.25% at December 29, 2023). Notes receivable terms could not exceed five years unless for the purchase of a primary residence. Loans were secured by the balances in the participants’ accounts and a promissory note. Principal and interest were paid ratably usually through payroll deductions. If the participant terminated employment, the outstanding principal and accrued interest would continue to be payable in accordance with the loan note. Failure to repay would result in the loan being offset from the participant’s account. The offset loan amount would be considered a taxable distribution to the participant. On December 29, 2023, \$12,241 of notes receivable from participants were transferred to the Velsera 401(k) Plan.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits: On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a partial withdrawal. A participant could also request a withdrawal upon attainment of age 59½, or upon demonstration by the participant to the Plan Administrator that the participant was suffering from a hardship, as defined in the Plan document. The hardship withdrawals were subject to a minimum of \$500. The Plan required a lump-sum distribution if a participant terminated employment, and the vested account balance was less than \$5,000.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements are prepared using the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Under the modified cash basis of accounting, investments are recorded at fair value, contributions are recorded when received and benefits are recorded when paid. The modified cash basis of accounting is an acceptable alternative method of reporting under regulations issued by the Department of Labor ("DOL"). The financial statements have been prepared to satisfy the reporting and disclosure requirements of ERISA.

Investment Valuation and Income Recognition: Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determined the Plan's valuation policies utilizing information provided by the investment advisers, trustees and other parties involved with the Plan. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses: Certain expenses for maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation of fair value of investments.

Use of Estimates: The preparation of financial statements in conformity with the modified cash basis of accounting required Plan management to make estimates and assumptions that affected the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Risks and Uncertainties: The Plan utilized various investment instruments. Investment securities, in general, were exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities could have occurred in the near term and that such changes could have materially affected the amounts reported in the statements of net assets available for benefits – modified cash basis.

Payment of Benefits: Benefit payments to participants were recorded when paid.

Notes Receivable from Participants: Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of December 31, 2023 or 2022.

Uncertain Tax Positions: The modified cash basis of accounting required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan Administrator had analyzed the tax positions taken by the Plan, and had concluded that as of December 31, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE 3: PLAN TERMINATION

During 2023, the Company incurred a reduction in workforce force and as a result, the Plan experienced a partial plan termination as defined by the IRC for the 2023 Plan year. Under the IRC, a partial Plan termination may occur if at least 20% of eligible Plan participants are terminated by the Company within the applicable period. As a result of the partial Plan termination, full vesting in the employer's matching contribution was required for the affected participants, but the remaining participants' vesting continues to be determined per the Plan provisions.

NOTE 4: TAX STATUS

On June 30, 2020, the Internal Revenue Service (“IRS”) stated that the prototype adopted by the Plan, as then designed, was in compliance with the applicable sections of the IRC. The Plan had not received a determination letter specific to the Plan itself; however, the Plan Administrator believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Operational failures were identified during the year ended December 31, 2023. In 2023, participants impacted by the partial Plan termination improperly had amounts forfeited. Participants also had improper true up matching contributions due to errors in eligible compensation, whereby certain pay codes were included or excluded in error. The true up calculation was also deemed to be incorrect due to the calculation not factoring in the last payroll of the 2023 year regarding employee and employer matching contributions. No provision for income taxes has been included in the Plan’s financial statement as Plan Management has engaged its advisors and is in the process of correcting these issues in accordance with applicable IRS and DOL regulations.

NOTE 5: CERTIFICATION OF TRUSTEE

The Plan Administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (“FMTC”), the Trustee, certified that the following data included in the accompanying financial statements were complete and accurate.

NOTE 6: FAIR VALUE MEASUREMENTS

The framework for measuring fair value was determined by using a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gave the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that were observable for the asset or liability;
- inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must have been observable for substantially the full term of the asset or liability.

Level 3 - inputs that are unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used needed to maximize the use of observable inputs and minimize the use of unobservable inputs.

There were no plan assets at December 31, 2023.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2022:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Common/collective trust: Valued at the net asset value of units of a collective trust. The NAV, as provided by the fund manager, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not have been used if it was determined to be probable that the fund would sell the investment for an amount different from the reported NAV.

The preceding methods described may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. While Plan management believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.
