## Notes to Financial Statements

---

### 1. Plan Description

The following description of the Kiosk Information Systems, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan was adopted by Kiosk Information Systems, Inc. (the Company or Employer) effective January 1, 1997 and most recently restated effective January 1, 2022. The Plan is a defined contribution plan covering eligible employees of the Company. The Plan was established under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Trustee, Issuer, and Administration of the Plan*

The trustee is a named individual of the Company and Empower Trust Company, LLC. The issuer of the fixed-rate group annuity contract is Empower Annuity Insurance Company of America. The recordkeeper of the Plan is Empower Retirement (individually and collectively Empower). The third-party administrator of the Plan is Alerus Retirement and Benefits (Alerus). Empower holds all assets of the Plan in accordance with the provisions of the service provider contract with the Company. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Each employee is eligible to become a participant in the Plan on the first day of the month coinciding with or following attainment of age 21 and completion of 30 days of service for all contribution types. Leased employees, union employees, non-resident aliens, residents of Puerto Rico, and temporary employees under contract status are not eligible to participate in the Plan.

#### *Contributions*

Participants may contribute up to 100% of their eligible annual compensation on a pre-tax or after-tax Roth basis, subject to certain IRC limitations. The Plan also allows catch-up contributions for participants aged 50 or older based on IRC limitations.

The Company makes Safe Harbor matching contributions equal 100% of first 3%, plus 50% of the next 2% of compensation the employee contributes to the Plan. The Plan also allows for an additional discretionary matching contribution and a discretionary profit-sharing contribution to eligible employees who complete 1,000 hours of service during the plan year and are employed on the last day of the plan year. This profit-sharing contribution is integrated with social security. No additional discretionary matching or profit-sharing contributions were made for the year ended December 31, 2023.

### ***Rollover Contributions***

Participants' accounts are credited with participant pre-tax, after-tax Roth, rollover, discretionary matching, Safe Harbor matching, and discretionary profit-sharing contributions, as well as an allocation of plan earnings or losses. Participants are charged with certain administrative fees that are paid by the Plan. Earnings or losses from investment funds are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option or based on participant-initiated transactions. Participants may direct the investment of their account balances into various mutual funds and a fixed-rate group annuity contract offered by the Plan. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Notes Receivable from Participants***

An employee may borrow a minimum of \$1,000 up to the lesser of \$50,000 reduced by the excess of the participant's highest outstanding loan balance during the previous 12 months, or one-half of their vested account balance. Participants may not have more than two loans outstanding at any time. The maximum term of the borrowing is five years, unless for the purchase of a principal residence where the loan can be up to 15 years. A participant's loan shall immediately become due and payable if such participant terminates employment for any reason or fails to make a principal and/or interest payment as provided in the loan agreement. The loans are secured by the balance in the participant's account and bear interest at the Wall Street Journal posted prime rate plus 1% and are fixed for the duration of the loan. The interest rate on outstanding loans at December 31, 2023 ranged from 4.25% to 8.00%. Principal and interest are repaid ratably through payroll deductions.

### ***Benefit Payments***

Upon termination of service due to death, disability, separation of service, or attainment of normal retirement age (65), a participant may elect to receive his/her benefit payment in the form of a lump-sum amount, installment payments, or annuity; remain in the Plan; or may roll over the amount to another qualified retirement plan or Individual Retirement Account (IRA). Immediate lump sum distributions are to be made to terminated participants if the participant's vested account balance is \$1,000 or less. If the account balance is \$1,001 to \$5,000, the balance is rolled into an IRA. These mandatory distributions are only made if the participant has not affirmatively elected to receive their distribution in another form. Hardship withdrawals and certain other in-service withdrawals at age 59 ½ are also allowed by the Plan if certain criteria are met.

### ***Vesting***

Participants are immediately vested in their pre-tax, after-tax Roth, rollover, catch-up, Safe Harbor matching, discretionary matching, and discretionary profit-sharing contributions and actual earnings thereon.

### *Revenue Credits*

The Plan's trust agreement with Empower provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits to be used to pay administrative expenses. Unallocated revenue credits at December 31, 2023 and 2022 are de minimis. During 2023, the Plan received credits of approximately \$24,516 which was used to pay administrative expenses. Revenue credits are presented in other income in the statement of changes in net assets available for benefits.

### *Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the terms of the Plan Document to terminate the Plan, subject to the provisions of ERISA.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments in mutual funds, as detailed in the accompanying ERISA-Required supplemental Schedule H, Line 4i, Schedule of Assets (Held at End of Year), are stated at fair value as further discussed in Note 4, *Fair Value Measurements and Disclosures*. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and Empower.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income and capital gains are recorded on the ex-dividend date. The net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses (in the form of an expense ratio) charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and reflected as a reduction of investment return for such investments.

### *Contributions*

Participant contributions, Safe Harbor matching contributions, and discretionary matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Employer profit sharing contributions would be recognized when

due to the Plan. A true-up matching contribution is performed after year end and any amounts due to participants are recorded in the period to which the true-up contribution relates.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. Any accrued but unpaid interest was de minimis at December 31, 2023 and 2022. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### ***Benefit Payments***

Benefit payments to participants are recorded upon distribution.

### ***Administrative Expenses***

During the year ended December 31, 2023, administrative fees totaling \$98,082 were paid by the Plan for distribution processing, recordkeeping, loan administration, and investment management fees. During 2023, the Plan received expenses account deposit of \$24,516 which was used to pay administrative expenses. Expense account deposits are presented in other income in the statement of changes in net assets available for benefits. Under the service provider agreement with Empower, certain revenue sharing rebates received from certain mutual funds held by the Plan reduce recordkeeping fees. Fees in excess of the rebates are charged to the Plan. Certain other fees and expenses may be charged within the investments (as an expense ratio) and are reflected in the net appreciation in fair value of investments. The Company, on behalf of the Plan, paid all other administrative expenses of the Plan, and those expenses are excluded from these financial statements.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, qualified institutions.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 4. Fair Value Measurements and Disclosures

Accounting Standards Codification (ASC) 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - This level consists of inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2023 and 2022:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Accounting for Investment Contracts with Insurance Company

The Plan entered into the Key Guaranteed Portfolio Fund (the Fund) with Empower, which is a fixed-rate group annuity contract. The Fund meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts since this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The Fund is a general account product and is credited with participant and employer contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to pay the principal and specified interest rates guaranteed. The effective annual interest rate can never be less than 0% and interest earned is compounded daily to the effective annual interest rate. The interest crediting rate is reset quarterly. The method for calculating the interest crediting rate is based on earnings of the underlying assets in the entire medium long-term portfolio compared to the minimum crediting rate, as stated in the contract, and prevailing market conditions.

Certain events could limit the ability of the Plan to transact at contract value, including but not limited to, premature termination of the contract by the Plan, plan termination, bankruptcy, mergers, and early retirement incentives. This would cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from the contract value; however, the plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

## 6. Related Party and Party-In-Interest Transactions

The Plan invests in mutual funds and a fixed-rate group annuity contract with Empower, the trustee and issuer of the fixed-rate group annuity contract of the Plan. Participant loan and distribution processing fees are paid to Empower by participants. The Plan also received revenue credits from Empower. The Plan paid for third party administrator fees and investment advisory fees. The Plan also issues loans to participants which are secured by the vested balance of the participants'

accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions which are exempt from prohibited transaction rules.

### **7. Income Tax Status**

The Company has adopted a pre-approved plan, which has received its latest opinion letter from the Internal Revenue Service (the IRS) sponsored by Alerus Financial NA dated June 30, 2020, stating that the form of the Pre-approved Plan is qualified under Section 401 of the IRC, and therefore, the related trust is tax- exempt. The Plan has since been amended; however, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable provisions of the IRC and the Plan and related trust continue to be tax-exempt; therefore, no provision for income taxes have been included in the accompanying financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### **8. Subsequent Events**

The Plan has performed an evaluation of subsequent events through October 14, 2024, which is the date the financial statements were available to be issued. Effective January 1, 2024, Company entered into an agreement with Fidelity Management Trust Company (Fidelity) for recordkeeping and trustee services. On February 9, 2024, the assets of approximately \$ 8.7 million were transferred from Empower to Fidelity. Management has determined that there were no other material events requiring recognition or disclosure.
