INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of the National Product Sales, 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the National Product Sales, 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



Responsibilities of Management

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

(1) Description of the Plan

The following description of the National Product Sales, 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the Plan administrator.

- A. **General** – The Plan, which commenced on April 1, 2008, is a defined contribution plan covering all eligible employees of National Product Sales, Inc. (the “Company” or “Plan sponsor”), as defined in the Plan document. The Plan is designed to qualify under Sections 401(a) and 401(k) of the Internal Revenue Code (the “Code”) as amended and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by the Administrative Committee who has overall responsibility for the operation and administration of the Plan. The Administrative Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

In January 2022 the Plan document was restated to incorporate changes to address applicable sections of the Code. The restatement did not result in substantive changes to the Plan’s provisions.

The Plan has arranged for Great-West Life and Annuity Insurance Company and Great-West Trust Company, LLC (“Custodian”) to serve as Custodian and to provide record keeping services for the Plan (the “Recordkeeper”). During 2022, Great-West changed its operating names to Empower Annuity and Insurance Company of America and Empower Trust Company, LLC (“Empower”). These name changes did not affect custodial, or recordkeeping services being provided to the Plan by the Custodian and Recordkeeper.

- B. **Contributions** – Employees are eligible to participate in the Plan on the first day of the month upon reaching age 18 and after completing two months of eligible service. Participants can elect to contribute up to 100% of their annual eligible earnings on a pre-tax basis, each subject to the maximum amount allowable by the Internal Revenue Service (“IRS”) (\$22,500 for participants to age 50 and \$30,000 for participants over 50 years of age for the year ended December 31, 2023). Participants may also make Roth contributions on a post-tax basis. Participants may also contribute amounts representing distributions from other tax qualified retirement plans. In addition, the Company may make discretionary employer matching contributions to the Plan each year in amounts determined by the Company. During the year ended December 31, 2023, discretionary employer matching contributions were made based on 10% of the participant’s deferral as calculated on a pay period basis.
- C. **Participant accounts** – Each participant’s account is credited with the participant’s contributions, employer discretionary matching contributions, and the Plan’s earnings and losses, and is charged with an allocation of administrative expenses. Allocations are based on participants’ earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- D. **Vesting** – Participants are immediately vested in their voluntary contributions, earnings thereon, and rollover contributions. Participants vest in the discretionary employer matching contributions as follows:

More than 2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 or more years	100%

Participants also become 100% vested when the participant reaches normal retirement age (65), incurs a disability as defined by the Plan, or upon death.

(1) Description of the Plan (continued)

- E. **Participant investment account options** – The Plan currently offers various pooled separate accounts and a fixed interest contract as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.
- F. **Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans have terms from 1 year up to 5 years. Loans for the purchase of a principal residence may have terms up to 15 years. The maximum number of loans a participant may have outstanding under the Plan is two. Loans are secured by the balance in the participant's accounts and bear interest at fixed interest rates based on the custodian's prime rate of interest on the date of the loan. Interest rates on notes receivable as of December 31, 2023 ranged from 3.25% to 8.50%. Principal and interest are paid ratably through semi-monthly payroll deductions.
- G. **Payment of benefits** – Participants may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Benefit payments are made in a lump sum distribution or rollover contributions to another plan. Participants who terminate employment with an account balance of less than \$1,000 may receive an automatic lump sum distribution of their balance. Participants who terminate employment with an account balance of less than \$5,000, but more than \$1,000 may receive an automatic direct rollover of their account balance to an Individual Retirement Account.
- H. **Forfeited accounts** – At December 31, 2023 and 2022, forfeited non-vested accounts in the Plan totaled \$0 and \$0, respectively. Forfeited non-vested accounts represent discretionary employer matching contribution forfeitures, corrections to participant accounts, or excess employer contributions. During the year ended December 31, 2023, \$1,839 of forfeited amounts were used to offset discretionary employer matching contributions.

(2) Summary of significant accounting policies

Basis of accounting – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value, except for the fixed income account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions – Contributions from Plan participants and discretionary employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

(2) Significant accounting policies (continued)

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the participant's account as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022.

Excess contributions refundable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. For the year ended December 31, 2023, there were no excess contributions due to participants. The amount accrued for excess contributions for the year ended December 31, 2022 was \$5,735. The Plan distributed the 2022 excess contributions prior to March 15, 2023.

Payments of benefits – Benefits are recorded when paid.

Administrative expenses – Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses, net of revenue sharing, are included in net appreciation in fair value of investments.

(3) Information prepared and certified by the Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Retirement Trust Company has certified the following data accompanying financial statements and supplemental schedule of assets (held at year end of year) with regards to the Plan's pooled separate accounts, and Empower Annuity Insurance Company of America has certified the following data included in the accompanying financial statements and schedule of assets (held at end of year) with regards to the Plan's fixed interest account, is complete and accurate with respect to investments as of December 31, 2023 and for the year ended December 31, 2023:

- Investments
- Notes receivable from participants
- Interest income from notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividend income
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

(4) Fair value measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

(4) Fair value measurements (continued)

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2023 and 2022.

Pooled separate accounts: Valued at the net asset value ("NAV") of units of the separate accounts. The NAV, as provided by the Custodian, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

In accordance with Subtopic 820-10, the fair value of the investments in the pooled separate accounts has been measured using the NAV per share (or its equivalent) practical expedient, therefore, there they are not included in the fair value hierarchy. The pooled separate accounts are redeemed on a daily basis and do not have any redemption restrictions. Additionally, there are no unfunded commitments.

(5) Fixed income account

The Plan invests in a fully benefit-responsive fixed income account, which is reported at contract value. The contract value is the aggregation of contributions, plus interest, less withdrawals, if any. The methodology for calculating the interest is listed in Section 1.0 of the agreement under the term "Fixed Account Crediting of Interest." Under the terms of the existing contract, the interest rate is guaranteed for any calendar quarter to the end of the calendar year, and for each subsequent calendar year, the account is credited at a rate not less than a "Declared Interest Rate" for that calendar year. The initial minimum guaranteed interest rate of 1.0% remained in effect until December 31, 2013 after which the rate is re-determined annually. The fixed income account issuer is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan.

Because the fixed income account is fully benefit-responsive, contract value is the relevant measurement attribute for the net assets available for benefits. The fixed income account is presented on the face of the statements of net assets available for benefits at contract value as of December 31, 2023 and 2022. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the account value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1.0%. Such interest rates are reviewed on an annual basis for resetting.

(5) **Fixed income account (continued)**

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator, outside of those events disclosed, does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

(6) **Party-in-interest transactions**

Certain investments of the Plan are managed by Empower. Empower is the Plan's Custodian, and therefore, the transactions are considered exempt party-in-interest transactions. Fees incurred by the Plan for certain investment management services are paid through a revenue sharing agreement. The Plan Sponsor pays directly any other fees related to the Plan's activities. Administrative expenses paid to the Plan's Custodian and investment advisor qualify as party-in-interest transactions and totaled \$846 for the year ended December 31, 2023.

(7) **Plan termination**

The Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the discretionary employer matching contribution.

(8) **Tax status**

The IRS has determined that the prototype 401(k) profit sharing plan document is designed in accordance with applicable sections of the IRC and informed the Custodian of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan's Retirement Committee believes that the Plan and the related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) **Risks, uncertainties, and concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2023, and 2022, one of the Plan's investments was an option which individually represented approximately 15% of the Plan's investments.

(10) Delinquent participant contributions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employee's general assets. During the year ended December 31, 2022, employee contributions totaling \$19,934 were not remitted to the Plan until after the required time period. Lost earnings were remitted to the Plan in October 2023. During the year ended December 31, 2023, employee contributions totaling \$9,045 were not remitted to the Plan until after the required time period. Lost earnings were remitted to the Plan in October 2024.

(11) Subsequent events

In November 2023, the Administrative Committee voted to merge the Plan into the Associated Food Stores, Inc. 401(k) Plan and Trust as an unrelated adopting employer. In January 2024, the majority of the Plan assets were transferred to the Associated Food Stores, Inc. 401(k) Plan and Trust under the direction of Plan management. Management is in the process of distributing the plan assets which did not transfer, which consist of the Fixed Income Account, in accordance with the terms of that contract, which require the impacted participants to request a distribution or for funds to be distributed to the Associated Food Stores, Inc. 401(k) Plan and Trust annually through the year ended December 31, 2029.

The Plan has evaluated subsequent events through the date of the independent auditors' report which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
