Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Direct Mail of Maine, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Direct Mail of Maine, Inc. 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Direct Mail of Maine, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets Held at End of Year is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Direct Mail of Maine 401(k) Profit Sharing Plan

Note A - Description of Plan

The following description of the Direct Mail of Maine 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by Direct Mail of Maine, Inc. (the “Company” or the “Employer”) to encourage and assist eligible employees of the Company to adopt a regular program of savings to provide additional financial security for retirement. The Plan was established by the Company effective January 1, 1996, and was restated as of October 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”), and the Internal Revenue Code (“IRC”).

Eligibility

Each non-union employee of the Company who is age 18 or older is eligible to participate in the Plan after the completion of one month of service, as defined in the Plan. Contributions to the Plan can begin the first payroll cycle upon meeting the eligibility requirements.

Contributions

Each year, participants may contribute to the Plan a percentage or dollar amount of pretax annual compensation, as defined in the Plan, subject to certain limitations set forth by the Internal Revenue Code. The Plan also offers a Roth feature allowing for after-tax salary deferrals. Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2022, the Company implemented a safe harbor matching contribution equal to 100% of employee salary deferrals that do not exceed 3% of compensation, plus 50% of salary deferrals between 3% and 5% of compensation. Participants must be at least 18 years of age and complete one month of service to be eligible for a match. Employee deferrals and employer match contributions are funded on a payroll basis. All contributions are subject to certain limitations.

In addition, the company may elect to make a non-elective contribution; such contributions are to be allocated to all eligible participants based on earnings.

Notes to Financial Statements

Note A - Description of Plan - Continued

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, allocations of any Company's profit sharing contributions, Plan earnings (losses), and forfeitures. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of Company profit sharing contributions and forfeitures are based upon the ratio of the participant's earnings to earnings of all eligible participants. The allocation of administrative expenses is based upon specific participant transactions or as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting and Withdrawals

Participants are immediately fully vested in their voluntary contributions, employer safe harbor contributions, and the earnings or losses thereon.

Employer discretionary matching and profit sharing contributions are vested as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
At least 1 year, but less than 2	20%
At least 2 years, but less than 3	40%
At least 3 years, but less than 4	60%
At least 4 years, but less than 5	80%
5 years or more	100%

Additionally, participants become fully vested in Company contributions upon death, disability, or upon reaching the retirement age as defined in the Plan document.

Withdrawals are permitted from a participant's account prior to termination of employment, in the case of death, disability or financial hardship (as defined by the IRC). Participants who have reached age 59½ may receive an in-service distribution of all or part of their elective account, including Roth deferrals and qualified non-elective account.

Note A - Description of Plan - Continued

Notes Receivable from Participants

Participants may borrow a minimum of \$500 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum note repayment period is five years unless used to acquire a principal residence, in which case the loan must be entirely repaid within a period not to exceed thirty years of the date the loan proceeds are received.

Participants may have up to two loans outstanding at any time; provided, however, that only one loan with an initial term greater than five years may be outstanding at any time. Participant notes are collateralized by the participant's vested interest in their account balance. Principal and interest payments with respect to the notes are credited solely to the account of the borrowing participant from which the note was made. Interest rates on participant notes ranged from and 4.25% to 9.50% as of December 31, 2023, with various maturity dates through 2031.

Payment of Benefits

For termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the vested balance or annual installments in accordance with plan provisions. For termination of employment for other reasons, if the nonforfeitable portion of a participant's account balance is not more than \$5,000, the vested portion will be paid in a lump sum as soon as practicable thereafter. For vested balances in excess of \$5,000 the participant will be notified of the right to defer payment; participants requesting a distribution will receive an explanation of the consequences of failing to defer.

Forfeited Accounts

When termination of participation in the Plan occurs, the nonvested portion of the participant's account, as defined by the Plan, represents forfeitures. Forfeitures are utilized to pay administrative expenses or to reduce future discretionary employer matching contributions. There were no forfeited balances at December 31, 2023 and 2022.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with United States generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Note B - Summary of Significant Accounting Policies - Continued

Notes Receivable from Participants

Notes receivable are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the outstanding loan balance will be included in participants' gross income for federal income tax purposes as if it were distributed to him or her.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected in the net change in fair value of investments for such investments.

Administrative Expenses

Professional and administrative expenses of the Plan, at the Company's election, may be paid out of the Plan or directly by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain fees are assessed by the custodian or trustee for the processing of participant loans and participant withdrawals, and are charged directly to the participant's account. In addition, personnel and facilities of the Company are used by the Plan for its accounting and other activities at no charge to the Plan.

Payment of Benefits

Benefits are recorded when paid.

Note C - Information Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform, and they did not perform any auditing procedures with respect to information certified by Reliance Trust Company, the custodian of the Plan as of December 31, 2023 and 2022, except for comparing information certified by the custodian to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has obtained certifications from the custodian for 2023 and 2022 that such information is complete and accurate.

Note D - Fair Value Measurements (Unaudited)

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 defines fair value and establishes a framework for measuring fair value through a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note D - Fair Value Measurements (Unaudited) - Continued

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: The Plan uses the NAV per share provided by the trustee as a practical expedient to estimate fair value. The practical expedient would not be used if it were determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions may occur daily. The fund's units are issued and redeemed daily. The NAV is based on fair market value of the underlying investments held by the fund less its liabilities. The collective trusts have no unfunded commitments, other redemption restrictions or redemption notice periods.

Note E - Related Party and Party-in-Interest Transactions

Certain Plan investments are shares in common/collective trust accounts managed by MetLife, a sub-custodian and, therefore, these transactions qualify as party-in-interest transactions. Participant notes receivable transactions are also considered to be party-in-interest transactions because they are transacted with Plan participants. During 2023, the Plan paid certain direct trustee and recordkeeping fees totaling \$17,181.

Note F - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note G - Tax Status

The Company, as the Plan's sponsor, adopted a prototype plan, which received an Internal Revenue Service ("IRS") opinion letter dated October 6, 2020, which states that the prototype document satisfies the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan has subsequently been amended; however, the Plan's management and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC, and that the Plan continues to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Note H - Risks and Uncertainties

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and statement of changes in net assets available for benefits.

Note I - Subsequent Events

Effective July 3, 2024, as a result of the sale of Direct Mail of Maine, Inc. to an outside third party, the Board of Directors voted to terminate the Plan.

Management has made an evaluation of subsequent events to and including October 14, 2024, which was the date the financial statements were available to be issued and determined that any subsequent events that would require recognition or disclosure have been considered in the preparation of the financial statements.
