Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

December 31, 2023 And 2022

1. Description Of The Plan

The following brief description of the Pixel-Docmation 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution plan, was established June 1, 2007 and is sponsored by BV-Pixel Acquisition, LLC (the Company). The Plan was restated effective January 1, 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Merger

On December 29, 2023, the Company approved a resolution to freeze the Plan effective immediately and merge the Plan into the Interpublic Group of Companies, Inc. Savings Plan.

Eligibility

The Plan covers substantially all employees of the Company excluding union employees, nonresident aliens and residents of Puerto and related employers Rico, Docmation, LLC, PixelMEDIA, LLC and BV-Pixel Acquisition, LLC, who have completed six months of service. Once eligible, employees may enter the Plan on the first day of the month after satisfying the eligibility requirements.

Plan Administration

Reliance Trust Company is the Plan's Custodian and Standard Insurance Company is the Plan's recordkeeper.

Contributions

Participants can contribute up to 100% of their annual compensation up to the maximum amount allowed by the law, as defined in the Plan Document, as pre-tax contributions, Roth contributions, or a combination thereof. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

PIXEL-DOCMATION 401(k) PLAN

Notes To Financial Statements *(Continued)*

The Company provides an employer safe harbor matching contribution equal to 100% of participant deferral contributions, not to exceed 4% of eligible compensation.

The Company also provides for a discretionary matching contribution equal to 100% of participant deferral contributions, not to exceed 6% of eligible compensation. No such discretionary matching contributions were made during 2023 or 2022.

Vesting

Participants are immediately 100% vested in their contributions and the Company safe harbor matching contributions plus actual earnings thereon.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, safe harbor matching contributions and an allocation of Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

Active participants, with some exceptions, may borrow from their account a minimum of \$500 or up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Note terms range from one to five years or up to fifteen years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at the prime rate. Principal and interest are paid ratably through weekly and bi-weekly payroll deductions. Participants may at any time prepay the entire amount due on the loan in one lump sum or make partial prepayments in any amount.

Payment Of Benefits

Participants are entitled to receive the balance of their accounts upon death, total disability, retirement, or termination of employment in the form of a lump-sum, equal installments, or partial withdrawals.

In-Service Withdrawals

Participants who attain the age of 59-1/2 may withdraw any portion of their vested account balance. In certain circumstances, a participant may elect a hardship distribution, as defined in the Plan Document. Hardship distributions are permitted from participant pre-tax deferrals, roth deferrals, employer matching contributions and rollover funds.

Administrative Expenses

A significant portion of the administrative expenses of the Plan are paid by the Company. The Plan pays expenses related to transactions and recordkeeping fees. Investment-related expenses are included in the net change in fair value of investments.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any of a variety of investment options available.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are maintained on an accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments, other than the fully benefit-responsive investment contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Standard Insurance Company Stable Asset Fund is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

Contributions Receivable And Credit Loss Policy

As of January 1, 2023, the Plan adopted Accounting Standards Codification Topic 326, *Financial Instruments - Credit Losses*, using a modified-retrospective approach. The standard replaces the previous incurred loss model and requires entities to record an estimate of expected losses on financial assets for the remaining estimated life of the asset. This estimate must include consideration of historical experience, current conditions and reasonable and supportable forecasts. The standard applies to the Plan's participant deferral receivables and Company matching contributions receivable. The adoption did not have a material impact on these financial statements.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2023 and no allowance for doubtful accounts was necessary at December 31, 2022.

Payment Of Benefits

Benefit payments are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2023 and for the year ended December 31, 2023, included throughout the Plan's financial statements that was prepared by or derived from information certified by the Custodian, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the Custodian that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31, 2023:

4. Fair Value Measurements

The Plan follows current accounting standards, which establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;

 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Registered Investment Companies

Registered investment companies are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the Plan merger, there were no investment assets held by the Plan as of December 31, 2023.

5. Investment Contract With Insurance Company

The Plan invests in a fully benefit-responsive investment contract with Standard Insurance Company. Standard Insurance Company maintains the contributions in a separate account. The investment account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the account. Contract value, as reported to the Plan by Standard Insurance Company, represents contributions plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon schedule with the issuer and is reset on a semi-annual basis.

Certain events may limit the ability of the Plan to transact at contract value. Such events include, but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification.

6. Income Tax Status

The Plan adopted a pre-approved defined contribution plan sponsored by Standard Retirement Services, Inc., for which a favorable IRS opinion letter was received dated June 30, 2020. The Plan has been amended since the date of the opinion letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party In Interest Transactions

The Plan has a service agreement with Standard Insurance Company to provide administrative and recordkeeping services. Certain participants have outstanding loans as of December 31, 2022. These transactions qualify as allowable party in interest transactions.

8. Reconciliation Of Financial Statements to Form 5500
