INDEPENDENT AUDITORS' REPORT

To the Management and 401(k) Oversight Committee of the SpringBoard, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the SpringBoard, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Emphasis of Matter

As discussed in Note 5 to the financial statements, the SpringBoard, Inc. 401(k) Plan was terminated effective December 29, 2023 and all assets were transferred to the Ingenovis Health, Inc. 401(k) Plan. Our opinion is not modified with respect to this matter.

DECEMBER 31, 2023 AND 2022

(1) DESCRIPTION OF THE PLAN

The following description of the SpringBoard, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan covering all employees of SpringBoard, Inc. (the “Company”), who met eligibility requirements. The Plan was established effective June 1, 2015. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was a profit-sharing plan, which qualified under Section 401 and 401(k) of the Internal Revenue Code of 1986. The Plan provided for retirement, disability, and death benefits for eligible employees.

On December 29, 2022, the SECURE Act 2.0 was signed into law. This legislation builds on the 2019 Setting Every Community Up for Retirement Enhancement Act (the “SECURE Act”) and includes several provisions that have impacted the Plan. These provisions include changes to contribution limits, catch-up contributions, hardship distributions, and required minimum distributions, as well as new rules for part-time employees and student loan borrowers. The Company evaluated the impact of the SECURE Act 2.0 on the Plan and implemented any necessary changes in accordance with the law.

Effective January 1, 2023, the Plan was amended to provide clarification on the Plan's eligibility requirements and to change the Plan’s trustees. These modifications were made to enhance the governance of the Plan and ensure clear communication to participants.

Effective December 29, 2023, the Plan was terminated and its assets were transferred to the Ingenovis Health, Inc. 401(k) Plan which assumed responsibility for future administration, participant contributions, and benefit distributions.

Administration

The Plan was sponsored by the Company and was administered by the 401(k) Oversight Committee (the “Plan Administrator”).

John Hancock Life Insurance Company (U.S.A.) served as the Plan’s custodian and performed record keeping services. Edberg & Perry, Inc. performed administrative services and prepared the Plan’s Form 5500. ABLE Financial Group was the Plan’s investment advisor.

Eligibility

Employees became eligible to participate in the Plan after completing one month of employment with the Company.

(1) DESCRIPTION OF THE PLAN (Continued)

Contributions

Each year, participants were able to contribute 1% to 100% of pre-tax annual compensation, not to exceed \$22,500 and \$20,500 in 2023 and 2022, respectively, as an elective deferral. Employees at least 50 years old were able to contribute a maximum of \$30,000 and \$27,000 in 2023 and 2022, respectively. The Company determined the amount of the matching contribution to be made. A participant must have made elective deferrals to the Plan in order to share in the employer match. The Company contributed to the participants account, 50% on the first 3% of each respective participant's elective deferral in 2023 and 2022.

Roth Designated Contributions

Participants were able to elect to have all or part of their salary reduction 401(k) contributions be made to the Plan as Roth after-tax 401(k) contributions. In this case, the participant would have to pay income tax on these contributions when the contributions were made to the Plan. If the requirements were met for a qualified distribution, the subsequent distribution to the participant of his or her Roth after-tax 401(k) contributions, and the investment earnings thereon, would be tax-free.

Excess Contribution Refundable

Corrective distributions may have been required to certain active participants to return to them excess deferral contributions as required to satisfy the relevant non-discrimination provisions of the Plan. These amounts, plus interim investment income or less interim investment loss, were refunded in the year following the respective excess deferral contributions. There were no excess participant deferral contributions relating to 2023 or 2022.

Vesting

Participants were immediately vested in their elective deferral contributions. Vesting on the employer matching contributions, and earnings allocable to these contributions, was based on years of continuous service with the participant becoming 20% vested at two years and then another 20% each year after until the participant was fully vested. Additionally, a participant became 100% vested upon the attainment of normal retirement age, total and permanent disability, or death.

Participant Accounts

Each participant's account was credited for his or her contributions on a cash basis when received by the Plan's custodian. In addition, each participant's account was credited with an allocation of the employer's matching contribution and earnings thereon. The employer matching contribution was allocated to the investment funds in the same relationship as the employee elective deferral contributions. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(1) DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants

Participants were able to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years (loans for the purchase of a primary residence could exceed five years). The loans were secured by the balance in the participant's account and bore interest at the prime rate in effect at the respective loan's origination, plus 2%. Principal and interest were paid through payroll deductions.

Investment Options

The Plan provided investment funds for the participants to invest their contributions. The available options included funds with varying allocations between equity and debt. The participants were able to elect to have their elective deferral contribution invested in any fund or combination of funds provided by the Plan. Participants were able to change their investment options at any time.

Forfeited Accounts

Non-vested portions of participant accounts were forfeited upon termination of employment. Forfeited amounts were able to be used to reduce the employer matching contributions or pay plan expense. During 2023 and 2022, forfeited amounts were \$72,405 and \$109,737, respectively. During 2023 and 2022, forfeitures totaling \$56,357 and \$13,130, respectively, were used to reduce employer matching contributions. During 2023 and 2022, forfeitures totaling \$30,908 and \$0, respectively, were used to pay administrative expenses. Forfeited accounts totaling \$82,263 were transferred to the Ingenovis Health, Inc. 401(k) Plan on December 29, 2023. At December 31, 2023 and 2022, forfeited accounts totaled \$0 and \$97,122, respectively.

Benefit Payments

A participant was able to receive in installment payments (if the account balance was greater than \$5,000), lump sum, or rollover distributions, the vested portion of their account upon attainment of age 59½ or termination of employment due to death, disability, retirement, or certain other circumstances.

(2) SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

(2) SUMMARY OF ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for doubtful accounts is necessary as any defaulted note receivable would be treated as a taxable deemed distribution to the participant.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The Plan presents in the accompanying statements of changes in net assets available for benefits the net investment income, which consists of the realized gains or losses, the unrealized appreciation or depreciation on those investments, capital gain distributions, and dividends.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payments of Benefits

Benefits are recorded when paid. At December 31, 2023 and 2022, all benefits requested had been paid.

Risk and Uncertainties

The Plan invested in a variety of investments which are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it was reasonably possible that changes in the values of investments could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(3) PLAN EXPENSES

The Company incurred a portion of the expenses pertaining to administration of the Plan, including accounting personnel and third party administrator fees.

Administrative expenses of \$103,333 and \$97,613, including loan and distribution fees of \$10,150 and \$51,480, for 2023 and 2022, respectively, were paid by participants.

(3) PLAN EXPENSES (Continued)

The investment funds were also subject to asset-based fees. These fees were taken out of the investment funds' assets, which lowered the returns generated by the investment funds. A portion of these fees were paid to the Plan's service providers. The remaining portion was used to pay investment fund operating costs and the various fund managers.

(4) INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.), a qualified institution, has certified the following investment information included in the accompanying financial statements is complete and accurate to the best of their knowledge and belief.

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2023 and 2022.
- Net investment income (loss) and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2023 and 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

(5) PLAN TERMINATION

As discussed in Note 1, the Company exercised its right to terminate the Plan effective December 29, 2023. As part of this termination, all plan assets were transferred to the Ingenovis Health, Inc. 401(k) Plan, which has assumed responsibility for the ongoing administration.

(6) TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan was amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan was designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan has not taken any uncertain income tax positions that would require recognition of a liability or disclosure in the Plan's financial statements. The Plan may be subject to routine audits by tax authorities but is not currently under audit. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

(7) RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The Plan's financial statements are prepared on the accrual basis of accounting, whereas the Plan's Form 5500 is prepared using a modified cash basis of accounting. For the years ended December 31, 2023 and 2022, there were no reconciling items between the net assets available for benefits as reported in the financial statements and the Form 5500.

(8) POOLED SEPARATE ACCOUNTS

The Plan invested in mutual funds via pooled separate accounts managed by John Hancock Life Insurance Company (U.S.A.), the Plan's custodian. Therefore, these qualified as party-in-interest transactions.

The pooled separate accounts were able to be redeemed on a daily basis at net asset value ("NAV") as of the measurement date. The NAV was used as a practical expedient to estimate fair value.

(11) SUBSEQUENT EVENTS

Management has evaluated all subsequent events through the date the financial statements were available to be issued on October 14, 2024. No subsequent events occurred during this period which require adjustment to or disclosure in the financial statements.


