### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Kentucky Trailer 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## **2022 Financial Statements**

The financial statements as of December 31, 2022, were audited by MCM CPAs & Advisors LLP, which was acquired by Cherry Bekaert LLP as of October 31, 2023. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated September 13, 2023, indicated that (a) the amounts and disclosures in the 2022 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2022 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2022 supplemental schedule, other than the information in the 2022 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2022 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ## NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2023 AND 2022

---

### Note 1—Description of the Plan

The following description of the Kentucky Trailer 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

*General* – The Plan was a defined contribution plan established by R.C. Tway Company, DBA Kentucky Trailer and adopting subsidiaries (collectively, the "Company" or "Plan Sponsor"). The Plan covered all employees of the Company who were not covered by a collective bargaining agreement, had attained age twenty-one prior to January 1, 2023 and age eighteen as of January 1, 2023 and had completed three months of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan Sponsor was acquired by Marmon Holding, Inc. on January 1, 2023. In December of 2023, the board of directors approved the merger of the Kentucky Trailer 401(k) Retirement Plan into the Marmon Holdings, Inc. Retirement Plan. Total assets of \$44,129,668 were transferred from the Plan to Marmon Holding, Inc. Retirement Plan on December 31, 2023.

*Administration* – The Plan Sponsor had designated certain employees, who served without additional compensation, to administer the Plan. The Plan administrator had the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

*Contributions* – Upon meeting eligibility requirements as defined in the Plan Agreement, participants of the Plan were permitted to make pre-tax and after-tax Roth contributions to the Plan up to 100% of their annual eligible compensation. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Plan Agreement provided for automatic enrollment of eligible employees at a pre-tax deferral rate of 1% of eligible compensation, unless the participant affirmatively elected otherwise. The Plan also provided for a 1% annual increase in the deferral rate (up to a maximum of 5% of eligible compensation). Effective January 1, 2022, the Plan was amended to provide for a Company safe harbor matching contribution equal to 100% of the first 3% of compensation contributed by the participant plus 50% of compensation contributed between 3% and 5%. Additional Company contributions were permitted at the discretion of the Plan Sponsor; however, no such contributions were made for the 2023 Plan year. Participants could also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. Contributions were subject to certain limitations as outlined in the Internal Revenue Code ("IRC").

*Participant Accounts* – Individual accounts were maintained for each Plan participant. Each participant's account was credited with the participant's contributions and Company safe harbor matching contributions, and an allocation of Plan investment results. Participant accounts were charged with their withdrawals and an allocation of administrative expenses paid by the Plan. Allocations were based on participant earnings, specific participant transactions or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

*Vesting* – Participants were immediately vested in their voluntary contributions and Company safe harbor matching contributions plus actual earnings thereon. Vesting in other Company contribution accounts was based on years of continuous service, with participants becoming 100% vested after five years of credited service.

*Investment Options* – Upon enrollment in the Plan, participants could direct the investment of their accounts into various investment options offered by the Plan. They could change their investment options among those investments provided at any time during the Plan year.

### Note 1—Description of the Plan (continued)

*Notes Receivable from Participants* – Participants could borrow from their individual fund balances. Participant loans could be for any purpose, classified as either a general purpose or residential purpose loan (as defined in the Plan Agreement), and were limited to the lesser of \$50,000 or 50% of the vested portion of the participant's account balance. The loans were secured by the balance in the participant's account and bore interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest were repaid ratably through payroll deductions.

*Payment of Benefits* – Upon termination of service or attaining normal retirement age, a participant could have elected to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments not exceeding the participant's life expectancy. In-service and hardship withdrawals were also allowed as defined in the Plan Agreement.

*Forfeited Accounts* – The nonvested portion of former participants' accounts could be used to pay administrative expenses of the Plan or to reduce the amount of future employer contributions. Forfeited accounts approximated \$-0- and \$1,281 at December 31, 2023 and 2022, respectively. During the Plan year ended December 31, 2023, forfeitures approximating \$1,409 were used to pay administrative expenses.

### Note 2—Summary of significant accounting policies

*Basis of Presentation* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan's investments were reported at fair value (except for fully benefit-responsive investment contracts, which were reported at contract value). U.S. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the Plan year.

*Investment Management Fees and Operating Expenses* – Investment management fees and operating expenses charged to the Plan for certain investments were deducted from income earned on a daily basis and were not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

*Notes Receivable from Participants* – Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were charged directly to the borrowing participant's account and were included in administrative expenses when incurred. No allowance for credit losses was recorded as of December 31, 2023 and 2022. If a participant ceased to make loan repayments and the Plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

*Payment of Benefits* – Benefits were recorded when paid. There were no benefit payments requested and not yet disbursed at December 31, 2023 and 2022.

### Note 2—Summary of significant accounting policies (continued)

*Administrative Expenses* – Administrative expenses of the Plan were paid by the Plan Sponsor or Plan participants, as defined in the Plan Agreement.

### Note 3—Information certified by the qualified institution (unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Minnesota Life Insurance Company ("Minnesota Life"), a qualified institution, has certified to the completeness and accuracy of the following data included in the accompany financial statements.

- Investments at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2023.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements.

### Note 4—Fair value measurements

U.S. GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### **Note 4—Fair value measurements (continued)**

The following is a description of the valuation methodology used for investments measured at fair value, including the general classification of such assets pursuant to the valuation hierarchy. There have been no changes in the methodology used at December 31, 2023 and 2022.

*Pooled Separate Accounts* – Valued at the net asset value (“NAV”) of units held by the Plan at year-end provided by the issuer of the account. NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying investment assets held through subaccounts of a separate account of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. Pooled Separate Accounts (“PSA”) are comprised, primarily, of shares of mutual funds at December 31, 2022. The PSAs seek to mirror the investment objectives and strategies of the underlying mutual fund for which the PSA is named. Certain PSAs are target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date. The investments are redeemable at the adjusted NAV on a daily basis under agreements with the insurance company. There are currently no redemption restrictions or unfunded commitments on these investments. Investments valued using NAV as a practical expedient are not reflected in the valuation hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5—Fully benefit-responsive investment contract**

The Plan had a fully benefit-responsive investment contract with Minnesota Life who maintained the contributions in a general account. The general account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract was included in the financial statements at contract value as reported to the Plan by Minnesota Life. Contract value was the relevant measurement attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

The determination of credited interest rates reflected a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment could apply to amounts withdrawn at the request of the contract holder. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to a breach of the contract terms by the investor.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan) (ii) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event which would have limited the Plan's ability to transact at contract value with participants is probable.

### **Note 6—Related party and party-in-interest transactions**

Certain administrative services were provided by the Company at no cost to the Plan and certain administrative costs incurred by the Plan were paid by the Company. The Plan had entered into various service agreements with parties-in-interest. The Plan's investments were managed by Minnesota Life, the custodian of the Plan. These transactions, as well as notes receivable from participants and related activity, qualified as party-in-interest.

### **Note 7—Income tax status**

The Internal Revenue Service ("IRS") ruled on June 30, 2020, that the non-standardized pre-approved plan of Minnesota Life, upon which the Plan was based, is designed in accordance with applicable sections of the IRC. The Plan had been amended since receipt of the opinion letter. However, the Plan administrator believes the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator analyzed the tax positions taken by the Plan, and concluded that as of December 31, 2023 and 2022, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8—Risks and uncertainties**

The Plan invested in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could have occur in the near term and such changes could have materially affect participant account balances and the amounts reported in the financial statements.

### **Note 9—Subsequent events**

The Plan evaluated all subsequent events through October 14, 2024, which is the date these financial statements were available to be issued and determined there are no subsequent events that require disclosure.
