### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of L&M Radiator 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter—Plan Merger**

As discussed in Note 1 to the financial statements, the Board of Directors of L&M Radiator, Inc., the Plan's sponsor, voted on October 11, 2023, to merge the Plan into Wabtec Savings Plan effective December 31, 2023. All plan assets were transferred to the control of Wabtec Savings Plan on December 31, 2023. Our opinion has not been modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1. Plan Description

The following description of L&M Radiator 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering employees of L&M Radiator, Inc. (the Company or Plan Administrator). Employees 18 years of age or older are eligible to participate in the Plan on the first day of the month after one month of service. Nonresident aliens, consultants, interns, leased employees and union employees, unless required by a collective bargaining agreement, are not eligible for the Plan. Seasonal employees whose regularly scheduled service is less than 1,000 hours of service during a year are not eligible for the Plan. For the purpose of the Company's discretionary matching contribution, eligibility occurs when the employee is 18 years or older, has completed one month of service, and is employed on the last day of the plan year. For the purpose of the Company's discretionary profit sharing contribution, eligibility occurs when the employee is 18 years or older, has worked 1,000 hours during a plan year, is employed on the last day of the plan year, and does not participate in the L&M Radiator, Inc. Pension Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan Administrator has appointed Newport Trust Company as trustee of the Plan. The trustee is responsible for maintaining custody of the Plan's assets, processing contributions and distributions, and executing transactions to appropriate investment options.

**Plan merger:** On June 15, 2023, L&M Radiator, Inc. was acquired by Westinghouse Air Brake Technologies Corporation (Wabtec) and effective December 31, 2023, the Plan was merged with Wabtec Savings Plan. As a result, net assets of \$13,860,094 were transferred to the control of Wabtec Savings Plan at December 31, 2023, and employer contributions receivable of \$646,889 were subsequently deposited into Wabtec Savings Plan on April 8, 2024. The merger does not impact the participant benefits as the benefit provisions were incorporated into Wabtec Savings Plan.

**Contributions:** Participants may contribute up to 100% of their eligible compensation according to the Plan's provisions up to the maximum dollar amount allowed by the Internal Revenue Code (IRC). Participants who have attained 50 years of age before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute, as rollovers, amounts representing distributions from other qualified defined benefit or defined contribution plans and certain individual retirement accounts. Participants direct the investment of Plan contributions into various investment options offered by the Plan.

The Company may elect to make a discretionary matching contribution to the Plan. The Company made a discretionary matching contribution equal to 20% of employee deferrals up to 4% of eligible compensation for the year ended December 31, 2023.

The Company may also elect to make a discretionary profit sharing contribution to the Plan. The Company made a discretionary profit sharing contribution equal to 4% of eligible compensation for the year ended December 31, 2023.

**Participant accounts:** Each participant's account is credited or charged with the participant's contributions, the Company's contributions, if any, and an allocation of investment results and administrative expenses that are paid by the Plan. Allocations are based on the participant's account balances, earnings, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Note 1. Plan Description (Continued)

**Vesting:** Participants are immediately vested in their participant and Company matching contributions and the investment earnings thereon. Company profit sharing contributions and the investment earnings thereon are subject to a vesting schedule based on years of credited service. A participant is 50% vested after two years of credited service and is 100% vested after three years of credited service, upon attaining retirement (age 65) or early retirement (age 55) during the term of employment, or upon death or total and permanent disability.

**Notes receivable from participants:** Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Note terms range up to five years, or longer if the note proceeds are used by the participant for the purchase of a principal residence. The notes are secured by the balance in the participant's account and bear a fixed rate of interest. Principal and interest are paid ratably through regular payroll deductions or remitted directly by participants.

**Payment of benefits:** On termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in the form of single lump sum or installment payments. The Plan also allows for in-service withdrawals at age 59½ or in the case of financial hardship, subject to certain restrictions. If the value of a participant's vested benefit is less than \$1,000, the benefit may only be paid in a single lump sum, and the participant's consent is not needed. Balances between \$1,000 and \$5,000 that are distributed without participant consent are rolled over into an individual retirement account designated by the Plan Administrator for the benefit of the participant.

**Forfeitures:** Forfeited nonvested accounts were previously used to partially fund Company contributions to the Plan. There were approximately \$29,000 of forfeited nonvested accounts at December 31, 2022. The Company profit sharing contribution for 2022, which was paid to the Plan in 2023, was partially funded by approximately \$29,000 of forfeited nonvested accounts. Approximately \$4,000 of forfeited nonvested accounts were transferred to another plan for the year ended December 31, 2023, as a result of the plan merger discussed in Note 1.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments were reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determined the Plan's valuation policies utilizing information provided by the Plan's investment advisors, trustee, and other third parties. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Notes receivable from participants:** Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. If a participant ceased to make note repayments and the Plan Administrator deemed the participant note to be in default in accordance with Plan provisions, the participant note balance was reduced and a benefit payment was recorded.

**Contributions:** Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Benefit payments:** Benefits are recorded when paid.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain other administrative expenses are paid directly by the Plan. Certain asset management and administrative expenses of the Plan are charged against the Plan's investment results.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 15, 2024, the date these financial statements were available to be issued.

#### Note 4. Fair Value Measurements

U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value at December 31, 2022.

**Mutual funds:** Mutual funds were valued based on the publicly quoted active market prices of the shares of funds held by the Plan at year-end.

**Collective trust fund:** The collective trust fund was a stable value fund that was composed primarily of fully benefit-responsive investment contracts and was valued at the net asset value (NAV) of the shares of the fund held by the Plan at year-end. The NAV, as provided by the trustee, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions to the Plan at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### Note 6. Income Tax Status

The Plan has adopted a nonstandardized preapproved plan sponsored by Newport Group, Inc. Newport Group Inc has received an opinion letter from the Internal Revenue Service as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate income tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements.
