#### 1. Plan Description

The following brief description of USNR, LLC 401(k) Tax Sheltered Plan (the “Plan”) is provided for general information only. Participants should refer to the plan agreement for more complete information.

##### **General**

The Plan is a deferred compensation tax sheltered savings plan established for eligible employees of USNR, LLC and certain adopting affiliates (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Company is the plan administrator, as defined by the plan document; accordingly, certain members of its management are responsible for oversight of the Plan including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

##### **Plan Merger**

As further discussed in Note 11 to the financial statements, effective January 1, 2024, the Plan merged into the Wood Technologies International 401(k) Plan (EIN: 87-2823783, Plan Number 001). The Plan’s net assets and participant accounts were transferred to the successor plan accordingly on December 29, 2023.

##### **Eligibility**

Upon commencing employment with the Company, employees are eligible to remit contributions to the Plan and receive any employer contributions. Individuals who are employed as a consultant, temporary contract employee, intern, or are a union employee, are excluded from the Plan.

##### **Contributions**

Effective January 1, 2022, the plan document was amended and restated resulting in certain changes to the terms of the Plan including permitting Roth contributions and the adoption of an auto-enrollment provision. Under the auto-enrollment provision, on or after January 1, 2022, all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated investment option until changed by the participant.

The Plan provides investment options in various investment securities. Participants allocate their contributions in whole percentages among the investment funds offered by the Plan. Voluntary salary deferral contributions are made by the employee and matched by the Company as follows:

- The employee may defer salary of at least 1% but not more than 100% of compensation and not to exceed the annual limit set by the Internal Revenue Service for the calendar year.
- The Company may make matching contributions equal to a discretionary percentage, to be determined by the Company, of the participant’s voluntary deferred salary contributions. For the year ended December 31, 2023, the Company matching contribution was \$0.50 for each dollar deferred, up to 6% of the participant’s qualifying compensation.
- The Company may make discretionary contributions, as determined annually, equal to a uniform percentage of each eligible participant’s qualifying compensation. For the year ended December 31, 2023, no such contributions were made.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are 100% vested in employee contributions at the time of participation in the Plan and are 100% vested in Company contributions after completing five years of service for contributions made prior to December 31, 2001. Company contributions vest at a rate of 20% per year commencing after the second full year of credited service and become fully vested after six years of credited service for contributions made after January 1, 2002. Effective January 1, 2023, participants are 100% vested in Company contributions after completing four years of service; accordingly, company contributions vest at a rate of 25% per year commencing with the first full year of credited service and become fully vested after four years of credited service. A participant who terminates employment because of death, disability or retirement becomes fully vested in Company contributions.

#### **Notes Receivable from Participants**

Participants in the Plan are allowed to borrow an amount not to exceed 50% of their account balance and, under no circumstances, in excess of \$50,000. Participants have up to five years for repayment, unless for the purchase of a primary residence, and are charged interest at the Plan's applicable rate on the date of the loan. Participant loans are collateralized by the balance in the participant's account. Interest paid by the participants on the loans is credited to each respective participant's account.

#### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant (or beneficiary) may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in installment payments. For account balances not exceeding \$5,000, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

#### **Forfeited Accounts**

The unvested portion of Company contributions forfeited by terminated employees is credited against future employer contributions. Unallocated forfeited amounts totaled \$57,018 and \$8,952 at December 31, 2023 and 2022, respectively. For the year ended December 31, 2023, employer contributions were reduced by \$47,967 from forfeited nonvested accounts.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. The plan administrator bases its estimates on historical experience and on various other

assumptions that are believed to be reasonable under the circumstances at the time. Actual results could differ from those estimates under different assumptions or conditions.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a corresponding benefit payment is recorded.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### **Subsequent Events**

Management has evaluated subsequent events through October 14, 2024, the date the financial statements were available to be issued.

### **3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, and interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

**Level 1.** Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022. Fair values are provided by the Plan’s investment custodian as follows:

**Common/collective trust:** Investments in common/collective trust investments are valued at the net asset value (“NAV”) of units of a collective investment trust. The NAV, as provided by the trustee, is used to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This value is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions, including purchases and sales, are valued on a daily basis. Certain participant-initiated withdrawals may be executed subject to a 90-day redemption notice period. The Plan initiated a full redemption of the Morley Stable Value Fund and, under the terms of the collective trust agreement the investment issuer exercised the right to temporarily delay withdrawal from the fund through August 5, 2023. Were the Plan to initiate a full redemption of the Putnam Stable Value Fund, under the terms of the collective trust agreement the investment issuer reserves the right to temporarily delay withdrawal from the fund. At December 31, 2023, the average yield and crediting rate earned by the fund were approximately 3.85 percent and 4.09 percent, respectively.

**Mutual funds:** Investments in registered investment companies are valued at the daily closing price as reported by the respective fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Transfers from Affiliated Plan**

Certain net assets and participant accounts from an affiliated subsidiary's 401(k) plan, totaling \$166,744, were transferred into the Plan during the year ended December 31, 2023.

**6. Related Party and Party-In-Interest Transactions**

Empower Annuity Insurance Company of America and Empower Trust Company, LLC serve as the Plan's investment custodians (the "Custodians"). Transactions with the Custodians, including plan administration and investment advisory services provided by other affiliated entities, qualify as party-in-interest transactions. Fees incurred by the Plan for certain investment expenses are included in net appreciation in fair value of investments, as they are paid through fees charged at the investment level rather than direct payments remitted by the Plan. The Plan made direct payments for custodial, investment advisory, and plan administration expenses totaling \$161,659 during the year ended December 31, 2023. The Company pays directly certain other fees related to the Plan's operations.

**7. Plan Termination and Merger**

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a plan termination, participants would have become 100 percent vested in the employer contributions portion of their accounts. As further discussed in Note 11 to the financial statements, the Plan merged into a successor plan, the Wood Technologies International 401(k) Plan (EIN: 87-2823783, Plan Number 001), effective January 1, 2024.

**8. Tax Status**

The Plan has adopted a volume submitter profit sharing agreement as the plan document which the Internal Revenue Service has determined, by a letter dated June 30, 2020, is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed, and currently being operated, in compliance with applicable sections of the IRC and, therefore, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

#### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **10. Delinquent Participant Contributions**

As reported on the supplemental schedule of Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain employee contributions and loan payments were not remitted to the Plan within the timeframe specified by the Department of Labor, therefore constituting nonexempt transactions between the Plan and the Company for the years ended December 31, 2023. The delinquent remittances were pending correction through the funding of lost earnings to the Plan under applicable regulations as of December 31, 2023.

#### **11. Subsequent Events, Plan Merger, and Transfers of Assets**

Effective January 1, 2024, the Plan's net assets and participant accounts were transferred to, and merged into, the Wood Technologies International 401(k) Plan (EIN: 87-2823783, Plan Number 001). On December 29, 2023, the Plan's net assets and participant accounts, totaling \$63,473,363, were transferred to the successor plan accordingly.
