We have performed audits of the accompanying financial statements of Counter Brands 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits (in liquidation) for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Generally accepted accounting principles require financial statements to be prepared on the liquidation basis of accounting when an entity is in liquidation or when liquidation is imminent.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1 - DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Counter Brands 401(k) Plan (the "Plan") is a defined contribution plan established effective January 1, 2017 to provide voluntary retirement benefits and tax-deferred savings opportunities to eligible employees of the Plan's sponsor, Counter Brands, LLC dba Beautycounter (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Officers and employees of the Company serve as the Plan's administrator. The specific provisions of the Plan are contained in the Plan document, which governs the legal operations of the Plan. The following provides only general information; participants and others should refer to the Plan document for further details.

A. Basis of Accounting

The Plan's financial statements are prepared on the liquidation basis of accounting.

B. Estimates

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Risks and Uncertainties

The Plan provides for various investment options in any combination of investments offered by the Plan. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the risk associated with certain investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

D. Eligibility

Employees are eligible to participate in the Plan upon attaining the age 21 and having completed three months of service. Participants may join the Plan on the first day of the calendar month upon meeting the eligibility requirements.

E. Contributions and Vesting

Participants may contribute to the Plan through tax-deferred salary deductions or after-tax Roth deductions of eligible compensation, as defined in the Plan, up to the statutory maximum allowed by the Internal Revenue Code (the "Code"). Company Safe Harbor contributions are equal to 100% of the first 3% of elective deferrals plus 50% of the next 2% of the elective deferrals. Participants' rights to voluntary contributions, Company contributions and rollover contributions and related earnings are always 100% vested.

F. Notes Receivable from Participants

At the discretion of the Plan administrator, a participant may borrow up to the lesser of 50% of his or her vested account balance or \$50,000. The minimum loan is \$1,000. The term of the loan cannot exceed five years (ten years for loans used to purchase a primary residence). Loans bear interest at the prime rate plus 1%. Participants may only have one outstanding loan at any time.

G. Distributions and Withdrawals

Each participant's share of the net assets of the Plan is allocated to an individual account. Vested benefits are payable upon termination, death or retirement. Additionally, a participant may withdraw vested amounts from his or her account prior to termination of employment with the Company after age 59½. Hardship withdrawals are allowed, as defined by the Plan.

H. Retirement Age

Normal retirement age is 65. Early retirement is not allowed.

I. Administrative Expenses

Most administrative expenses of the Plan are paid by the Company.

J. Investment Valuation and Income Recognition

Accounting principles establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend rate. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

K. Payments of Benefits

Benefits are recorded when paid.

NOTE 2 - INCOME TAX STATUS

The Plan is based upon a Prototype Volume Submitter Profit Sharing Plan with CODA document that received its most recent tax exempt status from the Internal Revenue Service in a letter dated July 25, 2020. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 - PLAN TERMINATION

Effective September 4, 2024, the Plan was terminated and force out date will be October 28, 2024. The participants will be 100% vested in their accounts and net assets will be distributed based upon participants' account balances.

NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2023 and 2023 and investment income for the year ended December 31, 2023, that is disclosed in the accompanying financial statements and supplemental schedules was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the trustee of the Plan.

NOTE 5 - RELATED PARTY TRANSACTIONS

Certain investments held by the Plan are issued and managed by the trustee or its affiliates. Transactions related to these investments qualify as party in interest transactions; however, they are exempt from the prohibitions under ERISA.

NOTE 6 - RECONCILIATION OF FINANCIAL STATEMENTS TO THE FORM 5500

NOTE 7 - AMENDMENTS

On March 17, 2022, the Plan was amended to change the trustee effective March 18, 2022.

On July 5, 2022, the Plan was amended effective January 1, 2022, to adopt the Internal Revenue Service cycle 3 retirement provisions to comply with certain changes required by law, to implement hardship distribution provisions of the Bipartisan Budget Act of 2018 and to adopt the loan program provisions as stated in the loan program form.

On October 3, 2022, the Plan was amended to add an additional trustee.

On March 1, 2023, the Plan was amended to change the trustee.

On March 26, 2023, the Plan was amended to remove the hardship requirement for a loan.

On July 3, 2023, the Plan was amended to change the trustee, effective July 6, 2023.

NOTE 8 - SUBSEQUENT EVENTS

Effective April 1, 2024, the Plan was amended to change trustee from Empower Trust Company, LLC to Fidelity Management Trust Company.

In April 2024, the decision was made to terminate the Plan by December 31, 2024. The participants will be 100% vested in their accounts and net assets will be distributed based upon participants' account balances.

In April 2024, the Company went into foreclosure.

Effective May 6, 2024, new Plan trustee and Plan administrator were appointed.

Effective September 4, 2024, the Plan was terminated and force out date will be October 28, 2024.



Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Counter Brands 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits (in liquidation) for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

As discussed in Note 3 to the financial statements, the Plan will terminate effective December 31, 2024 and, accordingly, the Plan's financial statements are prepared on the liquidation basis of accounting. Generally accepted accounting principles require financial statements to be prepared on the liquidation basis of accounting when an entity is in liquidation or when liquidation is imminent.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Counter Brands 401(k) Plan (the "Plan") is a defined contribution plan established effective January 1, 2017 to provide voluntary retirement benefits and tax-deferred savings opportunities to eligible employees of the Plan's sponsor, Counter Brands, LLC dba Beautycounter (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Officers and employees of the Company serve as the Plan's administrator. The specific provisions of the Plan are contained in the Plan document, which governs the legal operations of the Plan. The following provides only general information; participants and others should refer to the Plan document for further details.

A. Basis of Accounting

The Plan's financial statements are prepared on the liquidation basis of accounting.

B. Estimates

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Risks and Uncertainties

The Plan provides for various investment options in any combination of investments offered by the Plan. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the risk associated with certain investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

D. Eligibility

Employees are eligible to participate in the Plan upon attaining the age 21 and having completed three months of service. Participants may join the Plan on the first day of the calendar month upon meeting the eligibility requirements.

E. Contributions and Vesting

Participants may contribute to the Plan through tax-deferred salary deductions or after-tax Roth deductions of eligible compensation, as defined in the Plan, up to the statutory maximum allowed by the Internal Revenue Code (the "Code"). Company Safe Harbor contributions are equal to 100% of the first 3% of elective deferrals plus 50% of the next 2% of the elective deferrals. Participants' rights to voluntary contributions, Company contributions and rollover contributions and related earnings are always 100% vested.

F. Notes Receivable from Participants

At the discretion of the Plan administrator, a participant may borrow up to the lesser of 50% of his or her vested account balance or \$50,000. The minimum loan is \$1,000. The term of the loan cannot exceed five years (ten years for loans used to purchase a primary residence). Loans bear interest at the prime rate plus 1%. Participants may only have one outstanding loan at any time.

G. Distributions and Withdrawals

Each participant's share of the net assets of the Plan is allocated to an individual account. Vested benefits are payable upon termination, death or retirement. Additionally, a participant may withdraw vested amounts from his or her account prior to termination of employment with the Company after age 59½. Hardship withdrawals are allowed, as defined by the Plan.

H. Retirement Age

Normal retirement age is 65. Early retirement is not allowed.

I. Administrative Expenses

Most administrative expenses of the Plan are paid by the Company.

J. Investment Valuation and Income Recognition

Accounting principles establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend rate. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

K. Payments of Benefits

Benefits are recorded when paid.

NOTE 2 - INCOME TAX STATUS

The Plan is based upon a Prototype Volume Submitter Profit Sharing Plan with CODA document that received its most recent tax exempt status from the Internal Revenue Service in a letter dated July 25, 2020. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 - PLAN TERMINATION

Effective September 4, 2024, the Plan was terminated and force out date will be October 28, 2024. The participants will be 100% vested in their accounts and net assets will be distributed based upon participants' account balances.

NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2023 and 2023 and investment income for the year ended December 31, 2023, that is disclosed in the accompanying financial statements and supplemental schedules was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the trustee of the Plan.

NOTE 5 - RELATED PARTY TRANSACTIONS

Certain investments held by the Plan are issued and managed by the trustee or its affiliates. Transactions related to these investments qualify as party in interest transactions; however, they are exempt from the prohibitions under ERISA.

NOTE 7 - AMENDMENTS

On March 17, 2022, the Plan was amended to change the trustee effective March 18, 2022.

On July 5, 2022, the Plan was amended effective January 1, 2022, to adopt the Internal Revenue Service cycle 3 retirement provisions to comply with certain changes required by law, to implement hardship distribution provisions of the Bipartisan Budget Act of 2018 and to adopt the loan program provisions as stated in the loan program form.

On October 3, 2022, the Plan was amended to add an additional trustee.

On March 1, 2023, the Plan was amended to change the trustee.

On March 26, 2023, the Plan was amended to remove the hardship requirement for a loan.

On July 3, 2023, the Plan was amended to change the trustee, effective July 6, 2023.

NOTE 8 - SUBSEQUENT EVENTS

Effective April 1, 2024, the Plan was amended to change trustee from Empower Trust Company, LLC to Fidelity Management Trust Company.

In April 2024, the decision was made to terminate the Plan by December 31, 2024. The participants will be 100% vested in their accounts and net assets will be distributed based upon participants' account balances.

In April 2024, the Company went into foreclosure.

Effective May 6, 2024, new Plan trustee and Plan administrator were appointed.

Effective September 4, 2024, the Plan was terminated and force out date will be October 28, 2024.
