Opinion

Termination of Plan

As discussed in Note 6, the Company terminated the Plan effective December 31, 2023.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Notes to Financial Statements

Note 1 – Description of the Plan

The following description of the Washington Health Industry Health Trust Plan (the Plan), provides only general information. Participants should refer to the plan documents, summaries, and other descriptive plan literature for a more complete description of the Plan's provisions.

- a. **General** – The Plan was established on January 1, 2014. The Plan was established to hold insurance policies through which participating employers can provide programs of health and other insurance benefits under the employee benefit plans they maintain for their employees and dependents.

This program is considered a “group insurance arrangement” as defined by the Employee Retirement Income Security Act of 1974 (ERISA). ERISA defines a “group insurance arrangement” as an arrangement providing benefits to the employees of two or more unaffiliated employers, fully insures one or more welfare plans of each participating employer, and uses a trust as the holder of the insurance contracts and conduit for payment of premiums to the insurance company(ies). The types of benefits currently available through the Plan are described as follows: medical, hospital, surgical, prescription drug, dental, vision, group life, supplemental life, additional accidental death and dismemberment, long-term disability, and employee assistance program. The Plan has terminated effective December 31, 2023.

- b. **Eligibility** – Participation in the Plan is limited to employers in the healthcare industry in the state of Washington who are also members of Associated Industries of the Inland Northwest (AIIN). The only individuals who are entitled to participate in and to receive benefits from the Plan are those selected employees and dependents identified by participating employers.
- c. **Contributions** – Under an administration agreement signed by the Washington Health Industry Health Trust (the Trust) and Associated Industries Management Services, Inc. (AIMS), AIMS has all necessary authority to receive contributions to pay premiums on the group insurance policies offered through the Trust and to also pay reasonable expenses of the Plan. Each employer agrees to provide information, including payroll information and data, to the Plan regarding the employer's participants and employees of any controlled group in which the employer may be a member. Each employer agrees to promptly remit to the Plan the amount of contribution required to maintain welfare benefits coverage for each of the employer's participants in the amounts and at times described in the Adoption Agreement. In the event that any employer fails or refuses to remit the employer's or the participants' contributions due to the Plan on a timely basis, AIMS will cancel and terminate the coverage afforded the employer's participants, and the employer will be notified.

Employer and participant contributions are received and held by the Trust pending payment of approved insurance premiums and welfare benefits. Such contributions are determined by the Plan.

The Plan allows participating employers to elect various benefit coverage options. The contribution rates for each option are determined by the Board of Trustees.

Note 1 – Description of the Plan (Continued)

- d. **Benefits** – The Plan provides medical, prescription drug, dental, and vision benefits for eligible employees and their dependents. The Plan fully insures these benefits. Premiums are paid by the Plan.
- e. **Related parties and parties-in-interest** – The sponsor of the Plan is the Trust, organized by AIIN. The administrator of the Plan is AIMS, a contract administration organization related to AIIN. The Trust contracts with various insurance brokers. Financial statement accounting and auditing services are provided by Anastasi, Moore & Martin, PLLC.

The administration agreement provides for a Board of Trustees responsible for the administration of the Trust. An independent fiduciary, on behalf of the Board of Trustees, has contracted with AIMS to provide administrative services to the Trust. Under the terms of this contract, the Trust pays AIMS a base administrative fee of 2.35% on gross contributions collected and reimburses AIMS for necessary and reasonable administration costs of the Plan.

During the years ended December 31, 2023 and 2022, the Plan paid administration fees totaling \$41,557 and \$24,431, respectively, to AIMS.

At December 31, 2023 and 2022, the Plan recorded receivables in the amounts of \$-0- and \$101,437, respectively, from Associated Employers Health and Welfare Benefit Plan representing a settlement from AIMS which will be used to purchase independent fiduciary services for the Trust.

Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Contributions receivable** – Employer contributions due but not paid at period end are recorded as contributions receivable. Delinquent contributions are recorded when collected. Amounts recorded are considered fully collectible and, accordingly, no allowance for doubtful accounts is presented.
- c. **Deferred revenue** – Employer contributions received in advance of the coverage period are recorded as deferred revenue. Revenue is recognized when the period of coverage begins.
- d. **Payment of insurance premiums** – Insurance premiums are recognized when paid. Rebates of insurance premiums are recognized when received. The Plan received rebates in the amounts of \$-0- for both years ended December 31, 2023 and 2022.
- e. **Benefit obligations** – Premiums payable is estimated based on participant eligibility earned as a result of contributions for participants through December 31, and paid by the Plan subsequent to year end. The Plan has no obligation to provide benefits to retirees; therefore, postretirement benefit obligations are not recorded on the financial statements.

Note 2 – Summary of Significant Accounting Policies (Continued)

- f. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.
- g. **Subsequent events** – The Plan has evaluated subsequent events through October 9, 2024, the date on which the financial statements were available to be issued.

Note 3 – Plan Tax Status

The Plan is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) as a tax-exempt organization and a favorable tax determination letter has been obtained from the Internal Revenue Service (IRS). The Board of Trustees believes the Plan is designed and has been operated through December 31, 2023, in compliance with the applicable provisions of the IRC. The Plan is also subject to audit or examination by various regulatory jurisdictions. As of October 9, 2024, there were no audits or examinations in progress.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the IRS. Management has analyzed the tax positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are no audits for any tax periods in progress.

Note 4 – Priorities Upon Termination

The plan sponsor terminated the Plan effective December 31, 2023. See Note 6. Upon termination of the Plan, all assets remaining in the Trust (net of payments for all expenses) shall be used for the continuance of benefits provided until such assets have been depleted. If the assets are insufficient to pay all accrued benefits and liabilities, distribution of the assets shall be made in accordance with plan termination provisions and the requirements of ERISA and applicable government regulations. In no event shall any of the assets remaining in the Plan be paid to or be recoverable by any employer.

Note 5 – Risks and Uncertainties

The Plan maintains its cash balances with one financial institution. Such balances are insured up to \$250,000 by the Federal Deposit Insurance Corporation. At times during the Plan year, the Plan's cash balances may exceed federally insured limits.

The Plan and the related insurance carriers face an increasingly challenging regulatory environment. Certain interpretations of laws, rules, and regulations may potentially affect the Plan. However, it is not expected the Plan will significantly change operations or terminate prior to December 31, 2023.

Note 6 – Plan Termination

The plan sponsor terminated the Plan effective December 31, 2023, subject to the provisions set forth in ERISA.

The plan sponsor has evaluated subsequent events through October 9, 2024, the date the financial statements were available to be issued.
