INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Employee Benefit Plan of Alert Holdings Group, Inc.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Employee Benefit Plan of Alert Holdings Group, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets in available for benefits as of December 4, 2023 (merger date) and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended December 4, 2023, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 4, 2023 and December 31, 2022 and for the period ended December 4, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Merger

As further discussed in Note 1 to the financial statements, the Board of Directors of the Plan voted to merge the Plan effective December 4, 2023 into the Zeus Fire & Security Retirement Plan, which is the successor plan. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the period ended December 4, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

(1) Plan description

The following description of the Employee Benefit Plan of Alert Holdings Group, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General - The Plan is a defined contribution plan covering substantially all full-time employees of Alert Holdings Group, Inc. ("Plan Sponsor" or the "Company") who are not covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Board of Directors of the Plan voted to merge the Plan effective December 4, 2023, into the Zeus Fire & Security Retirement Plan, which is the successor plan.

Contributions - Each year, participants could contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants aged 50 or older, who were making contributions to the Plan, were allowed to make catch-up contributions as defined in the Plan. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company contributed a matching contribution equal to 50% of participant contributions up to 6% of compensation for participants who had completed six months of service.

Effective July 1, 2023, the Plan was amended to allow for entry dates on the first day of the month coinciding with or next following the date eligibility requirements were met. Previously, the entry date was the first day of the plan year quarter coinciding with or next following the date eligibility requirements were met.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant investment account options - Participants directed the investment of their contributions into various investment options offered by the Plan. Prior to the plan merger, the Plan offered various mutual funds, pooled separate accounts, a money market fund, and a fixed interest account as investment options for participants.

Participant accounts - Each participant's account was credited with the participant's contribution and allocations of (a) the Company matching contributions and (b) plan earnings and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(1) Plan description (continued)

Vesting - Prior to the merger, participants' contributions plus actual earnings were 100% vested immediately. Company contributions were subject to the following vesting schedule:

Notes receivable from participants - Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bore interest at rates that were commensurate with local prevailing rates as determined by the plan administrator. Principal and interest were paid ratably through payroll deductions.

Payment of benefits - On termination of service due to death, disability or retirement, a participant could elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than the individual's assumed life expectancy. For termination of service due to other reasons or upon qualifying instances of hardship, a participant could receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited accounts - As of December 31, 2022, there were no forfeited nonvested accounts. These accounts could be used to pay Plan expenses or to reduce future employer contributions. During the period ended December 4, 2023, \$5,728 of forfeitures were used to reduced employer matching contributions.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Reporting period - The 2023 reporting period was for the period from January 1, 2023, through December 4, 2023 (merger date).

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments were reported at fair value, except for the fixed interest account that was reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

(2) Summary of significant accounting policies (continued)

Investment valuation and income recognition - Purchases and sales of securities were recorded on a trade-date basis. Interest and dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions - Contributions from Plan participants and the matching contributions from the Company were recorded in the year in which the employee contributions were withheld from compensation.

Notes receivable from participants - Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of December 31, 2022.

Payment of benefits - Benefits were recorded when paid.

Administrative expenses - Certain expenses of the Plan were paid by the Company and were not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation in fair value of investments.

(3) Information prepared and certified by the trustee

Certain information related to investments disclosed in the accompanying financial statements, including investments held as of December 31, 2022, and net appreciation in fair value of investments and interest income for the period ended December 4, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company ("Mutual of America"), the trustee of the Plan. The trustee's certified information included that there were no investments held by the Plan as of December 4, 2023.

(4) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

(4) Fair value measurements (continued)

Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 4, 2023 and December 31, 2022.

Mutual funds and money market fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at the Net Asset Value ("NAV") of units of the separate account. The NAV, as provided by the trustee of the accounts, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities' liquidations will be carried out in an orderly business manner.

There were no Plan investments as of December 4, 2023. The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2022.

(5) Investment contract with an insurance company

The Plan had an evergreen group annuity contract, which was a fully benefit-responsive investment contract with Mutual of America. Mutual of America maintained the contributions in a general account. The investment was valued at contract value, which was \$118,335 as of December 31, 2022, as determined by Mutual of America and was based on the value of the underlying assets in Mutual of America's general account. The account was credited with earnings and losses on the underlying investments and charged with participant withdrawals and administrative expenses. The investment contract issuer was contractually obligated to repay the principal and specified interest rate that was guaranteed to the Plan.

Because the investment contract was fully benefit-responsive, the contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. When the Plan discontinued this investment, the contract value at that time was due to the Plan. The underlying investments of Mutual of America's general accounts consisted primarily of public and private fixed maturity securities and commercial mortgage loans. No specific investment or groups of investments in Mutual of America's general account backed this investment contract. Contract value, as reported to the Plan by Mutual of America, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of one of the plan sponsors or other plan sponsors' events (for example, divestitures or spin-offs of a subsidiary) that caused a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. There were no events that limited the Plan from transacting at contract value with participants.

The investment contract could be terminated by the Plan at any time but could only be terminated by Mutual of America if the Plan did not meet certain operational obligations or failed to pay certain expenses as defined by the contract or if Mutual of America abandoned this class of investment. During the period ended December 4, 2023, the Plan terminated its contract with Mutual of America due to its merger with the Zeus Fire & Security Retirement Plan (Note 1).

(6) Related-party transactions and party-in-interest transactions

Certain Plan investments were managed by Mutual of America, who was the trustee as defined by the Plan and, therefore, these transactions qualified as a party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$1,341 for the period ended December 4, 2023. The Company paid directly any other fees related to the Plan's operations.

(7) Tax status

The Internal Revenue Service ("IRS") has determined that the prototype plan is designed in accordance with applicable sections of the IRC and informed Mutual of America of such in a letter dated November 30, 2020. The plan administrator has adopted the prototype plan and believes that the Plan was being operated in compliance with the applicable requirements of the IRC.

(7) Tax status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Delinquent participant contributions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. The Plan Sponsor failed to remit employee contributions and loan repayments of \$11,209, which will be remitted to the Zeus Fire & Security Retirement Plan, along with lost earnings. In addition, the Company remitted an additional \$90,183 of employee contributions and loan repayments to the Plan that were not remitted within the required time period for the period ended December 4, 2023, which will have lost earnings remitted to the Zeus Fire & Security Retirement Plan.

(9) Subsequent events

The Plan has evaluated subsequent events through October 15, 2024, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
