#### Note 1 – Description of plan

The following description of the Wilshire Law Firm 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### General

The Plan covers substantially all employees of Wilshire Law Firm, PLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was established January 1, 2021.

A Plan restatement was completed effective February 1, 2023 as part of the compliance with the Internal Revenue Service requirement to ensure Plan provisions are updated with statutory changes.

Effective September 1, 2023, the Plan’s adoption agreement was modified to allow the issuance of participant loans. As of December 31, 2023, no loans have been requested by participants.

##### Eligibility

An employee is eligible to participate in the Plan, for purposes of making voluntary salary deferral contributions, upon attaining age 18 and completing two months of service. An employee is eligible to participate in matching and non-elective contributions upon completion of one year of service and must be employed on the last day of the Plan year. The Plan excludes leased employees, non-resident aliens, and employees covered by a collective bargaining agreement. Plan entry date is the month following the date eligibility requirements are met.

##### Contributions

Eligible employees (“participants”) may contribute a portion of their annual compensation subject to certain limitations as defined by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Automatic enrollment is implemented with 5% of compensation per payroll for new participants.

The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount of elective deferrals. The Company did not make a discretionary matching contribution for the year ended December 31, 2023.

In addition, a non-elective profit-sharing contribution may be made at the option of the Company. The non-elective contribution is allocated to participants based on the participant’s compensation for the plan year in proportion to total compensation of all participants. A participant is not required to make contributions to the Plan to be eligible for an allocation of the non-elective contribution. The Company did not make a non-elective profit-sharing contribution for the year ended December 31, 2023.

##### Rollover contributions

The Plan provides for rollover contributions, which represent contributions by participants from other tax-qualified retirement plans. The maximum amount of a participant’s rollover contribution is not affected by the limits otherwise applicable to participant deferral contributions.

##### Participant accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings and charged with an allocation of administrative expenses. The contributions are allocated within each participant account based upon the participant’s investment elections. All amounts in participant accounts are participant-directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Note 1 – Description of plan (continued)

##### Vesting

Participants are immediately vested in their elective contributions and rollover contributions plus actual earnings thereon. Vesting in the matching and non-elective profit-sharing contribution portion of their account plus actual earnings thereon is based on years of service. A participant is 20% vested each year beginning in year two and 100% vested after six years of credited service.

##### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest in the Plan. The loans are secured by the vested balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions over the repayment term of 5 years unless the purpose of the loan is to acquire the principal residence for the participant, in which case the loan may be repaid for a period up to 30 years. Only one outstanding loan at the time is permitted.

Notes to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document. Plan management has evaluated the collectability of notes receivable from participants and, because they are secured by the participants' accounts, an allowance has not been recorded.

##### Payment of benefits

Benefits are payable to participants or designated beneficiaries upon retirement at age 65, in-service at age 59 ½, termination, death or disability. Distributions may be paid in a lump-sum amount equal to the value of the participant's vested interest in his or her account, payments over a fixed period, or they may be rolled over into another plan or an individual retirement account. Partial distributions are permitted.

The Plan has a mandatory cash out provision for account balances up to \$5,000. Benefits are recorded when paid.

##### Hardship withdrawals

Participants may withdraw all contribution types in the event of hardship as defined in the Plan agreement.

##### Forfeitures

Forfeitures of Company contributions are used to reduce Company matching contributions, non-elective contributions or pay plan expenses. At December 31, 2023, there were no forfeited accounts available. There were no forfeitures used in 2023.

##### Administrative expenses

The Plan's recordkeeping and administrative fees are paid directly by the Plan.

#### Note 2 – Summary of significant accounting policies

##### Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

##### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

##### Payment of benefits

Benefits are recorded when paid.

##### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Reclassification

Certain investment information for the prior year has been modified to conform with current year's presentation and disclosures.

##### Subsequent events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of events that affect the financial statements. Management believes there are no subsequent events required for recording or disclosure in the financial statements for the year ended December 31, 2023. Subsequent events were evaluated through October 1, 2024, which is the date the financial statements were available to be issued.

#### Note 3 – Information prepared and certified by custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022.
- Net appreciation in fair value of investments and interest and dividends reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2023.
- Investments reflected on the schedule of assets held at December 31, 2023.

#### Note 4 – Fair value measurements

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price, as reported by the fund. Funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Stable value fund:* Valued at the NAV of units of the stable value fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchase and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5 – Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company contribution accounts.

#### Note 6 – Tax status

The Plan document is a 401(k)/Profit Sharing Non-Standardized Plan with an Internal Revenue Service (IRS) opinion letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC).

The Plan Administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's annual return/report of employee benefit plan for the past three years are subject to examination by tax authorities and may change upon examination.

#### Note 7 – Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

### Note 8 – Related party and party-in-interest transactions

Certain plan investments were managed by T. Rowe Price Retirement Plan Services and Reliance Trust Company, the custodians as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. The Plan also paid administrative fees to independent third-party administrators. Fees paid by the Plan for the recordkeeping and administrative services for the year ended December 31, 2023 were \$37,425.

### Note 9 – Prohibited transactions

For the Plan year 2022, participant contributions of \$308,415 were withheld from participants' pay on various dates during 2022 but were not remitted to the Plan's trust within the time required by the Department of Labor. The lost earnings on participant contributions of \$480 were calculated based on interest rates determined by the Internal Revenue Code and remitted to the Plan in October 2023.

For the Plan year 2023, participant contributions of \$283,157 were withheld from participants' pay on various dates during 2023 but were not remitted to the Plan's trust within the time required by the Department of Labor. The lost earnings on participant contributions of \$1,259 were calculated based on interest rates determined by the Internal Revenue Code and remitted to the Plan in October 2024.
