Notes to Financial Statements

1. Description of Plan

General

StackPath Management, Inc. 401(k) Plan (Plan) covers eligible employees of StackPath Management, Inc. (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee and recordkeeper of the Plan is Empower Trust Company (Trustee). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Termination

Subsequent to the year ended December 31, 2023, the Company initiated the process to terminate the Plan subject to the provisions of ERISA. Due to the Plan termination, participants will become 100% vested in their accounts. The Company intends to complete the Plan termination and distribution of participant's accounts during 2024.

Participant Accounts

Employees, excluding union, leased or non-resident aliens 18 years and older are eligible to become participants in the Plan. Each participant's account is credited with the participant's contributions, the Company's contributions and allocations of the invested funds' earnings. Allocations of earnings are based on account balances as defined by the Plan. Certain administrative expenses may be charged directly to the participant's account incurring those expenses.

Contributions

Participants may contribute up to 100% of their eligible annual compensation, as defined in the Plan, limited to the maximum permitted under applicable Internal Revenue Code (IRC) regulations. Participants may also contribute after-tax contributions to a Roth 401(k) options and amounts representing distributions from other qualified defined benefit or contribution plans. In addition, the Company makes safe harbor matching contributions equal to 100% of a participant's deferral election up to 3% of eligible compensation and 50% of deferral elections from 3% to 5% of eligible compensation to the Plan. For the year ended December 31, 2023, the Company contributed \$695,353.

Forfeitures

When certain events occur allowing for distributions from the Plan, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures may be used to reduce future Company contributions and expenses. For the year ended December 31, 2023, no forfeitures were used to reduce Company contributions or expenses. At December 31, 2023 and 2022, \$20,967 and \$17,356, respectively, of forfeitures were available for future use.

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Effective July 20, 2022, the Plan was amended to no longer permit profit-sharing contributions. Participants vest in Company profit sharing contributions in accordance with the following table:

Notes Receivable from Participants

Notes receivable from participants represent loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. The repayment terms of loans may not exceed five years except for loans used to acquire a principal residence. Each loan bears interest at prime rate plus 2%. Principal and interest are paid ratably through automatic payroll deductions. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be a distribution, notes receivable from participants is reduced and a benefit payment is recorded. Each participant may have a maximum of two outstanding loans at any time.

Payment of Benefits

Distribution of a participant's vested account balance is available upon the participant's retirement, death, disability, termination of employment, attainment of age 59 1/2 or for a financial hardship meeting the requirements of the IRC. In the event of death, disability, retirement or termination of employment, the Company has the option to require those participants with account balances of less than \$5,000 to take lump-sum distributions, unless a directed rollover is elected. If a participant's account balance exceeds \$1,000, they may elect to rollover their vested account balance, to receive a lump-sum distribution. Participant's accounts that exceed \$1,000 but are less than \$5,000 and an election is not made, the Plan will automatically roll over the distribution to an IRA designated by the Company.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan and are included in administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

Management uses estimates and assumptions in preparing financial statements in accordance with GAAP. Those estimates and assumptions affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could vary from the estimates used in preparing the accompanying financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The Plan presents the net change in fair value of investments, which consists of realized gains or losses, unrealized appreciation (depreciation), and any income or capital gain distributions from such investments, in the accompanying statement of changes in net assets available for benefits.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits

Benefits to participants are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

3. Fair Value Measurements

The Plan measures its investments at fair value on a recurring basis. The inputs used to develop fair value are ranked to indicate the quality and reliability of the resulting fair value measures, as follows:

- Level 1 quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; and model-derived valuations in which all significant inputs are observable in active markets.
- Level 3 valuations derived from valuation techniques in which one or more significant inputs are unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds

These investments are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is a quoted price in an active market.

Collective Trusts

These investments are valued at NAV per unit, as determined by the Trustee. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets less its liabilities.

The Plan holds other assets not measured at fair value on a recurring basis, including employer contributions receivable and notes receivable from participants. The fair value of these assets approximates the carrying amounts in the accompanying financial statements due to the short maturity of the instruments. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan holds a fully benefit-responsive investment contract with Great-West Life & Annuity Insurance Company. The investment contract contributions are held in a general account. The issuer is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan. Contract value as reported by Great-West Life & Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants transact at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events can limit the ability of the Plan to transact at contract value with the issuer, as defined by the contract with the Plan. The Plan administrator believes any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

7. Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. The Plan has been amended and restated since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan’s Annual Return/Report of Employee Benefit Plan is subject to examination by the IRS for three years from the date of filing.

8. Related Party Transactions and Party-In-Interest Transactions

Empower Trust Company LLC is the custodian as defined by the Plan and, therefore, qualifies as a party-in-interest. Some fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing rather than by direct payment.

9. Subsequent Events
