### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Netafim Irrigation, Inc. 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Netafim Irrigation, Inc. 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Netafim Irrigation, Inc. 401(k) Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Plan Merger***

As further discussed in Note 1 to the financial statements, the Plan was merged into the Mexichem Fluor, Inc. 401(k) Plan effective January 1, 2024. Our opinion was not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1 – Description of Plan

The following description of the Netafim Irrigation, Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

**General** – The Plan is a safe harbor 401(k) plan covering substantially all employees of Netafim Irrigation, Inc., and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Netafim Irrigation, Inc. (the Company), is the Plan’s sponsor and serves as Plan administrator.

Effective July 1, 2023, the Plan transitioned from John Hancock Life Insurance Company (John Hancock) to Fidelity Management Trust Company (Fidelity). The Plan adopted Fidelity’s pre-approved plan documents effective July 1, 2023, under substantially the same provisions held with John Hancock.

To facilitate the consolidation of existing plans within a controlled group, the account balances of the Netafim Irrigation, Inc. 401(k) Retirement Savings Plan and Dura-Line LLC 401(k) Retirement Plan (the Merged Plans) were transferred into the Mexichem Fluor, Inc. 401(k) Plan on December 29, 2023. Netafim Irrigation, Inc. 401(k) plan assets of \$42,443,674 were transferred to Mexichem Fluor, Inc. 401(k) Plan (see Note 7).

Effective January 1, 2024, the Mexichem Fluor, Inc. 401(k) Plan was renamed the Orbia 401(k) Plan and the Merged Plans’ employers, Netafim Irrigation, Inc. and Dura-Line LLC, became participating employers in the Orbia 401(k) Plan.

**Eligibility** – Employees of the Company are eligible to participate in the Plan upon reaching age 18. Employees who have reached age 18 are also eligible for employer safe harbor and fixed additional matching contributions, as well as employer nonelective contributions.

### Contributions

*Participant contributions* – Each year, participants may contribute between 1% and 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant.

*Employer matching contributions (safe harbor and fixed additional)* – The Company makes safe harbor contributions equal to 100% of employee contributions, up to 4% of eligible compensation. The Company also makes fixed additional matching contributions equal to 70% of employee contributions, up to 6% of eligible compensation. Employer safe harbor and fixed additional matching contributions were \$718,741 and \$689,572, respectively, for the year ended December 31, 2023.

*Employer nonelective contributions* – The Company may elect to make discretionary nonelective contributions to the Plan. Employer nonelective contributions are allocated to participants at the employer's discretion. Employer nonelective contributions were \$403,314 for the year ended December 31, 2023.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with the participant's contributions and Company safe harbor and fixed additional matching contributions, as well as allocations of the Company's nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** – Participants are vested immediately in their contributions and in matching and nonelective contributions plus actual earnings thereon.

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed 15 years. Under the terms of the Plan Agreement, plan loans will bear a rate of interest of prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

**Payment of benefits** – On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account. A participant who is required to receive lifetime required minimum distributions may receive installments payable in monthly, quarterly, or annual installments equal to or exceeding the annual required minimum distribution amount. Unless otherwise elected by the participant, the Plan also automatically distributes amounts to terminated participants with balances less than \$5,000 into an individual retirement account; balances less than \$200 are distributed in a lump-sum amount.

**Forfeitures** – Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and are used to pay the Plan's administrative expenses or are used to reduce future Company contributions.

#### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments are reported at fair value. The Plan’s custodians, John Hancock Life Insurance Company (John Hancock) and Fidelity Management Trust Company (Fidelity), certify the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2022.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund’s prospectus. Investment expenses are included in net investment income.

**Subsequent events** – The Plan has evaluated subsequent events through October 15, 2024, which is the date the financial statements were available to be issued.

### Note 3 – Investments

The Plan had a group annuity contract with John Hancock Life Insurance Company, which offered various pooled separate accounts (PSAs) with investment options (sub-accounts) that invest in the following:

- Mutual funds managed by unaffiliated mutual fund companies;
- Mutual funds managed by John Hancock Investment Management Services, LLC (John Hancock Investment Management), and sub-advised by MFC Global Investment Management or unaffiliated third parties; and
- Collective investment trusts managed by John Hancock Life Insurance Company.

Units held in sub-accounts of the PSAs were valued using the net asset value (NAV) practical expedient of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. All of the sub-accounts can be redeemed daily. There were no unfunded commitments, redemption frequency restrictions, or redemption notice requirements, with the exception of the withdrawal notice period for the John Hancock Stable Value Fund as disclosed below.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodology used by the PSAs at December 31, 2022.

The Plan invested in the following PSAs with significant balances at December 31, 2022. Other accounts available and insignificant accounts are not disclosed here.

*John Hancock Stable Value Fund* – This investment in a collective trust seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term. The fund is invested primarily in benefit responsive contracts issued by state-regulated insurance companies and banks, including but not limited to John Hancock Life Insurance Company. In addition, each insurance company either contractually guarantees or obtains contractual guarantees from third parties insuring against the loss of principal deposited into the fund and providing that individual participant withdrawals will be paid promptly at book value (i.e., the amount of participant contributions plus interest previously credited, less previous withdrawals) even if the fund's total book value exceeds the market value of its underlying securities. However, if the book value of the fund exceeds the market value of underlying securities, the stabilizing agreements provide that the payment of certain withdrawals may be delayed for up to 12 months unless the Plan or the participant requesting the withdrawal elects to accept such payment subject to a market value adjustment.

*John Hancock Multimanager Growth Lifestyle Portfolio* – This investment in a registered investment company seeks long-term growth of capital by investing approximately 80% of the portfolio's assets in underlying portfolios that invest primarily in equity securities and approximately 20% of its assets in portfolios that invest primarily in fixed-income securities. Current income is also a consideration. This asset allocation portfolio is managed with the intention of providing an optimal mix of a broadly diversified portfolio.

*John Hancock Multimanager Balanced Lifestyle Portfolio* – This investment in a registered investment company seeks to achieve a balance between a high level of current income and growth of capital, with a greater emphasis on growth of capital, by investing approximately 40% of the portfolio's assets in underlying portfolios that invest primarily in fixed-income securities and approximately 60% of its assets in underlying portfolios that invest primarily in equity securities. This asset allocation portfolio is managed with the intention of providing an optimal mix of a broadly diversified portfolio.

#### **Note 4 – Tax Status**

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 5 – Information Certified by the Custodians**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company and Fidelity Management Trust Company, the custodians of the Plan, has certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022.
- Net appreciation in fair value of investments and dividends and interest, reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2023.

#### **Note 6 – Party-in-Interest Transactions**

Plan investments include shares of pooled separate accounts that invest in registered investment companies and a collective trust managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the custodian of the Plan and, therefore, transactions with this entity qualify as exempt party-in-interest transactions.

Under the group annuity contract, John Hancock Life Insurance Company receives revenue from various investment options (sub-accounts) of the Plan. In the case of underlying funds advised and sub-advised by John Hancock Life Insurance Company and its affiliates, John Hancock Life Insurance Company uses revenue from its corporate profit to provide credits to the sub-account that invests in the underlying affiliated fund. These credits may be applied to pay Plan expenses or allocated to the accounts of participants. During 2023, there were no credits received in conjunction with this arrangement that were allocated to the accounts of participants.

Certain Plan investments are managed by Fidelity Management Trust Company (Fidelity). Fidelity is the custodian of the Plan and, therefore, transactions with this entity qualify as exempt party-in-transactions.
