### Note 1: Description of Plan

The following description of the Mid-State Truck Service, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is an amendment and restatement of a pre-existing plan established on January 1, 1987. It is a defined contribution plan covering all qualifying employees of Mid-State Truck Service, Inc. and its former wholly owned subsidiaries, Northland International Trucks, LLC, Skubic Bros., and Maney International, Inc., (the "Company") who have one hour of service during the first month of employment and are age 20 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants are allowed to contribute pretax annual compensation, as defined by the Plan, up to the maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also allows for Roth contributions. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate deferral rate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated default investment fund until changed by the participant. Participants direct the investment of contributions into various investment options offered by the Plan.

The Company contributes a match of 50% of the first 6% of base compensation that a qualifying participant contributes to the Plan. Roth and catch-up contributions are also matched. Rollovers are not matched. The Company's matching contributions were \$505,470 for the year ended December 31, 2023 (net of forfeitures used to reduce the Company matching contributions in the amount of \$27,347).

The Company may also make a discretionary nonelective contribution as determined by the Company's Board of Directors each year. Contributions are subject to certain limitations. There were no discretionary nonelective contributions for the year ended December 31, 2023.

The Company may also make a qualified nonelective contribution (QNEC) to the Plan, which is allocated to nonhighly compensated employees who are eligible to make salary deferrals. There were no QNEC contributions for the year ended December 31, 2023.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, and allocations of the Company's discretionary nonelective contribution and plan earnings (losses), and charged with an allocation of administrative expenses and investment management fees. Allocations are based on participant earnings, account balances, or specific transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Company's matching and discretionary nonelective contributions plus actual earnings (losses) thereon is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service and become fully vested after six years of service, upon normal retirement age of 59½, disability, or death.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a maximum of two loans with a minimum of \$1,000 each up to a maximum of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of interest of 2% above the prime rate of interest established by Associated Trust Company, N.A., the Trustee. Interest rates on existing loans range from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or severance of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, in partial withdrawals, or in installments if the participant's balance exceeds \$5,000. If the participant's vested account balance does not exceed \$5,000, it will be distributed in a single lump-sum payment. In addition, hardship distributions out of the participant's voluntary, Company matching, and Company discretionary nonelective contribution accounts are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's matching and discretionary nonelective contributions. These forfeitures may be used by the Plan for several purposes at the Company's discretion. At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$2,255 and \$2,419, respectively. During 2023, forfeitures of \$27,347 were used to reduce Company matching contributions.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2023 or 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit is recorded.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

The Company absorbs plan audit fees. The Plan pays administrative expenses and investment advisory and management fees. Administrative expenses and investment advisory and management fees are allocated proportionately to plan participants based on their respective account balances. Fees related to the administration of notes receivable from participants and lump-sum distributions are charged directly to the participant's account and are included in administrative expenses. Investment management fees are allocated to participants and are based on participant earnings, account balances, or specific transactions, as defined, and included in net investment income.

#### Subsequent Events

The Plan has evaluated subsequent events through October 15, 2024, which is the date the financial statements were available to be issued.

The Company was acquired by another entity during 2024, and as a result, on February 27, 2024, the Company's Board of Directors made a resolution to terminate the Plan effective March 8, 2024, at which time all participant and Company contributions into the Plan ceased. Employees of the Company will transition to employment with the acquiring entity, and eligible employees of the Company will have the option to participate in the plan sponsored by the acquiring entity subsequent to the employment transition.

Upon termination of the Plan, all participants became 100% vested in their account balances. Substantially all of the assets of the Plan were liquidated in accordance with participants' directives effective August 12, 2024.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust funds:* Valued at the NAV of units held by the Plan at year-end. Fair value is estimated using NAV as a practical expedient. The NAV's share price is quoted on a private market that is not active; however, the unit price is based on underlying investments, which are traded on an active market.

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held, notes receivable from participants, and interest and dividends receivable at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Associated Trust Company, N.A. ("Associated"), the Trustee of the Plan.

### Note 5: Party-in-Interest Transactions

Plan investments are managed by Associated, the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Trustee also provided third-party administrative services to the Plan.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 6: Plan Termination

The Company's Board of Directors voted to terminate the Plan effective March 8, 2024, at which time all participant and Company contributions into the Plan ceased and all participants became 100% vested in their account balances. See Note 2 - Subsequent Events for additional information.

### **Note 7: Tax Status**

The Company adopted a non-standardized preapproved plan document with an IRS notification letter which states the non-standardized plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
