## INDEPENDENT AUDITORS' REPORT

October 15, 2024

To the Participants and Plan Administrator and  
of the Baker Commodities Supplemental Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Baker Commodities Supplemental Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, are complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Baker Commodities Supplemental Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Baker Commodities Supplemental Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTES TO FINANCIAL STATEMENTS**

**DECEMBER 31, 2023**

**NOTE 1 — DESCRIPTION OF THE PLAN:**

The following description of the Baker Commodities Supplemental Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for complete information.

*General*

The Plan is a cash deferred arrangement under Section 401(k) of the Internal Revenue Code of 1986, as amended (the “Code”), covering non-union and certain union employees of Baker Commodities, Inc. (the “Company”). The Plan was established for the purpose of providing retirement benefits for employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan is administered by the Pension Committee, members of which are appointed by the Company’s Board of Directors. In general, contributions to the Plan, as well as investment earnings, are tax deferred. The Plan was adopted April 1, 2007.

Effective December 28, 2023, the Plan was amended and restated (see Note 7).

*Eligibility*

Non-collectively bargained employees and certain union employees are eligible to participate in the Plan upon completing two months of service and reaching 21 years of age.

*Contributions*

Employees may elect to defer a percentage of their eligible compensation into the Plan. Compensation deferral cannot exceed the maximum deferral, as determined by the Internal Revenue Service (IRS) each year. Such deferral limitation was \$22,500 and \$20,500 in 2023 and 2022, respectively, and employees who attained the age of 50 on or before December 31, 2023 and 2022 were eligible to make catch-up contributions of up to \$7,500 and \$6,500, respectively, during each respective Plan year.

Effective January 1, 2013, the Company converted the plan to a safe harbor plan covering all eligible employees. The Company now makes a 3% contribution regardless of the amount of each plan participant’s elective deferrals. The Company may make additional discretionary contributions to the plan, as approved by the Company’s Board of Directors.

During the years ended December 31, 2023 and 2022, the Company’s contributions to the Plan were approximately \$1,096,000 and \$1,007,000, respectively.

## **NOTE 1 — DESCRIPTION OF THE PLAN: (Continued)**

### *Participant Accounts*

The investment custodian maintains an account in the name of each participant. Each eligible participant's account is credited with (a) the participant's contributions, (b) the allocated amount of the Company's discretionary contribution, if any, and (c) an allocation of Plan earnings. Plan earnings, by investment fund, are allocated daily by the investment custodian on the basis of the ratio that each eligible participant's account balance in the fund as of the beginning of the day bears to the total account balances of all participants in the respective fund.

Employees are permitted to obtain loans from the Plan in certain instances.

### *Investments*

Participants may direct the investment of their individual contributions and any Company discretionary contributions in any one or more of the investment funds established for the Plan. Participants may elect to change the investments of their contributions and any Company discretionary contributions, or to transfer all or part of their account balances, among the various investment funds in increments of one percent. The Company maintains information about each investment option for use by the participants of the Plan.

The following investment options were available at December 31, 2023:

*Key Guaranteed Portfolio Fund* – The Funds seeks to achieve consistent returns to support a competitive credited rate.

Participants may change their investment options daily through use of an internet-based system maintained by the investment custodian.

### *Vesting*

Participant contributions are fully vested when made. Company contributions to certain union employee plans vest based upon credited years of service.

### *Distributions and Payment of Benefits*

The normal retirement age is 65. Upon the death, disability or retirement at or after normal retirement age of a participant who had not incurred a separation from service, their account is fully vested. A participant who incurs a termination of employment prior to normal retirement age is entitled to that portion of Plan benefits earned to date, with vesting based upon the years of service credited as of the date of termination.

### *Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

## **NOTE 1 — DESCRIPTION OF THE PLAN: (Continued)**

### *Forfeitures*

Forfeitures of terminated participants' non-vested account balances may be used to pay expenses or reduce employer contributions. During the years ended December 31, 2023 and 2022, there were no forfeitures used to reduce expenses or employer contributions. At December 31, 2023 and 2022, the unallocated forfeiture balance was \$60,846 and \$522, respectively.

### *Plan Expenses*

Administrative expenses and fees of the Plan and the trust are to be paid out of trust assets. The Company may, however, at its discretion reimburse the trust for such administrative expenses. During the years ended December 31, 2023 and 2022, the Company paid approximately \$45,000 and \$52,000, respectively, for such expenses.

### *Notes Receivable from Participants*

Notes receivable from participants are secured by the participant's account balance and may not exceed the lesser of 50 percent of the participant's account balance or \$50,000 in the aggregate for any individual participant. Loan maturity is not to exceed five years, except in the case where the loan is used to acquire or construct the participant's principal residence, in which case loans may be extended up to 10 years.

Loans bear interest at annual rates varying with the prime interest rate plus one percent on the date the loan is processed. At December 31, 2023, the annual rate of all notes outstanding ranged between 5.25 percent through 10.50 percent. Principal and interest are paid ratably through payroll deductions and on occasion directly from the participant to the Plan's investment custodian.

## **NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

### *Basis of Accounting*

The Plan's financial statements are prepared on the accrual basis, in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Contributions made by participants and the employer are recorded on the accrual basis. Contributions are recognized during the period in which the related compensation was earned.

Benefit payments to participants are recorded when paid.

## **NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (Continued)**

### *Investment valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and insurance company. See Note 3 for discussion of fair value measurements.

Investments in registered investment companies are valued at the quoted net asset value of the shares held by the Plan at year end. See Note 3 for discussion of fair value measurements.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and changes therein and disclosure of contingent assets at the date of the financial statements. Significant estimates are made in determining fair value of investments in pooled separate accounts. Actual results could differ from those estimates.

### *Concentration, Market Risks and Uncertainties*

Plan assets consist of various investments, which are exposed to a number of risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

### *Reclassifications*

Certain amounts in the 2022 financial statements have been reclassified to conform to the 2023 presentations. These reclassifications had no effect on previously reported net assets available for benefits.

### NOTE 3 - FAIR VALUE MEASUREMENTS:

Generally Accepted Accounting Principles describes a fair value hierarchy based on three levels of inputs, of which the first two are considered observable and the last unobservable, that may be used to measure fair value:

- Level 1 – Quoted prices in active markets for identical assets or liabilities.
- Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly; such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active; or other inputs that can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used at December 31, 2023 and 2022.

The reported values for fixed annuity options are reporting daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

The valuation of registered investment companies is determined based on quote net asset value of fund shares held. These fair values are generally obtained from third party pricing services or determined through the use of valuation models or methodologies, including matrix pricing, using substantially all observable inputs. Fund shares may be redeemed on a daily basis with no redemption restrictions, and investments in any class can be transferred once every thirty-day at the current net assets value per share based on the fair value of the underlying assets.

Registered investment companies may be redeemed on a daily basis, may with no redemption restrictions, and investments can be transferred once every thirty-days at the current asset value per share based on the fair value of the underlying assets. Participants are not allowed to transfer back into the originating investment until the thirty-day period has expired. New contributions are allowed during this time period.

Collective Investment Trusts (CITs) invest in stable value investment contracts (Stable Value Contracts) issued by life insurance companies, banks and other financial institutions, fixed income instruments that underlie Stable Value Contracts and other money market instruments. Under a Stable Value Contract, issuer of the contract agrees, subject to contract conditions, to make payments representing redemptions from the Fund for participant-initiated benefit payments at "contract value" which is generally equal to the principal plus accrued interest of the underlying investments. This "benefit responsiveness" is designed to allow the CITs to maintain participant balances at book value (except under certain circumstances set forth with the Stable Value Contracts) while the impact of market fluctuations on investor account balances is potentially smoothed via periodic adjustments to the daily rate of return credited to investors. As a practical expedient, the fair value of the CITs are reported based on the NAV of the CIT units since such units are not actively traded on a public market.

### NOTE 3 - FAIR VALUE MEASUREMENTS: (Continued)

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – CHANGE IN SERVICE PROVIDER**

On December 28, 2023, Plan trustees adopted the Non-Standardized Pre-Approved Profit Sharing Plan with CODA with an effective date of January 1, 2024. As of January 2, 2024, assets were received by Principal Trust, but had not been allocated to participant accounts. The Plan conversion was completed on January 3, 2024 and assets were allocated to participants.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS:**

Certain Plan investments are managed by Empower Retirement. Empower Management is also the investment custodian and record keeper as defined by the Plan and, therefore, these other services meet the ERISA definition of party-in-interest transactions. Purchases and sales and the underlying investments comprising are open market transactions at fair market value. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. Additionally, management fees and operating expenses charged to the Plan for investments in pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments. Fees paid by the Plan to Empower Retirement for record keeping services totaled approximately \$70,900 and \$54,200 during the years ended December 31, 2023 and 2022, respectively.

Effective January 3, 2024, certain Plan investments are shares of pooled separate accounts managed by Principal Global Investors and / or Principal Financial Advisors, which along with Principal Life Insurance Company are members of Principal Financial Group. Principal Life Insurance Company is also the trustee, custodian and record keeper as defined by the Plan and, therefore, these other services meet the ERISA definition of party-in-interest transactions.

**NOTE 7 — TAX STATUS OF THE PLAN:**

The Plan operates under the provisions of a volume submitter profit sharing employee benefit plan initially developed by Dissinger Associates Plan Administration & Design, Inc. On August 9, 2023, the Plan administrator obtained a determination letter from the Internal Revenue Service regarding the Plan's tax status as a qualified employee benefit plan. The Plan has been amended since the Internal Revenue Service issued its determination letter for the volume submitter profit sharing plan. The newly adopted Non-Standardized Pre-Approved Profit Sharing Plan with CODA obtained a determination letter from the Internal Revenue Service regarding the Plan's tax status as a qualified employee pension plan on June 30, 2020. However, the plan administrator, Empower Retirement and the Plan's tax counsel believe that the Plan, as amended, is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In accordance with U.S. GAAP, Plan management is required to evaluate the tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon the examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is not currently under audit nor has the Plan been contacted by any jurisdiction. The Plan's tax returns generally remain open for IRS audit for three years from the filing date. Based on the evaluation of the Plan's tax positions, management believes all tax positions taken would be upheld under an examination. Therefore, no provision for the effect of uncertain tax positions have been recorded for the years ended December 31, 2023 and 2022.

**NOTE 8 – SUBSEQUENT EVENTS:**

The Company evaluated all events and transactions that occurred from the balance sheet date of December 31, 2023 through October 15, 2024, the date the financial statements were available to be issued. During this period, except as noted in the following paragraph, there were no events or transactions occurring which require recognition or disclosure in the financial statements.
