Opinion

NOTE 1. DESCRIPTION OF THE PLAN

General

The Sharp Rees-Stealy Medical Group, Inc. (the "Company" and the "Employer") 401(k) Retirement Savings Plan (the "Plan") was formed effective July 1, 1998, by the Employer. The following description of the Plan provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

The Plan is a single-employer defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), and provisions of the Internal Revenue Code ("IRC").

Effective December 31, 2023, the assets of the Plan were transferred and merged into the Sharp Rees-Stealy Medical Group, Inc Profit Sharing Plan, another retirement plan sponsored by the Company, thereby effectively terminating the Plan.

Eligibility

Employees, except those excluded by the Plan, become eligible to make salary deferrals and receive matching contributions once they have completed three months of service. For the purpose of salary deferrals and matching contributions, the entry date will be the first day of the month coinciding with or next following the date eligibility requirements are met. Employees covered by a collective bargaining agreement, nonresident aliens with no income from U.S. sources, and leased employees are not eligible to participate in the Plan. For purposes of receiving matching contributions, excluded employees include employees covered by a collective bargaining agreement, nonresident aliens with no income from U.S. sources, leased employees, and physicians.

Contributions

Each year, participants may contribute up to 100% of their eligible compensation, as defined in the Plan, subject to limits imposed by Internal Revenue Service ("IRS") regulations. Participants may also, at the discretion of the plan administrator, contribute amounts representing distributions from other retirement plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants can change their contribution percentages on the first day of any month and may revoke their salary deferral election any time during the Plan year.

The Company makes matching contributions for all participants, except those excluded by the Plan. The Company's matching contribution calculation is as follows: (1) eligible participants with less than 10 years of service at the end of the Plan year receive a matching contribution equal to 100% of elective deferrals up to 2% of Plan eligible compensation; and (2) eligible participants with 10 years of service or more at the end of the Plan year receive a matching contribution equal to 100% of elective deferrals up to 3% of Plan eligible compensation. To be entitled to the employer match, the employee must be employed by the Company on the last day of the Plan year and have completed a year of service during the Plan year. A year of service is defined as having completed at least 1,000 hours of service during the Plan year.

Participant Accounts

Each participant self-directs their investments and makes all of their own investment decisions. Each participant's separate account is credited with (a) the participant's contribution, (b) the participant's allocation of the Company's contribution and (c) allocations of Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined.

Administrative charges related to participant loans and distributions are deducted directly from the transacting participants' accounts or paid by the participants themselves. Investment-related expenses are generally included in net realized and unrealized appreciation or depreciation in fair value of investments. Substantially all other expenses of Plan administration are paid by the Company.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested in their accounts attributable to the following contributions (1) salary deferrals, (2) rollover contributions, and (3) matching contributions.

Investment Options

Upon enrollment in the Plan, a participant becomes self-trusted and can fully self-direct their assets and make their own investment decisions. Participants may change their investments at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum generally equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loan terms range from 1-5 years or up to 30 years for the purchase of a primary residence and bear interest at a fixed rate of 1% over prime at the time of the loan. During the year ended December 31, 2023, interest rates on outstanding loans ranged from 4.25% to 9.50%. Interest and principal are paid ratably no less often than monthly.

Payment and Benefits

Upon termination of service due to death, disability, or retirement, a participant will automatically receive a life annuity (if not married) and will automatically receive a joint and 50% survivor annuity (if married) under which payments will be received for life.

The participant can elect an alternative form of payment. Alternative forms of payment include:

- a. single lump sum payment; or
- b. partial withdrawals of at least \$1,000

Payment and Benefits (Continued)

Participants terminating employment before death, disability, or retirement may elect to have their vested account balances distributed to them as soon as administratively feasible following their termination.

Pursuant to provisions in the Setting Every Community Up for Retirement Enhancement Act of 2019 (the "SECURE" Act), which became law on December 20, 2019, and the SECURE 2.0 Act of 2022 (the "SECURE Act 2.0"), which became law on December 29, 2022, participants may defer taking distributions as follows:

- If a participant reached the age of 70½ in 2019, the participant may defer receiving distributions until the later of April 1, 2020, or the April following the calendar year in which the participant retires;
- If a participant reaches the age of 70½ in 2020 or later, the participant may defer receiving distributions until the later of the April following the calendar year in which the participant reaches age 72 or retires, except that –
- Beginning in 2023, the age a participant must begin taking distributions was raised to 73. If a participant reaches the age of 72 during 2023, the participant may defer receiving distributions until April 1, 2025, the latest date that a required minimum distribution may be taken for 2024.

The Plan also allows for in-service distributions if the participant has reached age 59½.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, contributions and investment interest and dividends are recognized when received rather than earned and expenses are recognized when paid rather than incurred.

Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recognized when received. Net realized and unrealized appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Cash

The Plan, at times, has amounts deposited at financial institutions that exceed federally insured limits. The Plan believes there is no significant risk with respect to these deposits.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal. Related fees are recorded as administrative expenses and are expensed when they are paid. If the participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. For the year ended December 31, 2022, the excess participant contributions in the amount of \$81,729 were disbursed from the Plan during 2023.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company or the participants and are excluded from these financial statements. Certain fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses or are paid directly by the participant. Administrative and other expenses include investment advisory and management fees.

Subsequent Events

The Plan has evaluated subsequent events through the date of the independent auditors' report, which is the date these financial statements were available to be issued.

NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement for the asset or liability at the measurement date. These inputs reflect Plan management's best estimate of what market participants would use in pricing the asset or liability at the measurement date. Consideration is given to the risk inherent in the valuation technique and in the inputs to the model.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2022. As of December 31, 2023, the Plan's assets have been transferred to the Sharp Rees-Stealy Medical Group, Inc. Profit Sharing Plan (Note 1).

Money Market Funds and Certificates of Deposit ("CDs"): Valued at carrying value, which approximates fair value.

Common Stocks, Preferred Stocks, and Government and Corporate Debt: Valued at the closing prices reported on the active market on which the individual securities are traded.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

All Other Investments: All other investments are not actively traded and other significant observable inputs are not available. The best available unobservable inputs were used to estimate fair value for these investments.

NOTE 5. PARTY-IN-INTEREST TRANSACTIONS

Certain of the Plan's operating expenses are paid by the Company and the Company provides certain administrative services for the Plan at no cost to the Plan. In addition, the Plan allows participants to take loans against their account balances. These transactions are considered exempt party-in-interest transactions.

NOTE 6. TAX STATUS

The Plan received a favorable determination letter from the IRS dated September 27, 2022, stating that the Plan, including amendments, meets the requirements of Section 401(a) of the IRC and is exempt from federal income taxes under Section 501(a) of the IRC. Therefore, no provision for income taxes has been included in the accompanying financial statements. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require a recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Transition/Blackout Notice

As previously announced, effective December 31, 2023, Sharp Rees-Stealy Medical Group, Inc., will be merging the three defined contribution retirement plans listed below into a single plan, which will be named the Sharp Rees-Stealy Medical Group, Inc. Retirement Savings Plan.

- Sharp Rees-Stealy Medical Group, Inc. 401(k) Retirement Savings Plan
- Sharp Rees-Stealy Medical Group, Inc. Money Purchase Pension Plan
- Sharp Rees-Stealy Medical Group, Inc. Profit Sharing Plan

The Sharp Rees-Stealy Medical Group, Inc. Cash Balance Plan will not be involved in the plan merger and all rights, benefits and features will remain unchanged.

Announcement of Blackout Period

NWPS has been engaged to provide administrative services for the Sharp Rees-Stealy Medical Group, Inc. Retirement Savings Plan and the transition from the current provider, TRI-AD, to NWPS will require a period in which you will not be able to request certain transactions.

This period, during which you will be unable to exercise these rights otherwise available under the plan, is called a "blackout period." Whether or not you are planning retirement in the near future, we encourage you to carefully consider how this blackout period may affect your retirement planning, as well as your overall financial plan. The blackout period will start December 1, 2023, and end the week of January 29, 2024

You are still able to make transactions within your self-directed account during this period. Only transactions that remove assets from the Retirement Savings Plan will be restricted.

Restricted Transactions

During the blackout period you will be unable to request a loan, in-service withdrawal, or total plan distribution.

Participant Loans

- If you need to take out a participant loan prior to the end of the year, you must contact TRI-AD and obtain the necessary paperwork as soon as possible.
- You must submit your paperwork, in good order to TRI-AD no later than 11/30/2023.
- Any paperwork received by TRI-AD after 11/30/2023 will not be processed until after the blackout period ends.

Inservice Withdrawals and Total Plan Distributions

- If you are a terminated participant and wish to rollover your account to an IRA or another employer's plan you must contract TRI-AD to obtain the necessary paperwork as soon as possible.
- If you are an active participant and need an in-service withdrawal prior to year-end, you will need to contract TRI-AD to obtain the necessary paperwork as soon as possible.
- You must submit your paperwork, in good order to TRI-AD no later than 11/30/2023.
- Any paperwork received by TRI-AD after 11/30/2023 will not be processed until after the blackout period ends.

Investment Direction

During the blackout you will be able to direct or diversify investments in your individual brokerage accounts. As a reminder, it is very important that you review and consider the appropriateness of your current investments. For your long-term retirement security, you should give careful consideration to the importance of a well-balanced and diversified investment portfolio, taking into account all your assets, income and investments.

What happens after the blackout period is over?

You will be notified after the blackout is over. You will then have access to the NWPS participant website which will allow you to:

- Select your user ID and password
- Update your beneficiary information
- Review your account balances
- Change your 401(k) deferral election
- Review the new core investment options, including historical performance and fees
- Chose to invest your future contributions into the core investment options

The participant website will also provide information on how to transfer the assets in your self-directed brokerage accounts or mutual fund to the core investment funds.

Website login information will be provided when the blackout ends in January.
