Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Enterprise Florida, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements are comprised of the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing), and the related statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2023 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Enterprise Florida, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are

presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Enterprise Florida, Inc. Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note A to the financial statements, the Plan sponsor terminated the Plan on August 5, 2023. As a result, the Plan changed its basis of accounting from the ongoing plan basis used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the

participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. A. Description of the plan:

The following description of the Enterprise Florida, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General:

The Plan was a defined contribution plan covering all employees of Enterprise Florida, Inc. (the "Company") that were age 21 or older and not a leased employee. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2023, Florida Legislature passed House Bill 5 which dissolved the Plan Sponsor effective July 1, 2023. As such, all employees were terminated during 2023 and the Plan terminated effective August 5, 2023. Due to the Plan termination, all participants became 100% vested in all contributions. Participants received terminating distributions in the form of rollovers to a retirement plan of the participant's choice or a lump sum payment to the participant. Participants that transferred employment to a related employer were also permitted rollovers to the related employer's retirement plan.

Contributions:

Participants were permitted to contribute up to 100% of compensation, as defined in the Plan, subject to Internal Revenue Code limitations. Participants who attained the age of fifty before the end of the Plan year were eligible to make catch-up contributions. The Company matched 25% of the first 4% of all wages the employee contributed and made bi-weekly discretionary contributions equal to 7% of employee wages excluding bonuses. The Plan included a Safe Harbor provision which required the Company to make minimum qualified non-elective contributions in accordance with requirements of the Internal Revenue Code. Under the Safe Harbor provision, the Company contributed 3% of all employee wages. Participants directed the investment of their accounts into various investment options offered by the Plan. Forfeitures of terminated participants' non-vested accounts were first used to reduce any reasonable Plan expenses and then to reduce the company contributions.

Voluntary "rollover" contributions were accepted by the Plan under certain terms and conditions.

A. Description of the plan (continued):

Participant accounts:

Each participant's account was credited with participant contributions and allocations of (a) the Company's contributions, (b) forfeitures of terminated participants' non-vested accounts and (c) Plan earnings. Allocations were based on participant compensation or account balances, as defined. The benefit to which a participant was entitled equaled the vested balance of the participant's account.

Vesting:

Participants were immediately vested in all of their contributions and the Company's qualified non-elective contributions plus actual earnings. Effective August 5, 2023, participants were immediately vested in the Company's contributions plus actual earnings. Prior to August 5, 2023, vesting in the Company's match and discretionary contributions plus actual earnings was based on years of service as defined in the Plan. A participant vested at 33.33% annually until fully vested upon completion of three years of credited service. Any participant employed at the date of total and permanent disability, death or the attainment of normal retirement age, as defined, was deemed to be 100% vested.

Participant notes receivable:

Participants were permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participants' vested account balances. The receivables were secured by the balance in the participants' accounts and accrued interest at a rate commensurate with the prime lending rate effective when the receivable originated. Principal and interest were paid ratably through bi-weekly payroll deductions.

Payment of benefits:

Upon termination of service, death, disability or retirement, a participant was permitted to receive a lump-sum payment equal to the vested value of his or her account.

A. Description of the plan (continued):

Payment of benefits (continued):

Participants who continued in the employment of the Company were permitted to request a pre-retirement distribution of defined amounts under certain hardship conditions, as defined in the Plan.

The Plan also allowed for in-service distributions of the participant's vested accounts upon reaching the age of 59 ½ or under certain qualifying conditions, as defined in the Plan.

Forfeited accounts:

For the years ended December, 31, 2023 and 2022, forfeited non-vested accounts were used to reduce Company matching contributions and pay plan expenses of of \$20,209 and \$44,772, respectively.

At December 31, 2022, there were \$1,031 of forfeited non-vested accounts, available to reduce future employer contributions and plan expenses. As December 31, 2023, there were no forfeited non-vested accounts.

B. Summary of significant accounting policies:

Basis of accounting:

As discussed in Note A, the Plan sponsor terminated the Plan effective August 5, 2023. Accordingly, the accompanying financial statements of the Plan for the year ended December 31, 2023 were prepared on the liquidation basis of accounting. The financial statements of the Plan for the year ended December 31, 2022 were prepared on the accrual method of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

Use of estimates:

The preparation of financial statements in conformity with GAAP required management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

B. Summary of significant accounting policies (continued):

Investment valuation and income recognition:

The Plan's investments were reported at fair value. Fair value was the price that would have been received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis.

The Plan's investment contracts (Guaranteed Interest Accounts) were not fully benefit-responsive and were stated at fair value as determined by the custodian of the Plan's assets.

The change in fair value of investments and realized gains (losses) were reflected in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. The realized gains or losses on investments was the difference between the proceeds received and the fair value of the investment sold at the beginning of the Plan year.

Participant notes receivable:

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest.

Payment of benefits:

Benefits were recorded when paid.

C. Information prepared and certified by the custodian:

The plan administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

C. Information prepared and certified by the custodian (continued):

The investment information included in the accompanying financial statements was obtained from data that was certified as complete and accurate to the plan administrator by Principal Life Insurance Company (Principal), the custodian of the Plan, at December 31, 2023 and 2022. Incorporation of this financial information in the accompanying financial statements and supplemental schedule was based solely on those certifications.

The investment income reported in the statement of changes in net assets available for benefits for the year ended December 31, 2023 was also certified by Principal.

D. Fair value measurements:

The Fair Value Measurements and Disclosures Topic of FASB ASC required disclosure of a fair value hierarchy of inputs the Plan used to value an asset or a liability.

The three levels of the fair value hierarchy are described as follows:

Level 1: Quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan could access at the measurement date. For the Plan, Level 1 inputs included marketable securities that are actively traded.

Level 2: Inputs other than Level 1 that were observable for the asset or liability, either directly or indirectly. The Plan did not have any Level 2 assets at December 31, 2023 or 2022.

Level 3: Inputs that represent financial assets or liabilities whose values were based on prices or valuation techniques that required inputs that are both unobservable and significant to the overall fair value measurement.

The determination of where assets and liabilities fell within this fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used needed to maximize the use of observable inputs.

D. Fair value measurements (continued):

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2023 and 2022.

Mutual Funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan were open-ended funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Pooled Separate Accounts: Valued at the net asset value of shares held by the Plan at year end.

Collective Investment Trusts: Valued using fair value of pooled separate accounts and mutual funds that comprised the collective investment trusts.

Guaranteed Interest Accounts: Valued at fair value using guaranteed interest account values adjusted for current market interest rates to the extent such market rates exceed contract crediting rates. This value represented contributions allocated to the guaranteed interest accounts, plus interest at the contractually guaranteed rate, less funds used to pay Plan benefits and expenses.

The methods described above may produce a fair value calculation that may not have been indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

E. Tax status:

The Internal Revenue Service determined and informed Principal by a letter dated June 30, 2020, that the Plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan was subsequently amended; however, the plan administrator believed the Plan continued to be designed and operated in accordance with the applicable requirements of the code. Therefore, no provision for income taxes was included in the Plan's financial statements.

F. Related party transactions:

Certain Plan investments were shares of mutual funds managed by Principal, the custodian as defined by the Plan and, therefore, these transactions qualified as exempt party-in-interest transactions.

G. Administrative expenses:

Administrative expenses associated with custody and recordkeeping were paid by the Company. Loan and other transaction fees were charged to participants. The Company provided certain accounting and management services to the Plan at no charge and paid for the annual audit of the Plan.

H. Risks and uncertainties:

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could have occurred in the near term and that such changes could have materially affected participants' account balances and the amounts reported in the statement of net assets available for benefits.

I. Subsequent events:

Subsequent events were evaluated through October 15, 2024, which is the date the financial statements were available to be issued.
