## Independent Auditors' Report

To the Administrator and Participants of  
Ontic 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2023 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Other Matter - 2023 Supplemental Schedule Required by ERISA**

The supplemental schedule, Schedule of Assets Held at End of Year as of December 31, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

We did not audit or review the 2022 financial statement, nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by management. Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on the 2022 financial statement.

## Notes to Financial Statements Year Ended December 31, 2023

---

### 1. Description of Plan

The following brief description of Ontic 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan covering substantially all employees of Ontic Technologies, Inc. (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Betterment for Business LLC is the recordkeeper (the “Recordkeeper”), Betterment LLC is the investment advisor (the “Investment Advisor”), and Inspira Financial Trust, LLC is the Trustee (the “Trustee”) of the Plan. Company management personnel act as the administrator of the Plan.

**Eligibility** - Employees who are at least eighteen years of age are eligible to participate in the Plan immediately. Union employees and non-resident aliens with no U.S. source income are not eligible to participate in the Plan.

**Contributions** - All newly eligible employees are automatically enrolled in the Plan with a pre-tax deferral percentage of 5%, unless the employee changes the election. Participants have the option to contribute pre-tax and Roth contributions, and may authorize the Company to withhold up to the annual limit established by the Internal Revenue Code (“IRC”). A participant’s pre-tax and Roth contributions are separately accounted for, as are the gains and losses attributable to each. Participants who reach fifty years of age before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts and repayments of 2020 penalty-free distributions permitted under the Coronavirus Aid, Relief, and Economic Security Act.

The Company may make a discretionary employer matching contribution, although this was not elected for the year ended December 31, 2023.

Participants direct the investment of contributions into various investment options offered by the Plan.

**Participant Accounts** - Each participant’s account is credited with the participant’s contributions, the Company’s contributions and an allocation of Plan earnings, and may be charged with an allocation of Plan expenses, as applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

**Notes Receivable from Participants** - Notes receivable from participants are not permitted.

**Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer matching contributions plus actual earnings thereon is based on years of credited service. Participants are 100% vested in the employer matching contributions after four years of credited service, as defined, which is earned in 25% increments annually. Participants may also become fully vested upon reaching retirement age, if they become disabled while employed with the Company or terminate employment due to death.

**Payment of Benefits** - Benefits are generally payable upon age 59.5, disability, death, retirement or termination of employment. Benefits equal to the participant's vested account balance may be paid to a participant or beneficiary by lump sum, partial withdrawals or rollover into a qualified plan, subject to regulatory requirements. Required minimum distributions are made to applicable participants in the absence of adequate distribution elections. Generally, if no longer employed by the Company, participants must either take a lump sum distribution or begin systematic, actuarially determined withdrawals by April 1 of the year following the year in which the participant turns 73 years of age (an increase from 72 years of age effective January 1, 2023). In-service distributions of rollover contributions may be taken at any time. In-service qualified reservist distributions are permitted if certain criteria are met.

**Forfeitures** - Forfeitures by participants of unvested Company contributions are used to pay Plan administrative expenses and to reduce future employer contributions. There was no forfeiture balance as of December 31, 2023 or 2022 (compiled) as there have been no employer matching contributions since the Plan's inception.

**Current Legislation** - The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date, all of which range over the next several years. Any SECURE 2.0 amendments must be adopted by the Plan no later than December 31, 2026, although it may operate under the new provisions as required or elected prior to amending the Plan document. The Company is currently evaluating the impact of the remaining required and voluntary provisions of SECURE 2.0 on the Plan and its participants.

## 2. Significant Accounting Policies

**Basis of Accounting** - The Plan's financial statements are prepared on the accrual basis of accounting.

**Accounting Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan fiduciaries determine the Plan's valuation policies utilizing information provided by the Trustee and the Investment Advisor. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the Plan year.

**Contributions Receivable** - Contributions from participants are recorded in the year in which the participant contributions are withheld from compensation. The Company recognizes an allowance for credit losses based on factors such as the age of the contribution receivable balance, historical experience, current economic conditions, and reasonable and supportable forecasts. There was no allowance for estimated credit losses as of December 31, 2023 or 2022 (compiled) as management deemed the outstanding contribution receivable balances collectible.

**Benefits Paid to Participants** - Benefits are recorded when paid.

**Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from the financial statements. Advisory and recordkeeping fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are also included in net appreciation in fair value of investments.

**Risks and Uncertainties** - Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer contribution portion of their accounts.

**Subsequent Events** - The Company has evaluated subsequent events through October 14, 2024, the date the financial statements were available to be issued, and no events have occurred through that date that would impact the financial statements except for the impact of current legislation as disclosed in Note 1.

### **3. Information Certified by the Trustee**

All information disclosed in the accompanying financial statements, notes and supplemental schedule related to the Plan's investments as of December 31, 2023, and the related net investment gain during the year then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee.

#### 4. Fair Value Measurements

The Plan follows a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022 (compiled).

*Exchange-traded funds:* Exchange-traded funds are valued at the closing price reported by the active market on which the individual securities are traded.

## 6. Tax Status

The Company has not applied for a determination letter from the Internal Revenue Service (“IRS”) to determine if the Plan is designed in accordance with applicable sections of the IRC. The Plan document is based upon a pre-approved plan instrument from CCH Incorporated dba ftwilliam.com which received an IRS opinion letter dated June 30, 2020. Although the pre-approved plan instrument has been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 7. Party-in-Interest and Related Party Transactions

Fees earned by the Recordkeeper and Investment Advisor are included in administrative expenses. Transactions such as these qualify as party-in-interest transactions. The Company pays directly certain other fees related to the Plan’s operations.
