## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of **SWORD Health Technologies Inc 401(k) Plan**:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of **SWORD Health Technologies Inc 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

**A. Description of Plan**

The following description of SWORD Health Technologies Inc 401(k) Plan (the “Plan” or “SWORD Plan”) provides only general information. Participants should refer to the Plan document or the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution, tax-deferred profit sharing plan established January 1, 2022, covering all employees of SWORD Health Technologies Inc. (the “Company”) and Sword Health Care Providers P.A. (“Affiliate”), with certain exceptions. The Company is the Plan sponsor and serves as the Plan administrator.

Employees aged 21 years or older are eligible able to participate in the plan immediately upon hire and may begin participation as of the first day of the following month. Non-resident aliens with no U.S. income and residents of Puerto Rico are exempt from participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect deferral contributions as either pre-tax or Roth elective deferrals or both up to 90% of compensation, not to exceed the maximum salary deferral limit and other limitations established by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the Internal Revenue Code (IRC). The Plan permits rollover contributions from other qualified retirement plans and certain individual retirement accounts. In-plan Roth rollovers are permitted. Participant contributions are invested according to direction of the participants. Beginning in June 2024, the Plan implemented automatic enrollment procedures for new hired employees for certain parts of the company and for all company employees beginning January 2025.

The Company has the option to make profit sharing contributions to the Plan, although the Company is not required to do so. Profit sharing contributions are invested according to participant investment elections.

Participant Accounts

Each participant's account is credited with the participant's contributions and any Company contributions. Investment earnings, losses, and changes in market value are allocated based upon the investment experience of each holding in a participant account. Certain transactional costs and service charges, if any, are allocated to the specific accounts involved in the transaction or receiving the service. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own deferral contributions, rollover contributions, and earnings thereon. Profit sharing contributions and related investment earnings are subject to a six-year vesting period.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms require amortization of principal and interest over a period not to exceed five years, with certain exceptions for purchase of a primary residence.

Participants may have a maximum of two loans outstanding at a time. Loans are secured by the balance in the participant's account. The loan interest rate is set at the prime rate of interest in effect as of the initiation of the loan plus 2%. Principal and interest are paid ratably through payroll deductions.

Payments of Benefits

Plan participants are eligible to receive benefit payments from the Plan at retirement, prior to retirement under certain circumstances, upon termination of employment with the Company, upon disability and at death. Benefit payments are limited to the value of the participant's vested interest in his or her account. Payment of benefits may be requested as a lump-sum payment or as a partial payment. Hardship and in-service withdrawals are allowed, subject to Plan provisions and applicable law.

**B. Summary of Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. The loans are secured by vested participant account balances. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain administrative expenses of the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Per-use transaction fees are charged directly to specific

participant accounts for certain services, such as processing loans, in-service withdrawals, distributions, and other transactions, and are included in fees and other expenses. In addition to per-use transaction fees, participants with account balances share in the operational expense of the Plan. In addition, certain investment related expenses are net against the investment returns of the applicable investments.

Subsequent Events

The Plan has evaluated subsequent events for disclosure in these financial statements through September 26, 2024, the date the financial statements were available to be issued.

**C. Information Prepared and Certified by the Plan Trustee**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified as to the completeness and accuracy of investment and participant loan balances and related investment and loan activity in these financial statements and supplemental schedule, summarized as follows:

**D. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability. Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds are valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**E. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

**F. Related Party and Party-In-Interest Transactions**

Automatic Data Processing, Inc. (“ADP”) is the recordkeeper of the Plan and Reliance Trust Company is the trustee of the Plan. Each receives fees for services. The Company provides the Plan with accounting and administrative services, for which no fees are charged to the Plan. The Plan allows loans to participants. These transactions qualify as party-in-interest transactions. In June 2024, the Plan accounts were moved to Guideline, Inc. for recordkeeping services and to Benefit Trust Company for trustee and custodial services.

**G. Tax Status**

The Internal Revenue Service has determined and reported in its opinion letter dated October 6, 2020, that the form of adopted pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan administrator believes the Plan is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no uncertain tax positions have been taken or are expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, currently there are no audits for any tax periods in progress.

**H. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100 percent vested in their accounts, and the Company will arrange for distributions as soon as administratively feasible.
