## REPORT OF INDEPENDENT AUDITORS

To the Plan Administrator of the  
Maverick Fitness Holdings, LLC 401(k) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Maverick Fitness Holdings, LLC 401(k) Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of March 15, 2024, and December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the period from January 1, 2024 through March 15, 2024, and for the years ended December 31, 2023 and 2022, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 15, 2024, and December 31, 2023 and 2022, and for the period from January 1, 2024 through March 15, 2024, and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ## NOTES TO FINANCIAL STATEMENTS

March 15, 2024 and December 31, 2023 and 2022

### A. Description of the Plan

#### General

The following brief description of the Maverick Fitness Holdings, LLC 401(k) Retirement Plan (formerly known as SPP Resource Services, LLC 401(k) Retirement Plan) (the “Plan”) is provided for general information purposes only. Participants should refer to the summary plan document for more complete information. Until January 1, 2020, the Plan was sponsored by SPP Resource Services, LLC. As the result of an asset purchase of SPP Resource Services, LLC by Maverick Fitness Holdings, LLC in December 2019, effective January 1, 2020, the Plan was amended to change the Plan sponsor to Maverick Fitness Holdings, LLC (the “Plan Sponsor” or “Company”) and the Plan’s name was changed to Maverick Fitness Holdings, LLC 401(k) Retirement Plan. As a result of the change in the Plan Sponsor, the Plan incurred a partial Plan termination resulting from a significant number of employees who were terminated effective December 31, 2019. Accordingly, the affected participants were vested 100% in their account balances if not already vested. The Company’s corporate offices are located in Frisco, Texas.

The Plan was effective January 1, 2007, restated most recently effective January 1, 2021, and is a defined contribution plan available to substantially all employees of the Company who have attained age 18 and have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The purpose of the Plan is to enable eligible employees to defer compensation and share in employer contributions, and to save and invest funds for retirement.

Effective March 15, 2024, the Plan merged into the Secure Your Retirement 401(k) Plan, a Pooled Employer Plan. All related assets and participant accounts totaling \$3,975,865 were subsequently transferred out of the Plan and into the Secure Your Retirement 401(k) Plan on March 18, 2024.

#### Contributions

Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. In addition, participants may contribute designated Roth (after tax) contributions. Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (the “Code”) as defined in the Plan document. Eligible participants may make a rollover contribution to the Plan.

Until January 1, 2020, eligible employees who did not decline enrollment in the Plan became automatically enrolled and were considered to elect pre-tax contributions equal to 4% of their eligible compensation.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the Plan year may make catch-up contributions in accordance with, and subject to the limitations imposed by the Code.

**Contributions – continued**

The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount of the participants' elective deferrals, up to 4% of the participant's eligible compensation contributed to the Plan. For the period from January 1, 2024 through March 15, 2024, and for the years ended December 31, 2023 and 2022, the Company did not make discretionary matching contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution, Plan earnings, and forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contribution portion of accounts, plus actual earnings thereon is as follows:

Participants must work 1,000 hours in a year to accumulate a year of service.

In the event of death, disability, or reaching the normal retirement age of 65, as defined by the Plan, the participant will become fully vested.

**Benefit Payments**

Participants withdrawing during the year for reasons of service or disability, retirement, death, or termination are entitled to their vested account balance. Benefits are distributed in the form of rollovers or lump sum payments. If withdrawing participants are not entitled to their entire account balance, the amounts not received are forfeited.

##### Benefit Payments – continued

Certain in-service withdrawals are allowed. A participant may also elect to withdraw all or a portion of their vested account balance while employed after reaching age 59 ½. A participant may receive a hardship distribution from salary reduction contributions if the distribution is: (1) on account of uninsured medical expenses incurred by the participant, their spouse, or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of post-secondary tuition expenses; (4) needed to prevent eviction of the participant from their principal residence or foreclosure upon the mortgage of the participant's principal residence (5) for payments for the funeral or burial expenses for a participant's parent, spouse, child, or dependent; (6) to repair damage to a participant's principal residence that would qualify for a casualty loss; or, 7) for any other event that the IRS recognizes as a safe harbor hardship distribution event under ruling, notice or guidance of general applicability.

##### Forfeitures

Forfeited balances of terminated participants' non-vested accounts are used to pay Plan expenses or to offset employer matching contributions for the Plan year. There were no forfeitures allocated to reduce matching contributions for the period ended March 15, 2024, and years ended December 31, 2023, and 2022. Forfeitures of \$3,890 were allocated to reduce the Plan expenses for the period ended March 15, 2024. No forfeitures were allocated to reduce Plan expenses for the years ended December 31, 2023 and 2022. There were no unallocated forfeitures as of March 15, 2024, and unallocated forfeitures outstanding as of December 31, 2023 and 2022, were \$74,569 and \$59,839, respectively.

##### Investment Options

Upon enrollment in the Plan, a participant may direct their salary deferrals in 1% increments into any of the Plan's investment options.

##### Plan Expenses

Employees of the Company perform certain administrative functions with no compensation from the Plan. In accordance with Plan provisions, the Company pays substantially all costs relating to asset charges and recordkeeping. All significant administrative expenses are paid by the Company and are not reflected in the accompanying financial statements.

#### B. Summary of Significant Accounting Policies

##### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

##### **Use of Estimates**

The preparation of the financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

##### **Contributions**

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan's administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Employee contributions receivable in the amount of \$6,191 are recorded within the Plan transfers in the statements of changes in net assets available for benefits for the period from January 1, 2024 through March 15, 2024.

##### **Investment Valuation and Income**

The investments of the Plan are stated at fair value as of the end of the period/year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note C for information related to the Plan's valuation methodologies under GAAP.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains on investments include realized gains and losses on sales of investments during the period/year and unrealized increases or decreases in the market value of investments held at period/year end. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

##### **Notes Receivable from Participants**

Notes receivable from participants are recorded at the unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

##### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Code are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 excess contributions to the applicable participants prior to March 15, 2023.

##### **Payment of Benefits**

Benefits are recorded when paid.

#### **C. Fair Value Measurements**

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

- Level 1 — observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 — observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 — inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

GAAP requires that management describe the methodologies used to measure the fair value of assets and liabilities. The methodologies used to measure the fair value of the Plan's investments are as follows:

- Mutual funds are valued at the published per share net asset value of shares held by the Plan and are classified within Level 1 of the valuation hierarchy. There are no significant restrictions on redeeming these investments at net asset value.

These items are classified in their entirety based on the lowest priority level of input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the placement of assets and liabilities within the levels of the fair value hierarchy.

**D. Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments at March 15, 2024, December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends, for the period from January 1, 2024 through March 15, 2024, and the years ended December 31, 2023 and 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company (the trustee of the Plan).

**E. Tax Status**

Effective January 1, 2021, the Plan was amended and restated by the adoption of the Definiti LLC Non-Standardized Pre-Approved Profit Sharing Plan with CODA. The Internal Revenue Service (“IRS”) has issued an opinion letter dated June 30, 2020, stating that the preapproved plan is acceptable under Section 401(a) of the Code for use by employers for the benefit of their employees. The Company may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations.

#### **E. Tax Status – continued**

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since requesting its determination letter, the Plan Sponsor believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of March 15, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **F. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, all amounts credited to participant's accounts will become 100% vested.

#### **G. Parties-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Transactions with the Plan's trustee and custodian, as well as loans made to participants, qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA which are exempt from the prohibited transaction rules.

**J. Subsequent Events**

In preparing the accompanying financial statements, management has evaluated all subsequent events and transactions for potential recognition or disclosure through October 15, 2024, the date of the financial statements were available for issuance.
