### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). As a result, the Plan changed its basis of accounting from the ongoing basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**1. DESCRIPTION OF PLAN**

The following description of the Move It Management, LLC 401(k) Plan (the “Plan”) provides only general information. The Plan is sponsored by Move It Management, LLC (the “Plan Sponsor”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, established on October 22, 2018, as amended from time to time, covering substantially all employees of the Plan Sponsor. Employees are eligible to participate upon hire and are eligible for the employer match after completing one year of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as well as all provisions of the federal income tax laws.

The Trustee and Plan Administrator are responsible for oversight of the Plan and determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

The Plan was terminated on June 30, 2023 as the Plan Sponsor terminated its business and no longer has employees. In accordance with Plan provisions, the Sponsor vested 100% of the Plan’s assets as of June 30, 2023. All Plan assets were distributed by October 25, 2023.

Contributions

Each year, participants may make tax-deferred contributions to the Plan not to exceed the amount deductible for federal income tax purposes. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor may make discretionary matching and profit-sharing contributions at the option of the Plan Sponsor. During the period from January 1, 2023 through November 2, 2023, the Plan Sponsor made matching contributions equal to 1% of total compensation for each participant; however, no profit sharing contributions were made during the period from January 1, 2023 through November 2, 2023. Contributions are subject to Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s tax-deferred contributions and employer matching contributions (if any), as well as allocations of the Plan Sponsor’s profit-sharing contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their deferred salary contributions, rollover contributions from other plans and actual earnings thereon. Vesting in the Plan Sponsor’s matching contributions and profit sharing contributions, if any, plus actual earnings thereon is based on years of continuous service. A participant is 100% vested upon retirement, permanent disability, death or reaching retirement age while employed by the Plan Sponsor.

Notes Receivable from Participants

Participants may borrow from their vested account balances a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes (see Note 2), are secured by the vested balance in the participant's account and bear interest at the prime plus 2%. In determining the availability of a Plan loan, a participant may only have two outstanding loans at a time. The term of the loan may not exceed five years. However, if the loan is for the purchase of a principal residence, the Plan may permit a longer repayment term. Principal and interest on notes receivable from participants are repaid through payroll deductions.

Payment of Benefits

Distributions from the Plan will be made in one lump-sum payment in cash equal to the value of the participant's vested interest in his or her account balance. If a participant's vested benefit in the Plan exceeds \$5,000, the participant must consent to the distribution before it may be made. If a participant's vested benefit is greater than \$1,000 but less than \$5,000, then the participant's benefit is automatically rolled to an individual retirement account for the benefit of the participant. If the participant's vested interest does not exceed \$1,000, then the participant's benefit will be distributed in a lump-sum as soon as practicable following the event that led to the participant being entitled to a distribution. With respect to mandatory distributions of \$1,000 or less, if a participant makes no election then the amount will be automatically rolled over to an individual retirement account provided the amount is greater than \$75.

Forfeited Accounts

Forfeitures are used to reduce the Plan Sponsor's matching contributions to the Plan or to pay Plan expenses. During the period from January 1, 2023 through November 2, 2023, there were approximately \$19,239 in the forfeiture account that were used to pay the Plan Sponsor's administrative expenses. At November 2, 2023, there was \$0 remaining in this account.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

As a result of the decision to terminate the Plan effective June 30, 2023, and in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), the Plan's

financial statements as of and for the period from January 1, 2023 through November 2, 2023 are presented using the liquidation basis of accounting. For periods before the decision to terminate the Plan was made, the financial statements were prepared using the ongoing basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustee and Plan Administrator determine the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis with dividends being recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on the Plan's investments bought and sold during the year as well as those held at the end of the year.

Notes Receivable from Participants

Notes receivable from participants (see Note 1) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are earned. No allowance for credit losses has been recorded as of November 2, 2023. Delinquent notes receivable from participants are reclassified as distributions in accordance with the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from the accompanying financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

During the period from January 1, 2023 through November 2, 2023, the Plan Sponsor paid approximately \$37,000 for Plan administrative fees.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Continued**

Recent Accounting Pronouncements

During the period from January 1, 2023 through November 02, 2023 and through October 14, 2024, there were several new accounting pronouncements issued by the Financial Accounting Standards Board (“FASB”). Each of these pronouncements, as applicable, has been or will be adopted by the Plan. Management does not believe the adoption of any of these accounting pronouncements has had or will have a material impact on the Plan’s financial statements.

Subsequent Events

In preparing the accompanying financial statements, the Plan’s management has reviewed, as determined necessary by the Plan’s management, events and transactions that have occurred after November 2, 2023, up until the issuance of the financial statements, which occurred on October 14, 2024, for items which should be accounted for or disclosed noting no such events or transactions other than the termination of the Plan as disclosed in Note 1 and Note 5.

**3. FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 2, 2023 and December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price.

**4. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Empower Trust Company (“Empower”) was the Plan’s custodian, Empower Retirement (“Empower”) was the Plan’s recordkeeper and The Finway Group was the Plan’s third-party administrator as of November 2, 2023 and therefore any transactions with the Plan qualify as party-in-interest transactions. Empower provides certain administrative services to the Plan pursuant to a contract between the Plan Sponsor and Empower. Empower receives revenue from mutual fund service providers for services they provide to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan.

**5. PLAN TERMINATION**

As disclosed in Note 1 and Note 2, the Plan Sponsor terminated its business and terminated the Plan effective June 30, 2023, in accordance with the plan provisions. The final distribution date of Plan net assets was October 25, 2023. Effective June 30, 2023, all participants became 100% vested in their full account balances.

**6. TAX STATUS**

The Plan is a Nova Volume Submitter Profit Sharing Plan with Cash or Deferred Arrangement (“CODA”). The IRS has determined and informed the third-party administrator by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and ERISA and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

It is not possible at this time to reasonably estimate the possible loss or range of loss, if any. We further caution that it is not possible to list all such factors, and you should not consider the identified factors as a complete list of all risks and uncertainties.
