### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the W. A. Kendall and Company, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 29, 2023 and December 31, 2022 and the related statement of changes in net assets available for benefits for the period ended December 29, 2023, and the related notes to the financial statements.

### Note 1 - Description of the Plan:

The following description of the W. A. Kendall and Company, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan Sponsor is W. A. Kendall and Company, LLC (the Company, Plan Sponsor, Plan Administrator). The Plan covers all employees of the Company who have completed two months of eligible service as defined in the Plan document and are age 18 or older. Upon attaining the eligibility requirements of the Plan, participants are allowed to enter the Plan on the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The investment committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. Effective February 2, 2023, the Plan was amended to allow Right of Way employees to participate in the Plan. Effective August 18, 2023, the Plan Sponsor acquired Tom's Tree Service and all employees were immediately eligible to participate in the Plan.

Effective December 29, 2023, the W.A. Kendall and Company, LLC 401(k) Plan was merged out of existence into the SIP 401(k) Plan (SIP Plan), a qualified plan. The Company's employees began participating in the SIP Plan as of January 2, 2024. Assets totaling \$5,933,962 were transferred out of the Plan on December 29, 2023 and deposited into the SIP Plan on January 2, 2024, which was the next business day.

#### Contributions

Each year, participants may contribute up to 100% of the participant's pre-tax annual compensation subject to the annual limits set under the Internal Revenue Code (IRC). The following are excluded from the compensation base: reimbursement or other expense allowances, fringe benefits, moving expenses, all deferred compensation, welfare benefits, unused leave, and the value of restricted stock or of a qualified or a non-qualified stock option granted to an employee by the employer. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may make discretionary non-elective contributions and discretionary matching contributions. For the period ended December 29, 2023, the Company made discretionary matching contributions of 3% of eligible compensation deferred by participants, totaling \$763,456. Effective April 1, 2021, newly hired and rehired employees are automatically enrolled at a 1% deferral rate.

#### Contributions - continued

There was no discretionary non-elective contribution made during the period ended December 29, 2023. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### Participant accounts

Each participant's account is credited with the participant's contributions, an allocation of the Company's contributions, and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

#### Vesting

All participant's contributions and earnings thereon are fully vested. Vesting in the Company's discretionary matching and other discretionary contributions and earnings thereon is based on years of service. Participants are 20% vested upon the completion of one year of service and vest 20% per year thereafter. Participants are fully vested in the Plan after five years. Participants are also immediately vested upon reaching normal retirement age or upon death or disability while still employed by the Company.

#### Forfeitures

Forfeitures of terminated participants' non-vested accounts are used to pay administrative expenses or reduce Company contributions. At December 29, 2023 and December 31, 2022, forfeited non-vested accounts in the Plan totaled \$0 and \$77,400, respectively. During the period ended December 29, 2023, \$317 of forfeitures were used to reduce Company matching contributions. The remaining forfeiture balance was transferred to the SIP 401(k) Plan.

#### Notes receivable from participants

Participants may borrow from the Plan in any amount greater than \$1,000 up to 50% of the participant's vested account balance, not to exceed \$50,000. Note terms are for a period not exceeding five years unless for the purchase of a principal residence, in which case the note repayment period may not extend beyond 15 years. Notes are secured by the balance in the participant's account and bear interest at an agreed-upon percentage based on prevailing market rates. Principal and interest is paid ratably through payroll deductions. Participants are allowed one outstanding note receivable.

### Note 1 - Description of the Plan - continued:

#### Payment of benefits

Upon termination of service, death, disability or attainment of retirement age of 65, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account or a certain minimum distribution required by the Plan. In-service distributions for participants age 59½ or older and hardship withdrawals may be made from the Plan in accordance with provisions specified in the Plan document.

#### Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Company reserves the right to elect to pay, or have the Plan pay, administrative costs in the future. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Note 2 - Summary of significant accounting policies:

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The preparation of financial statements in conformity with U.S. GAAP requires management to make certain estimates and assumptions. These estimates and assumptions affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 29, 2023 or December 31, 2022. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

#### Payment of benefits

Benefits are recorded when paid.

#### Corrective distributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding entry for corrective distributions. The Plan distributed the excess contributions for the period ended December 29, 2023 and the year ended December 31, 2022 to the applicable participants prior to March 15, 2024 and 2023, respectively.

#### Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

### Note 2 - Summary of significant accounting policies - continued:

#### Recent legislative developments

In December 2019 and December 2022, Congress passed the SECURE Act and SECURE 2.0 Act, respectively, which included numerous reforms to existing retirement law and allows plan sponsors to make certain immediate plan operational changes without formal amendment of the plan document. If adopted, plan documents are required to be formally amended in accordance with IRS guidelines.

The Plan Sponsor operationally adopted these changes and will timely amend the Plan in accordance with IRS guidelines.

#### Subsequent events

The Plan has evaluated subsequent events through October 15, 2024, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 29, 2023, have been incorporated into these financial statements.

### Note 3 - Investments and information certified by the trustee:

Fidelity Management Trust Company (Fidelity) is the trustee for the Plan. Fidelity holds the Plan's investment assets and executes investment transactions. Management has determined that Fidelity is a qualified institution and the information prepared and certified by Fidelity meets the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants as of December 29, 2023 and December 31, 2022, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the period ended December 29, 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity.

### Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification No. 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the methodologies used as of December 29, 2023 and December 31, 2022.

- Money market funds are stated at cost, which approximates fair value due to the short-term nature of the investment.
- Mutual funds (or shares of registered investment companies) are valued by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- Units of participation of the stable value fund are valued at the net asset value (NAV) provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value fund, the

investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 - Related-party transactions:

Fidelity performs services for the Plan, sells products to the Plan, and manages and maintains investments of the Plan for which fees are charged to the Plan. These types of transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments.

### Note 6 - Plan termination:

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Plan was merged out of existence during the period ended December 29, 2023.

### Note 7 - Tax status:

The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and; therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator is taking steps to bring the Plan in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 8 - Delinquent contributions:

For various paydates during 2023, the Plan Sponsor did not timely remit participant contributions. The missed earnings for 2023 were calculated and deposited into the trust in 2024.
