To Whom it May Concern,

I am writing on behalf of Bridge Boston Charter School, a small Commonwealth charter school located in Roxbury, Massachusetts. I am writing to explain the circumstances surrounding the late filing of our ERISA Form 5500 for the plan year 2022, the first year such filing was required for our plan. We recognize the importance of timely compliance with ERISA requirements and sincerely apologize for this oversight.

We are requesting that the penalties for this late filing be waived based on the following reasonable cause: change in staffing. Specifically, we had a staff transition in our Human Resources Department in 2022 and our new HR staff member was not informed of the need to file the ERISA Form 5500 for 2022 since it was a new requirement for us. As a result, we did not realize we needed to complete this filing until recently.

We have taken the following steps to ensure future compliance: we have incorporated the filing requirements for the ERISA Form 5500 into our annual checklists for compliance reporting for our Finance Department.

We appreciate your understanding and consideration of our request for a waiver of any penalties associated with this late filing. We are committed to maintaining compliance moving forward and ensuring that our filings are submitted on time.
