## Notes to Financial Statements

August 27, 2024

### **1. Description of Plan**

The following description of the Minol USA 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***Plan Termination***

Minol USA (the Company) reserved the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon Plan termination, participants became 100 percent vested in their employer contributions. On November 20, 2023, Minol USA, Inc. adopted a resolution to terminate the Minol USA 401(k) Retirement Plan. Substantially all assets of the Plan were transferred subsequent to the date of the resolution of the Plan termination on March 13, 2024.

#### ***Liquidation***

Upon resolution of the Plan termination on November 20, 2023, the Plan changed its basis of accounting to liquidation basis. On the termination date, March 13, 2024 the Plan transferred substantially all remaining assets to another qualified Plan, Voyager PEP - Minol USA. The Plan liquidated on August 27, 2024, due to a remaining receivable outstanding as of termination that was submitted after the termination date. Additional expenses incurred as a result of this termination was paid for by the Plan Sponsor, the Company, and is therefore not accrued.

#### ***General***

The Plan was a defined contribution plan established effective January 1, 2004, as restated February 18, 2022. The Plan covered all employees of Minol USA (the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator, the Company, was responsible for oversight of the Plan. The Plan's investment committee determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the Plan's Administrator.

## Notes to Financial Statements

August 27, 2024

### **1. Description of Plan (continued)**

#### **Contributions**

Each year, participants were allowed to contribute up to 100% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants could also designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Company, at its discretion, could elect to match participant contributions. For the period ended August 27, 2024 (beginning January 1, 2024) and year ended December 31, 2023, no such contributions were made. Contributions are subject to certain Internal Revenue Service (IRS) limitations

#### **Participant accounts**

Each participant's account was credited with the participant's contributions, Company matching contributions and an allocation of the Plan's earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

#### **Vesting**

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 20 percent vested after two years of credited service and continued to vest in increments of 20 percent until 100 percent vested after six years of credited service.

### 1. Description of Plan (continued)

#### **Notes receivable from participants**

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, reduced by the highest outstanding loan balance in their account during the immediate preceding 12 month period. The loans were secured by the balance in the participant's account. The loan interest rate, determined by the Loan Administrator, was set at the prevailing rate on the date of funding, based on rates available for similar loans from commercial lending institutions, as defined. Principal and interest were paid ratably through payroll deductions. Terms ranged up to 5 years or greater for the purchase of a primary residence.

#### **Payment of benefits**

On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump sum distribution.

If a terminated participant's vested balance was less than or equal to \$5,000, the amount may have been automatically distributed in the form of a direct rollover to an IRA of the plan administrator's choosing. If a terminated participant's vested balance was less than or equal to \$1,000, the amount was automatically paid to the participant in the form of a lump sum cash payment. In addition, the Plan allows for hardship distributions if certain criteria were met.

#### **Forfeited accounts**

At August 27, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0. These accounts could be used to reduce future employer contributions or to pay plan administrative expenses. During the period ended August 27, 2024 (beginning January 1, 2024) and year ended December 31, 2023, no amounts were applied to plan activities from forfeited nonvested accounts.

### **2. Summary of Accounting Policies**

#### **Basis of Accounting**

For the 2023 plan year, the Plan adopted the liquidation basis of accounting, as such the financial statements of the Plan were prepared on the liquidation basis of accounting in 2023 and 2024. Liquidation basis of accounting presents assets and liabilities at the estimated amount of cash the Plan expects to collect or pay to settle its obligations during the course of liquidation.

#### ***Use of Estimates***

The preparation of financial statements in accordance with the liquidation basis of accounting required management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments were reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

The Plan's investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and are expensed as incurred.

#### Payment of Benefits

Benefits were recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### Subsequent Events

Subsequent events were evaluated through September 18, 2024, the date the financial statements were available to be issued.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at August 27, 2024 and December 31, 2023:

*Pooled separate accounts:* Valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions. Pooled separate accounts are valued using their readily determinable fair value ("RDFV") as the fair value of the underlying assets are determined, published, and is the basis for current transactions.

*Investments measured at net asset value:* Consisting of common-collective trusts, valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. To seek total return consisting of long-term growth of capital and income consistent with the investment strategy of investors coinciding with their target retirement date

#### 4. Fully Benefit-Responsive Investment Contracts

The Plan held a traditional fully benefit-responsive guaranteed investment contract, for which contributions were maintained in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Contract value, as reported to the Plan by the sponsoring trustee, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer was contractually obligated to repay the principal and interest at the specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but could not be less than 1 percent. The crediting rate was reviewed on an annual basis for resetting. The contract could be terminated before the scheduled maturity date with a 90-day notice and subject to a surrender charge deducted from the payout.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events could limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include:

1. amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
2. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or,
5. premature termination of the contract.

No events were probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

1. an uncured violation of the Plan's investment guidelines;
2. a breach of material obligation under the contract;
3. a material misrepresentation; or,
4. a material amendment to the agreement without the consent of the issuer.

On November 20, 2023, the Plan Sponsor adopted a resolution to terminate the Minol USA 401(k) Retirement Plan including premature termination of the contract which did not have a material impact on the financial statements. The contract ended upon termination on March 13, 2024.

#### **5. Transfers Into or Out of the Plan**

On November 20, 2023, the Company adopted a resolution to terminate the Minol USA 401(k). On March 4, 2024, employees were no longer eligible to participate in the Plan and became eligible to participate in another qualified plan sponsored by the Company. These employees had their account balances transferred between the Plan and Voyager PEP - Minol USA, another qualified plan sponsored by the Company.

#### **6. Information Certified by Custodian**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Principal Life Insurance Company and Principal Trust Company, the Custodians of the Plan, have certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of March 13, 2024, and December 31, 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of August 27, 2024, and the related investment activity, net appreciation in fair value of investments, reported in the Statement of Changes in Net Assets Available for Benefits for the period ended August 27, 2024. The certification covered the period through March 13, 2023, which is the period when all investment activity occurred and then transferred to the new Plan. Activity from March 13, 2024 and Plan year end, August 27, 2024 included a contribution of missed deferrals (Note 10) and missed earnings, these were transmitted directly to the new Plan, Voyager PEP - Minol USA.

#### **7. Related-Party and Party In Interest Transactions**

Certain Plan investments were managed by the Custodians, and therefore, these transactions qualified as party in interest transactions.

Additionally, the Plan issued loans to participants, which were secured by the participant's account balances. These transactions qualified as party in interest transactions.

Certain administrative functions of the Plan were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

### **8. Tax Status**

The Plan adopted a pre-approved plan offered by Principal Trust company. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust were designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan had been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC, and, therefore believed that the Plan was qualified, and the related trust was tax exempt through the date of termination on March 13, 2024.

Plan management was required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks.

### **10. Delinquent Participant Contributions**

For the year ended December 31, 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. These amounts, which totaled \$11,191, were corrected outside of the Department of Labor Voluntary Fiduciary Correction Program.

The calculation for lost earnings on late remittances corrected after plan termination on March 13, 2024, were \$988. The Company compensated participant's for lost earnings and delinquent participant contributions, which totaled \$12,179, in August 2024 by remitting a corrective contribution to participant accounts in the new Plan, Voyager PEP - Minol USA.
