INDEPENDENT AUDITOR'S REPORT

To the Plan Trustees of
CWU, Inc. Plan - 002

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of CWU, Inc. Plan – 002 (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of July 25, 2024 (in liquidation) and 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024 through July 25, 2024 (in liquidation) and the statement of net assets available for benefits as December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period January 1, 2024 to July 25, 2024 and as of December 31, 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination

As discussed in Note A1 and A8 to the financial statements, the trustees of the Plan elected to terminate the CWU, Inc. 401(k) Plan and approved a plan of liquidation on April 15, 2024 and the plan was liquidated on July 25, 2024. Consequently, Plan management determined liquidation was imminent and the Plan changed its basis of accounting from the going concern basis to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit

conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



NOTES TO FINANCIAL STATEMENTS

July 25, 2024

NOTE A - DESCRIPTION OF PLAN

The following description of CWU, Inc. Plan - 002 (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General and Plan Termination

The Plan is a defined contribution plan covering substantially all the U.S. in-country based employees of CWU, Inc. (the "Company") who have attained the age of 21. The Plan record keeper is My Benefits, LLC and the Plan trustee is John Hancock Life Insurance Company ("JHLIC"). Officers and employees of the Company perform certain administrative functions. No such officer or employee receives compensation from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan was created January 1, 2013 and last amended January 1, 2019.

On April 15, 2024, the Sponsor of the Plan approved the termination of the Plan, effective April 15, 2024, whereby all net assets available for benefits were to be distributed from the Plan in accordance with the terms of the termination and Plan agreements. As a result of the Plan termination, Plan management determined that a liquidation was imminent and prepared the 2024 financial statements on the liquidation basis of accounting. The liquidation basis of accounting did not materially affect the presentation of these financial statements. The plan was liquidated and fully terminated on July 25, 2024.

The financial statements of the Plan are the representation of Plan management and include estimates of amounts and judgements it believes are reasonable under the circumstances.

2. Contributions

A participant may elect to make pre-tax and after-tax (Roth deferral) contributions, subject to limits set by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified plans. Participants who are at least age 50 may make an additional pretax "catch-up" contribution subject to IRC limitations.

Participants may elect to contribute to the Plan for any plan year during which they are participants, such amounts expressed in whole percentages of their compensation, that would otherwise be payable by the Company as compensation, subject to certain Internal Revenue Code limits.

Employer matching and profit-sharing contributions are discretionary. Participants who have attained the age of 21 are eligible for employer matching contributions. Participants who have attained the age of 21 and have one year of service, as defined by the Plan, are eligible for profit sharing contributions. Profit sharing contributions shall be allocated to each employee in proportion to their compensation as a percentage of the compensation of all eligible employees within their allocation group, as defined by the Plan. The Company made discretionary matching contributions of \$93,730 for the period ended July 25, 2024. No profit-sharing contributions were made to the Plan for the year ended July 25, 2024.

3. Participant Accounts

The participant accounts are participant directed investment options. The participants are allowed to change the percentage contributed to the Plan through payroll deductions at any time. Participants can also move individual accounts from one investment option to another or change how the funds are allocated among investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Each participant in the Plan has a separate account that is credited with the participant's contribution, the Company's matching and profit-sharing contributions and an allocation of Plan earnings or losses and charged with an allocation of administrative expenses and any distributions taken. Allocations are based on participant account balances, as defined.

4. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in their Company matching and profit-sharing contributions on a sliding scale based on their number of years of service. A participant is vested in employer matching contributions and profit-sharing contributions as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than one year	0%
One year but less than two years	20%
Two years but less than three years	40%
Three years but less than four years	60%
Four years but less than five years	80%
Five or more years	100%

One hundred percent vesting occurs, regardless of the number of years of service, when a participant reaches normal retirement age (65), meets the requirements for early retirement, dies, or becomes totally and permanently disabled. The Plan was effectively terminated on April 15, 2024 at which time all participants became one hundred percent vested in their accounts.

NOTE A - DESCRIPTION OF PLAN - Continued

5. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance (not including Roth deferral accounts). Loan transactions are treated as a transfer from the investment fund to the participant loan account. Loan terms may range from one to five years. The loans are collateralized by the balance in the participants' accounts and currently bear interest at the prime rate (8.50% as of July 25, 2024) plus 1%, as defined by the Plan. Principal and interest are paid ratably through payroll deductions. Upon separation of service, the vested account payable to an individual who has an outstanding participant loan will be determined by reducing the vested account balance by the amount of the loan.

6. Payment of Benefits

Benefit payments are made in the form of a single sum, annuity, or deferred status distribution upon normal retirement, death, or becoming permanently disabled. The participants will only be entitled to the vested portion of the employer contributions if employment is terminated for any reason other than those previously mentioned.

Participants are entitled to 100% of the account balance of any salary reduction or voluntary contributions made on their own behalf.

7. Forfeitures

Forfeitures consist of Company matching or profit-sharing contributions and may be used to reduce plan expenses, applied to reduce the Company's future matching contributions, or may be allocated to participants. Forfeited non-vested accounts totaled \$-0- at July 25, 2024 and December 31, 2023, respectively. In 2024 employer matching contributions were reduced by approximately \$14,000 from forfeited accounts.

8. Plan Termination

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination participants would become 100% vested in their accounts. On April 15, 2024, the Company approved the termination of the Plan and the Plan was terminated on July 25, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows:

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

2. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein as well as the related disclosures. Actual results could differ from those estimates.

3. Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value except for the fully-benefit responsive contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of July 25, 2024 and December 31, 2023.

NOTES TO FINANCIAL STATEMENTS - CONTINUED

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Deemed distributions of notes receivable from participants totaled \$148,584 for the period ended July 25, 2024.

5. Payment of Benefits

Benefits are recorded when processed and paid by the Plan.

6. Expenses

Certain administrative expenses of the Plan are paid by the Plan and are reflected in the Plan's financial statements. However, certain legal and other operating expenses of the Plan are paid by the Company and, therefore, are not included in the accompanying financial statements.

7. Excess Contributions Payable

Excess contributions payable represents unallowable amounts contributed to the Plan by participants and the related employer match amounts, plus any investment earnings or losses that will be refunded to the participant. There were no excess contributions for the 2024 Plan year.

NOTE C - FINANCIAL DATA CERTIFIED BY THE TRUSTEE (UNAUDITED)

The investments of the Plan were held and administered by John Hancock Life Insurance Company ("JHLIC" or the "Trustee"), as of July 25, 2024 and December 31, 2023 and for the period January 1, 2024 through July 25, 2024. JHLIC has certified the Plan investments and the related investment income as being complete and accurate as of July 25, 2024 and December 31, 2023 and for the period January 1, 2024 through July 25, 2024. In accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator has elected not to have this information audited by the Plan's independent certified public accountants.

NOTE D - INVESTMENT CONTRACTS WITH INSURANCE COMPANY

The Plan maintains a fully benefit-responsive guaranteed investment contracts with the Trustee. The Trustee maintained the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract values are the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. The guaranteed investment contracts are presented on the statement of net assets available for benefits at contract value.

Contract value, as reported to the Plan by JHLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Interest rates are reviewed on a quarterly basis for resetting. The contract value of the investment contract was \$-0- and \$196,699 as of July 25, 2024 and December 31, 2023, respectively.

NOTE D - INVESTMENT CONTRACTS WITH INSURANCE COMPANY - Continued

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for examples, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation.

The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring. The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE E - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTES TO FINANCIAL STATEMENTS - CONTINUED

NOTE E - FAIR VALUE MEASUREMENTS - Continued

Following is a description of the valuation methodologies used for assets measured at fair value at July 25, 2024 and 2023:

Noninterest bearing cash: Valued at amortized cost which approximates fair value.

Pooled separate accounts: Valued at the net asset value (“NAV”) of units held by the Plan at year end. Investments in these accounts are valued at quoted market prices of the issuer.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE F - PARTICIPANT TERMINATIONS

Some Plan participants have terminated employment from the Company but have not requested their vested balances to be paid to them at the year end. These unpaid benefits totaled approximately \$-0- and \$3,200,000 as of July 25, 2024 and December 31, 2023, respectively.

NOTE G - TAX STATUS

Effective December 1, 2014, the Plan adopted the use of the Volume Submitter 401(k) Profit Sharing Plan ("VSPSP"). The IRS has determined and informed the Company by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator do not believe any uncertain tax positions have been taken with respect to the Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE H - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were \$-0- at July 25, 2024.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
