We have performed audits of the accompanying financial statements of Maplewood Beverage Packers LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements

### NOTE 1 - Description of Plan

The Maplewood Beverage Packers LLC 401(k) Plan (the "Plan") was established by Maplewood Beverage Packers, LLC on July 1, 2017, as amended, dated June 8, 2022 for the purpose of providing eligible employees an opportunity to utilize the benefits of a tax-deferred savings plan. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The record keeper of the Plan is *ADP's Retirement Services (RS) 401(k) Qualified Plan and Participant Recordkeeping Operation and ADP Retirement Trust Services System* ("ADP"). The Plan's investments are certified by *Reliance Trust Company* the ("Trustee") as of December 31, 2023 and 2022 and for the year ended December 31, 2023.

#### A. Eligibility

The Plan is a defined contribution plan covering all eligible employees that have attained the age of 21 and have completed at least one month of service, and are not a member of a collective bargaining unit. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### B. Plan Administration

The Trustees of the Plan have appointed Company personal to be responsible for the operations of the plan.

The Plan is administered by the trustees and plan administrator, who represent the Plan sponsor. The Plan administrator is responsible for the day-to-day administration of the plan. The Trustees of the Plan are responsible for the safekeeping of the trust fund.

#### C. Employee Contributions

Participants may make voluntary salary pre-tax and Roth after tax contributions of up to 50% of eligible compensation, as defined by the plan, subject to certain Internal Revenue Code ("IRC") limitations. For the years ended December 31, 2023 and 2022 the limit capped by the Internal Revenue Service was \$22,500 and \$20,500, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions of \$7,500 for the year ended December 31, 2023. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans.

**D. Employer Contributions**

Employer matching contributions are equal to 50% of the participants deferral amount, inclusive of catchup contributions, up to 100% of salaries.

Employer may make a non-elective contribution and allocate it to all participants, based on compensation of the individual participant to the total compensation of all participants. No such additional non-elective contribution was made for the year ended December 31, 2023.

**E. Participant Accounts**

Individual accounts are maintained for each Plan participant with the Trustee. Each participant's account is credited or charged with the participant's contribution, the Employer's matching contribution, investment earnings (losses), and allocations of discretionary contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**F. Investments**

Participants direct the investment of their contributions and employer's contributions made on their behalf into various investment options offered by the Plan. The participants instruct the Trustee directly as to the allocation of deposits among funds and transfers among funds.

**G. Vesting**

Participants are vested immediately in their salary deferral and rollover contributions, plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on continuous service. A participant is 100% vested after six years of credited service. Vesting in the Employer's profit-sharing contribution is subject to a six-year graded vesting schedule. Vesting of Employer's matching contributions is according to the following table:

##### H. Participant Loans

Participants may borrow from their accounts a minimum of \$500 and up to a maximum of \$50,000, but no more than 50% of their vested account balance (pre-tax elective deferrals, after tax elective deferrals, roth elective deferrals and rollover accounts only). The loans are secured by the balance in the participant's account and bear interest at 1% over the prime rate of interest. Loans outstanding at December 31, 2023 and 2022 bear interest at the rate of between 4.25% - 9.50% and mature through 2029. Principal and interest are paid ratably through payroll deductions, over the term of the loan.

##### I. Payment of Benefits

Participants are entitled to receive a distribution of their vested interest upon the termination of employment, an in-service distribution for elective and matching contributions for participants who have attained the age of 59 ½, participants who have attained full retirement age of 65, and in the event of death or a disability. Participants may make a hardship distribution as permitted by the Plan. The beneficiary or beneficiaries of a participant's vested interest are entitled to receive a distribution of such interest in the Plan upon the death of the respective participant. Benefits to the participant or their respective beneficiary or beneficiaries are payable, depending upon the circumstances, in the form of a lump sum payment, or substantially equal monthly, quarterly, or annual installments. All distributions are made as administratively feasible. As of December 31, 2023, all employees who elected to withdraw from the Plan had been paid.

##### J. Forfeited Nonvested Accounts

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested shall be forfeited, the forfeited portion of a participants' account may be used to reduce future Employer's contributions or to pay Plan expenses. During the year ended December 31, 2023, and 2022 forfeitures used to reduce employer's contributions were \$24,565 and \$ 3,069, respectively. The forfeitures balance at December 31, 2023 and 2022 was \$ 11 and \$10, respectively.

##### K. Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the plan sponsor, who is a party -in-interest. Investment related expenses are included in net appreciation of fair value of investments.

Non-investment costs and administrative expenses that are paid by the plan sponsor, who is a party in interest, which are not reflected in the accompanying financial statements, constitute exempt party in interest transactions under ERISA.

#### NOTE 2 - Summary of Accounting Policies

##### A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

##### B. Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions. These estimates are subjective in nature and involve assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported amounts of investment income and deductions during the Plan year. Accordingly, actual results may differ from those estimates.

##### C. Investment Valuation and Income Recognition

The Plan's investments, excluding common collective trusts, are stated at fair value. Quoted market prices are used to value investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair market value of investments for such investments.

##### D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

##### E. Payment of Benefits

Benefit payments to participants are recorded upon distribution.

##### F. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions and earnings.

Amounts payable at December 31, 2023 and 2022 were \$13,063- and \$-0- respectively, representing excess contributions including respective income of \$522 were returned to the respective participants by March 15<sup>th</sup> of the following year.

##### G. Administrative Expenses

Professional and administrative fees and other expenses of the Plan, at the Company's election, may be paid out of the Plan.

##### H. Related Parties and Parties -in-Interest

###### Plan Expenses

Certain non-investment expenses of maintaining the Plan are paid directly by the plan sponsor, who is a party in interest, and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Certain fees may be charged to participants based upon the participant's use of a Plan feature such as receipt of a Plan distribution or loan.

Non-investment costs and administrative expenses that are paid by the plan sponsor, who is a party in interest, constitute exempt party in interest transactions under ERISA.

Administrative expenses paid by the Plan during 2023 to ADP, a party-in-interest, amounted to \$7,175

#### NOTE 3 - Fair Value Measurements

The Financial Accounting Standards Board ("FASB") established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2023. .

**Mutual funds** – The Funds are valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**Common/Collective Trust** - Valued at the net asset value ("NAV") based on the fair value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that this fund meets those requirements since the participants have the ability to redeem the accounts at NAV as of the measurement dates on a daily basis. There are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 - Plan Termination

Although it has not expressed any intention to do so, the Employers have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, the Trustee shall distribute to the participants, their beneficiaries, or estates, all assets remaining in the Plan after payment of any expenses properly chargeable to the Plan. Such distribution will be equal to the value of the accounts of the participants as of the date of the termination of the Plan, adjusted to reflect any increments or decrements occurring between such termination date and the date of distribution.

#### NOTE 6 - Federal Income Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service ("IRS") stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan is relying on IRS approval of a prototype plan dated October 6, 2020, in which the Internal Revenue Service stated that the prototype plan, *Non-standardized-Approved Profit Sharing Plan/Money Purchase/ CODA*, provided by ADP, LLC was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

#### NOTE 7- Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### NOTE 8 – Subsequent Events

On December 18, 2023, the Plan Sponsor approved a merger of the Plan into the Arizona Iced Tea 401(K) Plan, an affiliated company, effective January 1, 2024. The merger was completed on January 9, 2024, when all the funds were transferred to the new plan.

The Plan has evaluated subsequent events for recognition or disclosure through October 11, 2024 2024, which was the date these financial statements were available to be issued.

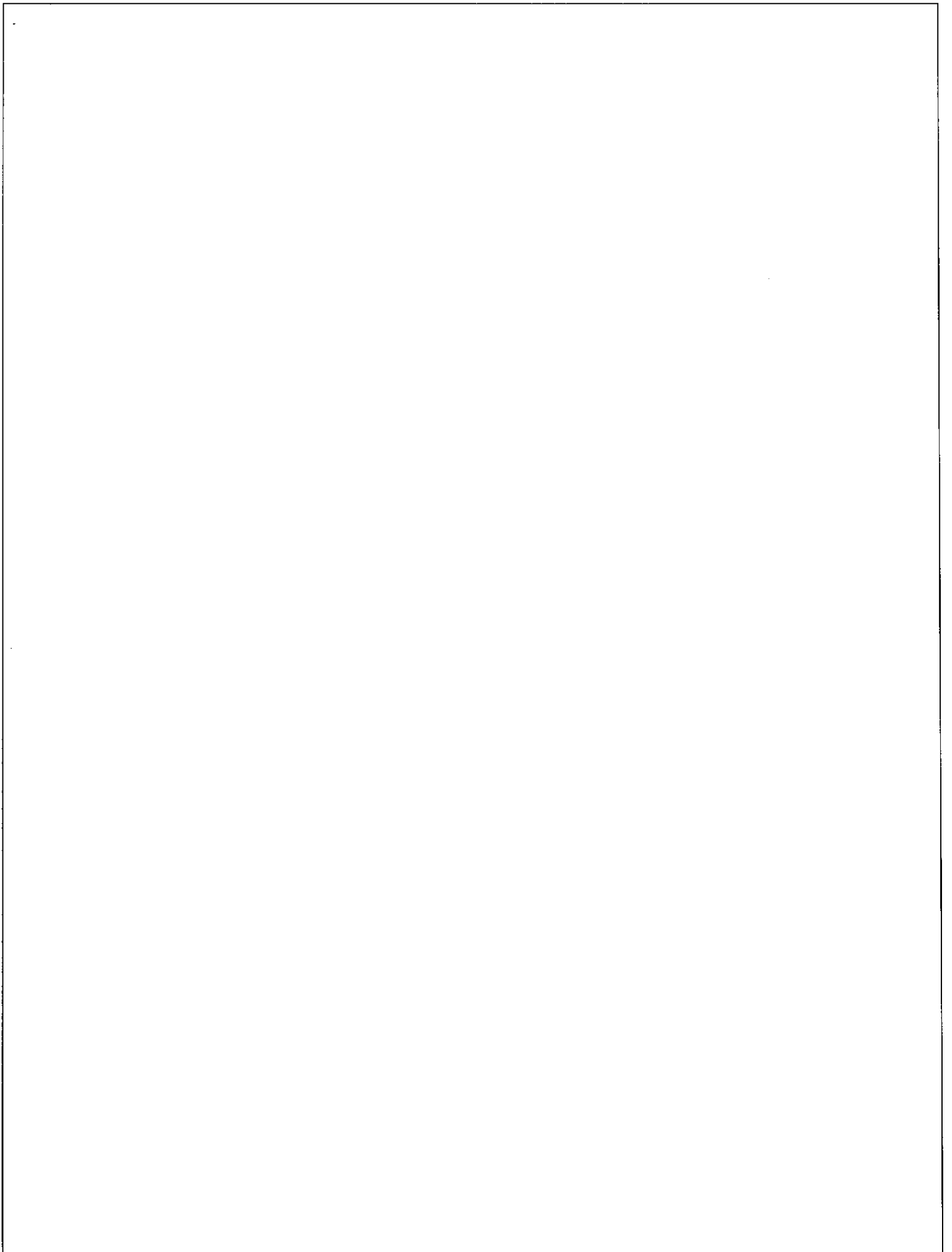
