INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

Opinion

We have audited the financial statements of American Equity Investment Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of January 16, 2024, December 31, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the sixteen days ended January 16, 2024 and the year ended December 31, 2023, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of January 16, 2024, December 31, 2023 and December 31, 2022, and the changes in net assets available for benefits for the sixteen days ended January 16, 2024 and the year ended December 31, 2023, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Substantial Doubt About the Plan's Ability to Continue as a Going Concern

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note 1 to the financial statements, on November 30, 2023, the Compensation and Talent Management Committee, a subset of the Board of Directors of American Equity Investment Life Holding Company and Subsidiaries, the Plan sponsor, voted to merge the Plan into the American Equity Investment Profit Sharing and 401(k) Plan (Profit Sharing Plan) as of January 1, 2024. The Plan transferred its net assets into the Profit Sharing Plan on January 16, 2024 and ceased operations as of that date. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Notes to Financial Statements

(1) Description of Plan

The following description of the American Equity Investment Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering all employees of American Equity Investment Life Holding Company (the Company or AEL). The Company specializes in the development and sale of fixed index and fixed rate annuity products. The Plan was effective July 1, 2007 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Going Concern & Plan Merger

In November 2023, the Compensation and Talent Management Committee adopted a resolution to merge the Plan into the American Equity Investment Profit Sharing and 401(k) Plan, effective January 1, 2024 (Plan Merger). Upon completion of the final phase of the transfer process on January 16, 2024, the Plan's operations ceased.

(c) Eligibility

Employees are eligible to participate in the Plan on the first day of the month immediately following the completion of six months of service. Employees must be 18 years of age to be eligible. The Plan excludes non-resident aliens, interns, and those subject to a collective bargaining agreement.

(d) Contributions

The Plan is funded by Company contributions on approximately June 30 and December 31. The Company's contribution is discretionary and determined by the Board of Directors. The contributions to the Plan are used to purchase shares of Company stock. However, due to the Plan Merger, the December 31, 2023 contribution was made in cash rather than shares. Employees are not eligible to make contributions to the Plan.

(e) Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant account is credited with an allocation of shares based upon the number of shares purchased with Company contributions. Allocations of shares are made in proportion to the participant's eligible compensation to total compensation of all participants, as defined in the Plan document. Dividends are credited to the participant's account based on the number of allocated shares in the participant's account. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account. At December 31, 2023 and 2022 there were 879,449 and 954,374 allocated shares, respectively. There are no allocated shares at January 16, 2024 due to the Plan Merger.

(f) Vesting

Participants become fully vested in the contributions and earnings thereon after completion of two years of service. Forfeitures are allocated to remaining participant accounts on the same basis as shares are allocated. Forfeited balances of terminated participants' nonvested accounts are allocated to active participants semi-annually based upon current six-month compensation. Forfeited shares of 3,973 were allocated for the year ended December 31, 2023. No forfeited shares were allocated during the period ended January 16, 2024.

(g) Participant Loans

The Plan does not allow loans to participants.

(h) Payment of Benefits

Benefit payments to participants are recorded upon distribution. Upon termination of service, distributions shall be payable in a lump sum distribution as soon as administratively possible. All distributions will be in cash or stock or both at the discretion of the Plan administrator.

(i) Diversification Transfer

Participants who meet the definition of a "qualified participant" are permitted to transfer up to 25% of their vested account balance attributable to Company stock to the American Equity Investment Profit Sharing and 401(k) Plan. The transfers must take place during the "qualified election period", which is the six-year period beginning with the plan year in which the participant first becomes a "qualified participant". A "qualified participant" is a participant who has completed ten (10) years of participation under the Plan and has attained age fifty-five (55). The portion of the participant's vested account balance eligible for this election increases to fifty percent (50%) during the last plan year of the qualified election period. In calculating the applicable percentage available for transfer, the number of shares previously distributed is taken into account.

(j) Voting Rights

Each participant has the right to direct the Trustee as to the manner in which shares of the Company's common stock that have been allocated to their participant account should be voted. The Trustee, at the direction of the Plan administrator, will vote all Plan shares to the extent participating voting directions are not provided.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

(b) Use of Estimates in the Preparation of Financial Statements

The preparation of the Plan's financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

(c) Risks and Uncertainties

The Plan provides for investments in the Company's common stock. Investment securities are exposed to various risks including, but not limited to, market and credit risks. Due to the concentration of Plan assets in common stock of the Company, the value of these assets may be impacted by the ongoing performance of the Company. Due to the level of risk associated with common stock, it is at least reasonably possible that changes in the value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(d) Investment Valuation and Income Recognition

The Plan's investment in the Company's common stock is reported at fair value as determined by quoted prices available in active markets. Cost of the investment in the Company's common stock is reported on an average cost basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
- c. Inputs other than quoted prices that are observable for the asset or liability;
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

e. Administrative and Operating Expenses

The Company pays administrative and operating expenses of the Plan.

(3) Related-Party and Exempt Party-in-Interest Transactions

At December 31, 2023 and 2022, the Plan held 879,449 and 954,374 shares of common stock of the Company, with a cost basis of \$22,438,221 and \$22,760,278, respectively.

(4) Federal Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated November 12, 2015 stating that the Plan is qualified, under the Internal Revenue Code (IRC) and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust are tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 16, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

(5) Subsequent Events

The Company has reviewed and considered the events subsequent to the date of the financial statements through October 11, 2024, which is the date the financial statements were available to be issued.
