PLAN YEAR 2020

It is our sincere belief that this program terminated in 2019. Explanation follows:

A decision was made in 2019 to discontinue the 401K PLAN. There had not been any contributions made in the plan since 2016 by the participants or the company.

In 2020, when the 2019 tax plan was due to be filed, COVID and regulations in the STATE OF TEXAS mandated all operations cease during the summer months. Our business was seasonal and not being allowed to operate required that all employees be furloughed. There was no one in the office at the time of filing requirement. In the fall of 2020, we were forced to begin liquidating the company. The mandate to cease operations was the main contributing factor that the business operations were sold in January 2021. We were under the impression that the 401K PLAN had terminated, and that VOYA maintained the assets in a secure fashion for the employees. There has not been transfer of assets from the plan since the COVID shutdown and the employees have access to their funds through the administration of VOYA.
