Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or are derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule,

NOTES TO FINANCIAL STATEMENTS
FOR THE PERIOD FROM JANUARY 1, 2023 THROUGH JANUARY 10, 2023
AND THE YEAR ENDED DECEMBER 31, 2022

1. Description of Plan

The following description of the Lamb-Weston/RDO Frozen Union 401(k) Plan (the “Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a 401(k) plan established June 1, 2017 by Lamb-Weston/RDO Frozen (the “Company”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is administered by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Nationwide Trust Company, FSB (“Nationwide”) serves as the trustee of the Plan.

Effective January 10, 2023, the Plan has merged with Lamb Weston/RDO Frozen 401(k) Plan. The Plan assets were transferred on April 24, 2023 and the Plan was terminated.

b. Eligibility

Union employees of the Company who are 18 years of age are eligible to participate in the Plan upon employment. Effective January 7, 2020, the Plan adopted an auto-enrollment feature whereby new employees are automatically enrolled after 30 days of employment with a 3% deferral rate unless they elect another deferral percentage or choose not to participate in the Plan. The automatic deferral provision did not apply to existing participants as of the effective date.

c. Participant Contributions

Participants may defer up to 100% of their eligible compensation on a pre-tax or Roth basis, limited by requirements of the IRC. Upon reaching the age of 50, eligible employees may make additional catch-up contributions as allowed by the IRC. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans into the Plan.

d. Employer Contributions

The Company, at its discretion, may make employer matching and profit sharing contributions to the Plan for employees who are employed on the last day of the Plan year and who had attained at least 1,000 hours of service during the year. During 2022, the employer matching contribution was 50% of eligible contributions, not exceeding 3% of the Plan compensation. During 2022, the Company also made a separate discretionary profit sharing contribution to employees over 50 years of age equal to 1% of eligible compensation.

e. Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses. Participants can direct their account into a variety of investments offered by Nationwide. The benefit to which a participant is currently entitled is the benefit that can be provided from the participant's vested account.

f. Vesting

Participants shall always be 100% vested in their elective deferrals and rollover contributions. Participants vest in their employer matching and discretionary contributions at a rate of 20% per year until they have completed 5 years of vesting at which time they become 100% vested.

g. Payment of Benefits

Upon reaching retirement age, termination of service, disability or death, a participant or beneficiary may be paid a lump-sum amount equal to the participant's vested account balance. Terminated participants with an account balance of less than \$5,000 but greater than \$1,000 are distributed in the form of a direct rollover to an individual retirement account designated by the Plan Administrator. Account balances less than \$1,000 may be distributed in a single lump-sum cash payment to the participant or beneficiary.

h. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, a portion of their elective deferrals and employer contributions as a result of an immediate and heavy financial need. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

b. Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net appreciation (depreciation) in fair value of investments consists of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis.

d. Payment of Benefits

Benefits are recorded when paid.

e. Expenses

Administrative costs, including trustee, recordkeeping, legal and accounting fees, are paid by the Company. For the period from January 1, 2023 through January 10, 2023 and for the year ended December 31, 2022, direct expenses paid by the Plan were approximately \$0 and \$10,000, respectively. Certain expenses are included in the transaction prices of investments bought and sold and cannot be separately quantified.

f. Forfeitures

Forfeitures may be used to reduce future Company contributions or to pay administrative expenses of the Plan. During 2023 and 2022, no forfeitures were utilized. As of January 10, 2023 and December 31, 2022, forfeitures totaling approximately \$0 and \$8,000 were available to reduce future employer contributions or pay Plan expenses.

3. Investments

Plan investment assets are held by Nationwide. Participants can direct their accounts among various mutual funds, a money market fund and an investment contract which is a group annuity contract.

The Plan's investment options include the Nationwide Fixed Select Contract ("FSC"). The FSC is a group annuity contract and is an obligation of Nationwide Life Insurance Company's general account and is subject to Nationwide Life Insurance Company's claims-paying ability. The FSC is fully benefit-responsive and, accordingly, is carried at contract value.

The interest rate for new contributions is declared prior to the beginning of each quarter and is applicable to all contributions received in that quarter and is guaranteed at a rate of no less than 0.5%. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt, premature termination of the contract, Plan termination or merger, or liquidation of the Company could result in the investment not transacting at contract value.

4. Fair Value Measurements

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, establishes a framework for fair value measurement, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at January 10, 2023 and December 31, 2022.

Money market fund and mutual funds: Valued at fair value based on quoted market prices at year end.

5. Risks and Uncertainties

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participant account balances.

6. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedule was provided and certified by the trustee, Nationwide Trust Company,

FSB as of January 10, 2023 and December 31, 2022 and for the period from January 1, 2023 through January 10 2023 and the year ended December 31, 2022 as complete and accurate.

- Investments, at fair value
- Investment, at contract value
- Investment income (loss)

7. Party-in-interest Transactions

Certain Plan investment funds are managed by Nationwide Investments, an affiliate of Nationwide. Nationwide is the trustee as defined by the Plan. Certain investment fees are paid by the trustee and are reflected in the investment income or loss for the year. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

Additionally, the Plan sponsor, Lamb-Weston/RDO Frozen, is a party-in-interest to the Plan. The transactions between the Plan and the Plan sponsor included funding of contributions to the Plan and payment of certain administrative expenses of the Plan, which are exempt transactions.

8. Tax Status

Effective January 1, 2021, the Plan was adopted utilizing Northwest Retirement Plan Consultants LLC Non-Standardized Pre-Approved Plan Document which received an opinion letter dated June 30, 2020 in which the Internal Revenue Service ("IRS") stated that as of that date the plan document was designed in compliance with the applicable IRC requirements. The Plan has been amended since receiving the opinion letter, however management of the Plan believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax exempt as of January 10, 2023 and December 31, 2022 and for the period from January 1, 2023 through January 10, 2023 and the year ended December 31, 2022.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 10, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Plan Termination

Although it has not expressed any intention to do so, the Company may terminate the Plan at any time subject to the provisions of ERISA.

10. Non-exempt Transactions

Certain participant contributions during 2022 were not remitted to the Plan by the Company within the time period required by the Department of Labor. These late remittances constitute prohibited transactions as defined by ERISA. Management has remitted the lost earnings to the Plan related to the 2022 late contributions in 2023.

11. Subsequent Events

The Plan has evaluated subsequent events with respect to the Plan through October 17, 2024, the date the financial statements were available for issuance.
