### NOTE 1 – Description of the Plan

The US Beverage Packers LLC 401(k) Plan (the “Plan”) was established by US Beverage Packers, LLC on April 1, 2019, and subsequently amended on April 6, 2022 for the purpose of providing eligible employees an opportunity to utilize the benefits of a tax-deferred savings plan. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### A. Eligibility

The Plan is a defined contribution plan that covers all eligible employees that have attained the age of 21 on the next plan entry date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### B. Plan Administration

The record keeper of the Plan is *ADP’s Retirement Services (RS) 401(k) Qualified Plan and Participant Recordkeeping Operation and ADP Retirement Trust Services System* (“ADP”). The Plan’s investments are certified by *Reliance Trust Company* the (“Trustee”) as of December 31, 2023, and 2022 and for the year ended December 31, 2023.

The Trustees of the Plan have appointed Company personnel to be responsible for the operations of the plan.

#### C. Employee Contributions

Participants may make voluntary salary pre-tax and Roth after tax contributions up to 90% of eligible compensation, as defined by the plan, subject to certain Internal Revenue Code (“IRC”) limitations. For the year ended December 31, 2023, and 2022 the limit capped by the Internal Revenue Service was \$22,500 and \$20,500, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans.

#### D. Employer Contributions

The Employer will match 50% of the contribution up to the first 100% of an employee's eligible salary. The Employer may make a non-elective contribution allocated to all participants, based on compensation of the individual participant to the total compensation of all participants.

#### E. Participant Accounts

Individual accounts are maintained for each Plan participant with the Trustee. Each participant’s account is credited or charged with the participant’s contribution, the Employer’s matching contribution, investment earnings (losses), and allocations of discretionary contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### NOTE 1 – Description of the Plan (Continued)

#### F. Investments

Participants direct the investment of their contributions and Employer's contributions made on their behalf into various investment options offered by the Plan. The participants instruct the Trustee directly as to the allocation of deposits among funds and transfers among funds.

#### G. Vesting

Participants are vested immediately in their salary deferral and rollover contributions, plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on continuous service. A participant is 100% vested after six years of credited service. Vesting in the Employer's profit-sharing contribution is subject to a six-year graded vesting schedule. Vesting of Employers' matching contributions is according to the following table:

<u>Participant's Years of Service</u>	<u>Vesting Percentage</u>
Less than 2 years	0%
2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%
5 years but less than 6	80%
6 years or more	100%

#### H. Participant Loans

Participants may borrow from their fund accounts a minimum of \$500 and up to a maximum of \$50,000, but no more than 50% of their vested account balance (pre-tax and rollover accounts only). The loans are secured by the balance in the participant's account and bear interest at the prime rate on the 14<sup>th</sup> day of each month plus two percent. The loans bear interest at rates ranging from 5.25% - 10.5%, and maturing through 2027. Principal and interest are paid ratably through payroll deductions.

#### I. Payment of Benefits

Participants are entitled to receive a distribution of their vested interest upon the termination of employment, an in-service distribution for elective and matching contributions for participants who have attainment the age of 59 ½, participants who have attained full retirement age of 65, and in the event of death or a disability. Participants may make a hardship distribution as permitted by the Plan. The beneficiary or beneficiaries of a participant's interest are entitled to receive a distribution of such interest in the Plan upon the death of the respective participant. A participant becomes fully Vested upon death or total and permanent disability. Benefits to the participant or their respective beneficiary or beneficiaries are payable, depending upon the circumstances, in the form of a lump sum payment, or substantially equal monthly, quarterly, or annual installments. All distributions are made administratively feasible. As of December 31, 2023, all employees who elected to withdraw from the Plan had been paid.

#### **J. Forfeited Nonvested Accounts**

Upon a participant's termination of employment prior to their normal retirement, disability or death, the portion of their Company contributions not then vested shall be forfeited, the forfeited portion of a participants' account may be used to reduce future Employer's contributions or to pay Plan expenses. At December 31, 2023, and 2022 the balance of forfeited nonvested accounts totaled \$11 and \$1,457, respectively. Forfeited nonvested accounts may be used to reduce future Employers' contributions or to pay Plan expenses. During the year ended December 31, 2023, employers' contributions were reduced by \$103,476 from forfeited nonvested accounts.

#### **K. Plan Expenses**

Professional and administrative fees and other expenses of the Plan, at the Company's election, may be paid out of the Plan.

### NOTE 2 – Summary of Accounting Policies

#### **A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles Generally accepted in the United States of America.

#### **B. Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities.

#### **C. Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair market value of investments for such investments.

#### **D. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

#### **E. Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **NOTE 3 - Fair Value Measurements**

The Financial Accounting Standards Board ("FASB") established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2023.

*Mutual funds:* Valued at the quoted net asset value of shares or units held by the Plan.

*Common/Collective Trust:* Valued at the net asset value of the shares held by the Plan at year-end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 6 - Plan Termination**

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, the Trustee shall distribute to the participants, their beneficiaries, or estates, all assets remaining in the Plan after payment of any expenses properly chargeable to the Plan. Such distribution will be equal to the value of the accounts of the participants as of the date of the termination of the Plan, adjusted to reflect any increments or decrements occurring between such termination date and the date of distribution.

#### **NOTE 7 - Federal Income Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service ("IRS") stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan is relying on IRS approval of a prototype plan on October 6, 2020, in which The Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America, require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020

#### **NOTE 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.
