December 31, 2023 and 2022

### NOTE 1 – DESCRIPTION OF PLAN AND PLAN TERMINATION

The following brief description of Amdal In-Home Care (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### Plan termination

On March 15, 2023, the Board of Directors of Amdal In-Home Care, Inc. (the Company) approved the termination of the Plan effective December 29, 2023. Consequently, no further contributions may be made to the Plan and accounts of all participants under the Plan became fully vested and nonforfeitable. Participants with remaining investment balances who did not affirmatively elect a distribution in connection with the Plan termination were transferred to an IRA account for their benefit. Any remaining balances will be paid out as soon as administratively feasible.

#### General

The Plan is a defined contribution 401(k) profit sharing plan established January 1, 2020, for the benefit of employees of Amdal In-Home Care, Inc. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's purpose is to enable eligible employees to defer a portion of their salary to provide for their retirement. The Trustees are responsible for oversight of the Plan and determine appropriateness of the Plan's investment offerings and monitor investment performances. The Plan has been restated for final Cycle 3 regulations effective January 1, 2022. The Plan was amended February 1, 2023 to remove automatic deferral provisions.

#### Eligibility

The Plan covers substantially all employees of the Company, except non-resident aliens and residents of Puerto Rico. An employee becomes eligible to participate in the Plan's salary deferrals, employer matching contributions and employer profit sharing contribution after completing three months of service. An employee is credited for each month during which he/she performs one hour of service, whether or not consecutive months. An hour of service is any hour for which an employee is paid or is entitled to payment. Employees may elect to participate in the Plan on the first day of the month following the completion of the eligibility requirements.

#### Employee contributions

Plan participants may contribute a pre-tax and/or after-tax salary deferral percentage or dollar amount of their annual compensation to the Plan up to 90% of compensation and subject to the maximum determined annually by the Internal Revenue Service (IRS). If the participant is age 50 or older, the participant may elect to defer additional amounts as defined by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also includes a provision for eligible automatic contribution arrangements whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation. The Plan has an auto escalation feature whereby participants that were automatically enrolled will have an annual 1% increase in deferrals up to a maximum deferral rate of 5%. As of February 1, 2023, the Plan no longer utilizes the automatic contribution arrangement.

#### NOTE 1 – DESCRIPTION OF PLAN AND PLAN TERMINATION (continued)

##### Employer contributions

Upon fulfillment of the eligibility requirements, the Company may make a discretionary profit sharing contribution to the Plan each year and in such amount, if any, as it may determine, as a percentage of compensation or a dollar amount per participant. The Company did not elect to make any discretionary profit sharing contributions to the Plan for the years ended December 31, 2023 and 2022. In addition, each year the Company may, at its discretion, make a matching contribution in an amount allocated proportionate to the amount of salary deferrals. The Company did not elect to make any matching contributions to the Plan for the years ended December 31, 2023 and 2022.

Contributions are subject to certain annual limitations.

##### Participant accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of the Company's profit sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants may direct the investment of their contributions, and any employer contributions, into a variety of mutual funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on a six-year graded vesting schedule. A participant becomes 100% vested in the Company's contributions if they become deceased, disabled, or attained the age 65.

As of December 31, 2022, the Plan held no assets subject to the vesting provisions.

All participants became fully vested on December 29, 2023 due to Plan termination.

##### Payment of benefits

Upon retirement, death, disability, or termination of service due to other reasons, a participant may elect to receive 1) a lump sum, 2) a non-recurring partial payment or 3) installment payments. The participants may make a direct rollover of their taxable distributions to another employer's qualified retirement plan or individual retirement account. Participants can request an in-service distribution upon attaining age 59 1/2.

##### Notes receivable from participants

Participants may borrow a minimum amount of \$500 and a maximum of 50% of their vested balance up to \$50,000. The loans are to be repaid with interest at least quarterly and in a time period not to exceed five years, unless the loan is being used to purchase a primary residence, in which case the loan must be repaid within 30 years of the original date of the loan. The loans are secured by the balance in the participant's account and bear a reasonable interest rate which is defined in the plan document as the prime rate plus 2 percent. Principal and interest are paid ratably through payroll deductions. Notes receivable were \$0 and \$540 as of December 31, 2023 and 2022, respectively.

##### Forfeitures

Forfeitures may be used to pay administrative expenses of the Plan or to reduce any employer contributions. If a participant does not receive a distribution of their vested account balance, the nonvested portion is forfeited at the end of the plan year during which the participant incurs their fifth consecutive one-year break in service. At December 31, 2023 and 2022, there were no forfeited nonvested accounts for each year. Additionally, during the years ended December 31, 2023 and 2022, employer contributions were not reduced by forfeited nonvested accounts.

#### NOTE 2 – ACCOUNTING POLICIES

##### Basis of accounting

For the year ended December 31, 2023, the financial statements are prepared on the liquidation basis of accounting. For the year ended December 31, 2022, the financial statements are prepared on the accrual basis of accounting.

##### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### Payment of benefits

Benefits are recorded when paid. Benefits distributed in 2024 due to Plan termination have been accrued.

##### Administration expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments.

#### Subsequent events

### NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value fund:* The stable value fund is classified as a cash equivalent. The net asset value is used as a practical expedient to estimate fair value and is calculated or valued using publicly available quotes on the underlying investment.

#### NOTE 5 – TAX STATUS

The Plan obtained its latest opinion letter on October 6, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 6 – ALLOCATION OF ASSETS

Net assets available in the amount of \$69,083 and \$14,471 for the years ended December 31, 2023 and 2022, respectively, have been allocated to the accounts of employees who have separated service with the Company. For the year ended December 31, 2023, net assets available in the amount of \$20,873 were included in benefits paid to participants to reflect liquidation status. There were no amounts subject to forfeiture at both December 31, 2023 and 2022.

#### NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 8 – RELATED PARTY TRANSACTIONS

While acting as custodian, Reliance Trust Company provided recordkeeping and investment services to the Plan and, therefore, these transactions qualified as party-in-interest transactions. Investment management services and third-party administrative services are paid for by the Company. Certain fees received by Reliance Trust Company or its affiliates and expenses charged by the mutual funds may be netted against investment income earned by the Plan. Administrative fees paid by the Plan were \$5,963 and \$402 for the years ended December 31, 2023 and 2022, respectively.

Administrative functions are jointly performed by employees of the Company and the third-party administrator. No employee receives compensation from the Plan. The independent auditor's fees are paid directly by the Company.
