Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Premium Windows 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023, and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of December 31, 2023, and 2022 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. DESCRIPTION OF PLAN

The following description of the Premium Windows 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan, as amended and restated, is a defined contribution plan established on January 1, 2020, for the employees of Mediland Corporation dba Premium Windows (collectively known as the Company). The Plan has a salary deferral arrangement provision as defined under Section 401(k) of the Internal Revenue Code (IRC). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended and restated effective August 1, 2022. With the amendment and restatement, the Plan received an opinion letter from the Internal Revenue Service dated October 6, 2020.

Eligibility. Employees are eligible to participate in the Plan and receive an employer match as of the first day of the plan quarter that coincides with the date after they have (1) reached age 21, and (2) have completed six months of service. The entry date is the first day of the month coinciding with or next following the date you satisfy the eligibility requirements.

Administration. The Plan Sponsor serves as the Plan administrator. Certain administrative costs are paid, and certain administrative functions are performed by the employees of the Company, without compensation from the Plan. The Plan administrator has designated Reliance Trust Company (Reliance or the Trustee), as Trustee of the Plan. The Trustee receives all contributions made under the Plan, holds Plan assets, pays benefits to participants and executes other transactions directed by the Plan administrator. The Plan administrator has engaged ADP Retirement Services as the third-party administrator to assist in the administration and maintain the records of the Plan.

Contributions. There are 4 different contribution types available in the plan: employer profit sharing, employer matching, employee elective deferrals, including Roth 401k deferrals, and employee rollovers. Participants may elect to contribute up to a specific percentage or dollar amount, subject to certain statutory limits which change periodically. The Participant contributions elections may be pre-tax salary deferrals. In addition, they may elect to make rollover contributions of balances held with other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. All employees who are eligible to make salary deferrals under this plan and who are age 50 or older before the close of a plan year, are eligible to make catch-up contributions. The catch-up contributions are in addition to the regular salary deferrals mentioned above. The IRS limits the amount that can be contributed as a catch-up contribution. The Plan provisions also include discretionary employer profit sharing and discretionary employer match.

Participant Accounts. Each participant's account is credited with the participant's contributions and the Company's matching contributions (if any), as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Upon enrollment in the Plan, a participant may direct his or her respective share of contributions into various investment options. The benefit to which a participant is entitled is the vested portion of the participant's account.

1. DESCRIPTION OF PLAN (CONTINUED)

Vesting. Participants are immediately vested in their elective contributions plus net earnings (losses) thereon. They become vested in discretionary employer profit sharing and matching employer contributions plus earnings (losses) thereon at a rate of 20% per year of vesting service, beginning with the 1st year of service.

Payment of Benefits. In the event of death, disability, retirement, or termination of employment, the vested portion of a participant's account may be paid to the participant or his or her beneficiary as a lump-sum payment or rolled over to an individual retirement account or another tax-qualified plan. A participant with a vested account balance of more than \$5,000 may instead choose to have the vested balance paid in installments or to defer receiving payments until age 70½.

Active employees that have reached the age of 70 ½ will begin to receive a distribution from their account on April 1st following the calendar year in which they reach the age 70 ½ or the calendar year in which he/she retires unless participant is a 5% owner.

Notes Receivable from Participants. Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their vested account balance. No loan in an amount less than \$500 will be granted to any participant. The loans are secured by the balance in the participant's account and must be repaid at a fixed interest rate which is commensurate with local prevailing rates as determined by the Plan. Generally, loans must be repaid within five years, unless the loan was for the purchase of a principal residence. In this case, the repayment period may be extended. Principal and interest is paid ratably through payroll deductions. Delinquent or default notes receivable from participants are written off as "deemed" distributions at the end of the quarter following the quarter in which the default occurs.

The Plan classifies participant loans as notes receivable from participants in the statements of net assets available for benefits and measures them at their unpaid principal balance plus any accrued interest.

Forfeitures. When participants terminate employment, any nonvested portions of their matching employer contributions are forfeited and may be applied to pay administrative expenses or reduce future employer contributions. During the year ended December 31, 2023, forfeitures in the amount of \$4,522 were used to pay plan expenses.

Administrative Expenses. Certain expenses for maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments on the accompanying statement of changes in net assets available for benefits.

Investment Elections. The investments of the Plan are self-directed by the participants into various investment options offered by the Plan. Investment elections may be changed online or by telephone at any time.

Plan Termination Provision. Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants become fully vested in their accounts.

2. SUMMARY OF ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

Basis of Accounting. The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). Investments held by a defined contribution plan are required to be reported at fair value.

Investment Valuation and Income Recognition. The Plan provides participants with the choice of investment options in a variety of mutual funds that invest in stocks, bonds, fixed-income securities, and other investment securities. The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and Custodian. See Note 4 for discussions of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

Payment of Benefits. Benefits are generally recorded when paid.

Use of Estimates. The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Concentrations, Risks, and Uncertainties. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan invests substantially all its assets with a single institution. In the event of the institution's failure, the Plan could be subject to substantial losses.

The Plan had four investments that accounted for approximately 71% of total investments as of December 31, 2023.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2- Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies during 2023.

Mutual funds: The fair value of these mutual funds is based on quoted prices in an active market for each share held by the Plan.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate or amend the Plan at any time, subject to the provisions of ERISA.

6. TAX STATUS

The Company adopted a non-standardized plan which received a favorable opinion letter on October 6, 2020 from the Internal Revenue Service stating that the plan document as then designed was in compliance with the applicable requirements of the IRC and making it exempt from income taxes under the provisions of Section 501(a). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no provision was made for federal income taxes in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's tax returns generally remain open for Federal tax audits for three years from the filing date.

7. EXCESS CONTRIBUTIONS PAYABLE

Contributions received from participants for the plan year ended December 31, 2023 include \$14,117 of excess contributions (net of corresponding gains and losses) that were distributed during the plan year ended December 31, 2023 to certain active participants. The excess deferral contributions, originally contributed in the year ended December 31, 2023, were returned to comply with the participants' applicable maximum annual contributions permitted under the IRC. The respective amounts are included in the Plan's statements of net assets available for benefits as excess contributions payable as of December 31, 2023. There were \$14,269 excess contributions payable as of December 31, 2022.
