### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Employee Benefit Plan of Dutchess County Chapter-New York State Association for Retarded Children (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 16, 2022 (in liquidation) and December 31, 2021 (ongoing), and the related statements of changes in net assets available for benefits for the period ended August 16, 2022 and year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 16, 2022 and December 31, 2021, and for the period ended August 16, 2022 and year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 1 to the financial statements, management of the Plan approved a plan termination as of September 1, 2022, and management determined liquidation was imminent during fiscal 2022. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTES TO FINANCIAL STATEMENTS**

**1. Plan Description:**

The following description of the Employee Benefit Plan of Dutchess County Chapter-New York State Association for Retarded Children (the "Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a non-contributory defined contribution plan covering substantially all employees of NYSARC, Inc. Dutchess County Chapter (the "Chapter") who have completed one year of service with a minimum of 1,000 hours and attaining the age of twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and the Internal Revenue Code ("IRC").

On January 1, 2021, the Sponsor became unified with Sullivan Orange Counties Chapter, NYSARC, Inc. (Sullivan Orange Counties Chapter). Based on this unification, effective January 1, 2021, the Board agreed to allow employees that are not covered by a collective bargaining agreement to participate in the pre-existing defined contribution plan of Sullivan Orange Counties Chapter.

Effective January 1, 2021, the Plan was also amended to allow participants to voluntarily withdraw funds beginning at age 59 1/2 to comply with federal guidance.

Effective August 16, 2022, the Board of Directors of the Sullivan-Orange-Dutchess Counties Chapter decided to terminate the Plan and transfer assets into The Arc New York Affiliated Employers 401(k) Plan.

The Plan has implemented certain requirements of the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief, to suspend required minimum distributions, and delay the commencement date for required minimum distributions.

**Contributions**

Each year, the Chapter contributes two percent of each participating employee's eligible compensation. Voluntary contributions from Plan participants are not permitted.

**Vesting**

Vesting in employer matching contributions is based on years of continuous service. The Plan's vesting terms for employer contributions are as follows:

**Participant Accounts**

Participant accounts are credited with the Chapter's contributions and an allocation of Plan earnings/(losses). Allocations are based on each participant's earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

**Notes Receivable from Participants**

Loans are not permitted under this Plan.

**Distributions**

Vested funds are paid to participants when they retire or terminate employment with the Chapter. Benefits are paid in periodic installments over a period that is not greater than or equal to the life expectancy of the participant. Benefits may be paid out in a single lump sum if the participant and their spouse waive the annuity form of payment.

**1. Plan Description (continued):**

Participants may receive distributions up to 100% of their vested account balance in the form of a hardship withdrawal upon meeting financial hardship requirements outlined in the Plan document.

**Forfeitures**

Upon termination of employment, participants forfeit their non-vested balances. Forfeited non-vested amounts are used to reduce future company contributions.

Forfeitures in the amount of \$10,147 and \$12,857 were used to reduce Chapter matching contributions during 2022 and 2021, respectively. Forfeiture balances amounted to \$- and \$4,054 as of August 16, 2022 and December 31, 2021, respectively.

**Plan Termination**

The Chapter has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their account balances.

Effective August 16, 2022, the Board of Directors of the Sullivan-Orange-Dutchess Counties Chapter decided to terminate the Plan and transfer assets into The Arc New York Affiliated Employers 401(k) Plan.

**Administration**

The Plan is administered by the Chapter, which is the "Plan Sponsor". Mutual of America Life Insurance Company ("Mutual of America") is the trustee for the Plan.

**2. Summary of Significant Accounting Policies:**

**Basis of Accounting**

Due to the decision to terminate the Plan as of August 16, 2022 and the subsequent liquidation, management determined that liquidation of the Plan is imminent and the financials for 2022 have been prepared using the liquidation basis of accounting. The 2021 financial statements have been prepared using the accrual method of accounting which recognizes income when it is earned and expenses as they are incurred.

**Pervasiveness of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on those investments bought and sold during the year as well as held at year-end.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain administrative fees are paid by the Sponsor. Fees paid to Mutual of America for investment management services are paid by the Plan as a reduction of investment returns.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan's investments are not insured or protected by the Plan's Trustee. Accordingly, the Plan is subject to the normal investment risks associated with money market funds, mutual funds, stocks, bonds and other similar types of investments.

**Income Taxes**

The Plan adopted a non-standardized form of a prototype plan sponsored by Mutual of America. The prototype plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and concluded that, as of August 16, 2022, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

**Subsequent Events**

The date to which events occurring after August 16, 2022, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustment to the financial statements or disclosure is June 4, 2024, which is the date on which the financial statements were available to be issued.

**3. Information Certified by Trustee:**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Mutual of America, the Trustee of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements for the period ended August 16, 2022 and the year December 31, 2021. The following table presents the fair value of the assets in the Plan certified by the trustee.

Mutual of America also certified to the completeness and accuracy of \$(810,782) and \$696,019 of net appreciation/(depreciation) in fair value of investments and \$3,890 and \$23,952 of interest and dividends related to the aforementioned Plan Assets for the period ended August 16, 2022 and the year ended December 31, 2021, respectively.

**4. Fair Value Measurements:**

Accounting principles generally accepted in the United States of America establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**4. Fair Value Measurements (continued):**

Level 2: Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
- c. Inputs other than quoted prices that are observable for the asset or liability;
- d. Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 16, 2022 and December 31, 2021.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of the future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. General Account:**

At December 31, 2021, the Plan had an interest accumulation account with Mutual of America that is considered fully benefit responsive. There are no front or back end charges, so investments in the General Account are completely liquid. The interest rate credited to investments in the General Account is a current rate, and is not dependent upon the length of time the assets are invested with Mutual of America. Requests for withdrawal can be made at any time and are processed on the day that they are received; they are not dependent on Mutual of America having to liquidate securities in order to generate a payment. The value shown of \$2,313,667 at December 31, 2021 is the redeemable value of the fund. There are no deferred sales charges, load assessments or interest rate adjustments that would affect the value as a result of a withdrawal request.

**6. Net Transfer To Other Plan:**

Effective August 16, 2022, the Board of Directors of the Sullivan-Orange-Dutchess Counties Chapter decided to terminate the Plan and transfer assets into The Arc New York Affiliated Employers 401(k) Plan. The plan assets totaling \$5,669,083 were transferred on September 6, 2022. In addition, the Plan also transferred \$14,806 of employer match contribution receivable, which was paid to The Arc New York Affiliated Employers 401(k) Plan on January 25, 2023, for contributions earned by the Plan before the transfer.
