To whom it may concern, My name is Selena Starr, Secretary at Viking Mechanical Inc.

I just received noticed on Oct. 14th 2024 that I failed to file 5500-SF form for both 2021 and 2022. In 2020 I was diagnosed with auto immune disorder which forced me to make significant life changes including closure of Viking Mechanical Inc, closing the related 401k account and relocating from CA to Washington State. From 2020 when I was initially diagnosed with my auto immune disorder, till even now, each and every day has been a struggle for me. Upon receiving this notice, with help, I have been working diligently and doing everything in my power to get these forms filed and get this oversight corrected immediately.

I am requesting due to reasonable cause, with the heath issues I am still struggling with even today that all fees and penalties be waived regarding this innocent mistake. I thought I had done everything correctly in closing the 401k account in April of 2022, not realizing the form 5500-SF needing to be filed a month later in May 2022 for the previous year and once again in May 2023 for the year 2022.
