INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Excell Communications, Inc. 401K Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. Description of the Plan

The following brief description of the Excell Communications, Inc. 401K Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the comprehensive plan document for a more complete description of the Plan’s provisions.

General

The Plan was adopted effective April 1, 2020 by Excell Communications, Inc. (the “Company”) who is the sponsor of the Plan. The Plan is a contributory defined contribution plan covering all eligible employees of the Company as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

In January 2022, Prower Telco Services Inc. was incorporated under the laws of the State of New York. At the time of incorporation, the Company received 50% ownership shares with the remaining 50% shares owned by an independent third party. Effective July 1, 2023, the Plan was amended to allow Prower Telco Services Inc. to become a participating employer in the Plan, and contributions for its employees are followed according to the Plan’s outline for *Contributions*.

On March 23, 2023, pursuant to a stock purchase agreement, the Company acquired all shares of Tele/Cable, Inc. based in South Plainfield, New Jersey. Tele/Cable, Inc. has been asked to continue with its existing 401K Plan, and therefore no contributions were made to the Plan during 2023.

Trustee (Custodian) and Administration of the Plan

The trustee (custodian) and record-keeper of the Plan is Reliance Trust Company (the “Trustee”), which is a subsidiary of Fidelity National Information Services, Inc. The administrator of the Plan is the Company. The trustee (custodian) holds all assets of the Plan in accordance with the service provider contract with the Company. The investment committee or plan management determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Eligibility

Any employee of the Company becomes an eligible participant in the Plan following their date of hire subject to the completion of three months of service and the attainment of twenty-one years of age unless (1) union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, unless the collective bargaining agreement requires the employee to be included within the Plan; (2) certain nonresident aliens who have no earned income from sources within the United States; (3) leased employees; (4) employees who are residents of Puerto Rico; and (5) certain part-time, temporary, and seasonal employees whose scheduled service is less than 1,000 hours of service in any year of employment. An eligible participant can enter the Plan immediately upon meeting the eligibility requirements.

Contributions

Contributions are comprised of participant deferral contributions including Roth 401(k) deferrals, employer matching contributions, employer discretionary profit-sharing contributions, and rollover contributions as follows:

- a) An employee participating in the Plan may annually contribute through payroll deductions, any amount up to 90 percent of compensation not exceeding amounts as determined by the Internal Revenue Service (“IRS”).
- b) The Plan also allows for Roth contributions.
- c) Any participant age 50 or over may make an additional “catch up” contribution as determined by the IRS. Participants direct the investment of their contributions into various investment options offered by the Plan.

1. Description of the Plan – continued

Contributions - continued

- d) The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.
- e) Participants may also contribute amounts representing distributions from other qualified retirement plans and certain IRAs (rollover).
- f) The Company may make an employer matching contribution as a percent of eligible compensation deferred by participants. Catch-up contributions are not eligible for matching contributions. During 2023, the Company made matching contributions of an amount equal to 100 percent of such contributing participants' elective deferral which does not exceed 4 percent of the contributing participants' compensation.
- g) Each year, the Company may also make a discretionary profit-sharing contribution to the Plan. No non-elective discretionary contribution was made for the year ended December 31, 2023.

Participant Accounts

Individual accounts are established for each Plan participant. Each participant's account is credited with the participant's pre-tax contributions and/or Roth contributions, the Company contributions, if any, and the proportionate share of dividends, interest and investment gains since the preceding valuation date. The Plan currently offers several mutual funds and stable value funds as investment options for participants. Each participant's account is reduced by withdrawals, losses on investments, expenses of the Plan, and any forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their individual deferral, Roth, and rollover contributions and the allocated earnings thereon. A participant's vested interest in the Company's matching contributions and discretionary profit-sharing contributions are based upon the participant's years of continuous service. A participant's account vests 20% per year of service completed after the second year, and is 100 percent vested after six years of credited service. A participant earns and accumulates a year of vesting when their account is credited with 1,000 hours of service during a plan year. With respect to the Company's matching contributions and profit-sharing contributions, any unvested portion of their account shall be forfeited on the earlier of the date of the distribution of your vested account balance or when you incur five consecutive 1-Year Breaks in Service. A participant shall be considered 100% vested in the matching and profit-sharing contributions upon reaching normal retirement age or termination of service due to death or disability. As of December 31, 2023, the vesting schedule of employer matching and profit-sharing contributions was as follows:

Notes Receivable – Participant Loans

Participants are permitted to borrow a minimum of \$500 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the excess, if any, of their highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan over their current outstanding balance of loans as of the date of the new loan. Loans are secured by the participant's account and bear an interest rate at the prime rate plus 2%. The interest rate is fixed for the duration of the loan. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence up to 30 years. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC. Participants are limited to two outstanding loans at any time.

Participant loans are reclassified as notes receivable from participant, and are measured at the unpaid principal balance plus unpaid accrued interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan. Deemed distributed loans for the year ended December 31, 2023 were \$38,210.

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined in the Plan, or termination of service. After attaining age 59-1/2, 100 percent of the participant's account may be withdrawn for any reason. In the event of termination of employment, a participant may elect to receive, as a lump-sum distribution, his/her participant contributions and earnings thereon, and vested Company contributions and earnings thereon, leave the account in the Plan, or rollover the vested balance to another qualified retirement plan or IRA.

If the participant's vested account balance does not exceed \$5,000, then their vested account balance may only be distributed in a single lump-sum payment. If the participant's vested account balance exceeds \$5,000, they may elect to receive a distribution of their vested account balance in:

- a single lump-sum payment
- installments over a period of not more than their assumed life expectancy (or the assumed life expectancies of them and their beneficiary)
- partial withdrawals of at least \$500

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Forfeitures

At December 31, 2023 and 2022, forfeited non-vested accounts totaled approximately \$52 and \$13, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. Approximately \$70,764 of the forfeited funds were used to pay administrative expenses and/or fund employer contributions in 2023.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the Plan's financial statements in conformity with the accounting principles generally accepted in the United States of America ("US GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments in the Plan are reported at fair value in accordance with ASC 820, Fair Value Measurements. The fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. No allowance for credit losses had been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Accounting Policies - continued

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

3. Investment Information Certified by the Plan's Trustee and Custodian (Unaudited)

Certain information related to the investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company ("Reliance").

The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the trustee as complete and accurate pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Security Act of 1974.

At the request of the plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurement

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022:

Mutual funds: Mutual funds represent investments with various investment managers. The fair value of these investments is determined by reference to the Fund's underlying assets, which are principally marketable securities and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value as of December 31, 2023 and 2022.

Stable value funds (common collective trusts): Shares of the stable value funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by the Plan's investment managers/advisors. Participant loan and distribution processing fees are paid to Reliance or the third-party administrator/recordkeeper by participants. The Plan paid for third party administrator fees and investment advisory fees which qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

7. Refund of Excess Contributions

The Plan failed the IRC Section 402(g) limit test, IRC 401(k) Actual Deferral Percentage ("ADP") and/or Actual Contribution Percentage ("ACP") compliance tests of employees and employer contributions for the year ended December 31, 2023. The Plan corrected the test failure by returning the excess contributions to the respective employees in the following year. Certain excesses of employer contributions are not refunded, but are forfeited. The refund included income/(loss) allocable to the excess contributions. As of December 31, 2023 and 2022, the excess contributions payable was \$10,040 and \$938, respectively.

8. Income Tax Status

The Plan adopted an ADP prototype non-standardized profit sharing 401(k) plan. The Internal Revenue Service has determined and informed ADP by an opinion letter dated October 6, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020. In addition, there have been no tax related interest or penalties for periods presented in these financial statements.

9. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100 percent vested in their accounts.

11. Partial Termination

The presumption of a partial termination happens when more than 20% of the total plan participants are laid off in a particular year. Partial terminations can occur in connection with a significant corporate event such as a closing of a plant or a division, or as a result of general employee turnover due to adverse economic conditions or other reasons that are not within the employer's control.

The law requires all affected employees to be fully vested in their account balance as of the date of a full or partial plan termination. They must become 100% vested in all employer contributions (including matching contributions) regardless of the plan's vesting schedule. Employee salary deferrals are always 100% vested. An affected employee in a partial termination is generally anyone who left employment for any reason during the plan year in which the partial termination occurred and who still has an account balance under the plan.

During the 2023 plan year, the Company involuntarily terminated a significant number of its employees and has determined that a partial termination of the Plan occurred, requiring full vesting of affected participant benefits. Consequently, it has been determined that the Company should make corrective contributions of approximately \$57,358 to the Plan in order to restore affected employees' accounts that need to be 100% vested. This amount has been included in the statements of net assets available for benefits and changes in net assets available for benefits under *employer's contributions*.

12. Subsequent Events

The Plan has evaluated subsequent events from the date of the statement of net assets available for benefits through October 14, 2024, the date the financial statements were available to be issued.

Subsequent to the end of the year, the Company continued to involuntarily terminate a significant number of its employees, and therefore it is more likely than not that the Plan will be subject to a partial termination pursuant to Section 411(d)(3) of the Internal Revenue Code ("IRC") and under Rev. Rul. 2007-43. It is estimated that the Company will have to make corrective contributions of approximately \$177,071 to restore affected participant benefits under the Plan.

Effective January 1, 2024, the Plan was amended to allow Tele/Cable, Inc. to become a participating employer in the Plan.
