**1. Description of Plan**

The following description of the Whiting Door Manufacturing Corp. 401(k) Retirement Plan for Bargaining Unit Employees (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan, established January 1, 2013, is a defined contribution plan covering employees of Whiting Door Manufacturing Corp. (the “Plan Sponsor” or “Plan Administrator”) who are members of the collective bargaining unit between the Plan Sponsor and the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers’ International Union (USW) and its Local 748, consisting of production and maintenance employees (excluding all supervisors, office clerical employees, plant guards and professional employees) employed at the Plan Sponsor’s Akron, New York, facility on 113 Cedar Street. The Plan was most recently amended effective January 1, 2023 to modify the eligibility requirements, add automatic deferral and automatic deferral increase features to the Plan, and change the Plan Sponsor matching contribution.

Effective January 1, 2023, employees are eligible to participate in the Plan upon attaining age 18 and upon the earlier of completing 1,440 hours of service or one year of eligibility service, as defined by the Plan. Leased employees and independent contractors are also excluded from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Merger** – Effective January 1, 2024, the Plan merged into the Non-Bargaining Plan. The merged plans were renamed as the Whiting Door Manufacturing Corp. 401(k) Retirement Plan (“Merged Plan”). Plan assets totaling \$7,297,783 transferred from the Plan to the Merged Plan on January 8, 2024. Each participant in the Plan is entitled to receive future benefits from the Merged Plan.

**Setting Every Community Up for Retirement Enhancement (SECURE) Act** – In response to the impacts of the COVID-19 (Coronavirus) pandemic, the Plan implemented regulations available to employee benefit plans under the SECURE Act during the year ended December 31, 2020. The regulations temporarily waived all required minimum distributions (“RMDs”) for calendar year 2020, and increased the required beginning date for RMDs from 70½ to 72. Plan management effectuated a Plan amendment on July 20, 2020 to allow for the aforementioned relief options.

On December 29, 2022, the SECURE 2.0 Act was signed into law to address additional retirement issues. SECURE 2.0 Act includes provisions to help participants increase retirement savings and simplify and clarify certain retirement plan rules. SECURE Act 2.0 increases the age for RMDs to age 73, effective January 1, 2023 and increasing it to age 75 by 2033. Plan management is currently reviewing SECURE 2.0 provisions and will amend the plan as required.

**1. Description of Plan (continued)**

The Plan has not implemented any changes or amendments related to the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act.

**Contributions** – Participants may elect to contribute between 1% and 100% of their annual compensation, subject to Internal Revenue Code (“IRC”) limitations. Participants may also elect to make voluntary after-tax contributions from 1% to 25% of the participant’s covered compensation. Effective January 1, 2023, participants who do not make an elective deferral are automatically enrolled at a 2% deferral rate. In addition, unless an election is made to opt out, participants with a deferral rate of 10% or less have their deferral rate increased by 1% annually.

Participants may also contribute rollover amounts representing distributions from other qualified retirement plans. Additionally, participants age 50 or older may elect to make a catch-up contribution limited to the amount imposed by law.

Effective January 1, 2023, the Plan Sponsor contributes 3% of the participant’s covered compensation for each contribution hour, as defined by the Plan. The Plan Sponsor also contributes the lesser of one-half of the participant’s elective deferral contributions or 1% of the participant’s eligible compensation for the Plan year.

There were no contributions to the Plan from January 1, 2024 to January 8, 2024 as this was a blackout period for the Plan. The Plan Sponsor withheld contributions and calculated Plan Sponsor contributions during this period which were remitted to the Merged Plan after the blackout was lifted after January 8, 2024.

**Participant Accounts** – Individual accounts are maintained for each Plan participant. Participants direct the investment of their elective, Plan Sponsor and rollover contributions into various investment options offered by the Plan. Participant accounts are increased by participant contributions, Plan Sponsor contributions and the participant’s share of Plan earnings. Participant accounts are decreased by participant distributions and each participant’s share of Plan expenses and losses. The allocation of earnings and losses to participant accounts is based upon the value of an individual account in relation to the total assets of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – Participants are immediately vested in their 401(k) salary deferral, after tax or rollover contributions plus actual earnings thereon. Vesting in the Plan Sponsor’s contributions to participant accounts plus actual earnings thereon is based on years of vesting service as shown in the table below. Vesting service starts on the participant’s date of employment with the Plan Sponsor.

Participants may become fully vested in Plan Sponsor contributions upon attainment of age 65 or upon death while employed by the Plan Sponsor.

***Notes Receivable from Participants*** – Participant loans are not permitted.

***Payment of Benefits*** – Upon termination of service, retirement or death, a participant may elect to receive a lump-sum or partial withdrawal amounts equal to the value of the participant’s vested interest in his or her account. The Plan permits in-service distributions for participants older than age 59½. Hardship withdrawals as defined by the IRC are available to participants younger than age 59½ only from the vested portion of their account.

***Forfeitures*** – Forfeitures may be used to fund Plan Sponsor contributions or pay administrative expenses. There were no forfeitures used during the period ended January 8, 2024.

***Income Taxes*** – The Plan Sponsor has received a determination letter dated January 28, 2015 stating that the Plan is qualified under the IRC Section 401 and therefore the Plan is exempt from taxation. Accordingly, no provision for income taxes has been included in the accompanying financial statements. The Plan has been amended since the effective date of the letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the requirements of the IRC and, therefore, believes that the Plan is qualified and related trust is tax exempt.

***Plan Termination*** – As discussed above, the Plan merged into the Whiting Door Manufacturing Corp. 401(k) Retirement Plan for Non-Bargaining Unit Employees (“Non-Bargaining Plan”) effective January 1, 2024. Each participant in the Plan is entitled to receive future benefits from the merged plan.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting*** – These financial statements are prepared under the accrual method of accounting in accordance with U.S. GAAP.

***Investment Valuation and Income Recognition*** – The Plan’s investments in mutual funds and collective investment trusts as of December 31, 2023 are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There are no reserves against investment values for credit risk. See Note 4 for discussion of fair value measurements.

The Plan’s investment in the Principal Life Insurance Company Fixed Income Guaranteed Option as of December 31, 2023 is reported at contract value. The contract value equals the accumulated cash contributions and transfers to the option, plus interest credited, less any withdrawals and transfers out of the option and charges deducted.

The Plan presents in the accompanying statement of changes in net assets available for benefits the net depreciation in the fair value of its investments, which includes both realized gains and losses and unrealized appreciation (depreciation) in the fair value of investments. Realized gains and losses on disposition of investments were based upon actual costs and selling prices.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Administrative Expenses*** – Certain accounting and administrative expenses necessary to administer the Plan are paid for by the Plan Sponsor. Expenses relating to investment activity are paid by the Plan. There were no expenses paid by the Plan during the period ended January 8, 2024.

***Party-In-Interest Transactions*** – Certain Plan investments were managed by Principal Trust Company, which also serves as the trustee of the Plan. Accordingly, transactions involving these investments qualify as party-in-interest transactions. There were no fees paid to the Trustee for custodial and investment management services during the period ended January 8, 2024.

***Use of Estimates*** – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

*Subsequent Events* – The Plan Administrator has evaluated subsequent events, for recognition and disclosure through September 21, 2024, the date the accompanying financial statements were available to be issued, and has determined that no additional recognition or disclosure was necessary.

**3. Information Certified by the Trustee (Unaudited)**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the investments included in the accompanying financial statements is complete and accurate at January 8, 2024 and December 31, 2023, respectively.

The Trustee also certified interest and dividend income totaling \$5 and net depreciation in fair value of investments of \$45,878 for the period ended January 8, 2024.

**4. Fair Value Measurements**

ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices identical or similar assets or liabilities in markets that are not active.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets of the Plan that were valued using Level 3 inputs at January 8, 2024 and December 31, 2023.

**4. Fair Value Measurements (continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Shares of mutual funds are valued at quoted market prices which represent the net asset value ("NAV") of shares held by the Plan at the end of the period/year.

*Collective Investment Trusts ("CITs"):* Collective investment trusts invest in a variety of separate investments and mutual funds, and are valued daily based on the market value of the underlying assets. No unfunded commitments exist on these investments at January 8, 2024.

**5. Fixed Income Guaranteed Insurance Contract with Principal**

Principal Fixed Income Guaranteed Option is a fully benefit-responsive insurance contract (the "Contract") issued by Principal Life Insurance Company. The account is credited with earnings on the underlying investments and charged with participant withdrawals and administrative expenses. The Contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the Contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Contract. Contract value, as reported to the Plan by Principal, represents contributions made under the Contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is contractually guaranteed by Principal. Principal guarantees that the crediting interest rate will never be less than 0%. Such interest rates are reviewed semiannually for resetting.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: 1) amendments to the Plan agreements including complete or partial Plan termination or merger with another plan; 2) premature termination of the Contract; 3) changes to the Plan's prohibition on competing investment options; 4) bankruptcy of the Plan Sponsor or other Plan Sponsor events that significantly affect the Plan's normal operations; or 5) the failure of Principal to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.
