### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* □

We have audited the financial statements of Medicago Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 24, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period January 1, 2024 to July 24, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Medicago Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 24, 2024 and December 31, 2023 and for the period January 1, 2024 to July 24, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Medicago Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting***

As further discussed in Note 1 to the financial statements, the Plan Sponsor elected on January 10, 2024 to terminate the plan effective March 31, 2024 and management determined liquidation is imminent. As a result, the Medicago Retirement Plan changed its basis of accounting from the ongoing basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Medicago Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **Plan Termination**

By a resolution adopted by the Plan Sponsor on January 10, 2024, the Plan Sponsor terminated the Plan effective March 31, 2024. In conjunction with the termination of the Plan, employees were no longer eligible to enter the Plan and no further contributions were allowed to be made to the Plan as of March 31, 2024. The Plan's net assets in liquidation were paid out to participants by July 24, 2024. Payments to participants may be in the form of a single lump sum or a rollover into a qualified Plan.

#### **General**

Prior to the date of termination, the Plan was a defined contribution plan covering all eligible full-time employees of the Medicago USA, Inc. (the "Company") immediately upon hire. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator was responsible for oversight of the Plan. The Plan's Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the Plan administrator.

#### **Contributions**

Prior to the date of termination, participants were able to contribute up to 100% of their pre-tax annual compensation, as defined in the Plan, up to the maximum amount allowed by law. Participants could also make qualified Roth contributions to the Plan and could contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants' deferral rate was set at 4% of their eligible compensation and increased annually by 1% up to a maximum deferral rate of 10%, unless otherwise elected by the participant. Participants directed the investment of their contributions into various investment options offered by the Plan.

Prior to the date of termination, the Company made safe harbor matching contributions equal to 100% of the participant's salary deferral up to 4%. The Company could also make discretionary profit sharing contributions. There were no discretionary Company profit sharing contributions made for the period January 1, 2024 to July 24, 2024. Contributions were subject to certain limitations as determined by the Internal Revenue Code.

#### **Participant Accounts**

Prior to the date of termination, each participant's account was credited with the participant's contributions, including amounts rolled over from other qualified plans, Company matching contributions, as well as allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

**Vesting**

All participants became fully vested on the Plan termination date of March 31, 2024.

**Notes Receivable from Participants**

Prior to the date of termination, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans were secured by the balance in the participant's account and bear interest, commensurate with local prevailing rates as determined periodically by the Plan administrator. Principal and interest were paid ratably through payroll deductions.

**Payment of Benefits**

Prior to the date of termination of the Plan, the Plan permitted withdrawals when a participant terminated employment, reached normal retirement age or became disabled or deceased. In-service withdrawals were also permitted for certain financial hardships or when a participant attained age 59 1/2. Benefits were payable in lump-sum payments.

Upon the decision to terminate the Plan effective March 31, 2024, participants were provided the opportunity to elect a full distribution of their account balance or to rollover their account balance to another qualified plan. If no election was made by the participant as of June 3, 2024, and the participant balance was greater than \$1,000, the balance was rolled over to an individual IRA. If participant balance was \$1,000 or less, a taxable distribution was made to the participant.

**Forfeited Accounts**

Forfeited nonvested accounts totaled \$-0- and \$5,819 as of July 24, 2024 (in liquidation) and December 31, 2023 (ongoing), respectively. These accounts could be used to pay administrative expenses or to reduce employer contributions. From January 1, 2024 to July 24, 2024, \$5,865 of forfeitures were used by the Company to reduce administrative expenses and Company contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**

"By a resolution adopted by the Plan sponsor on January 10, 2024, the Plan was terminated effective March 31, 2024. In 2024, Plan management determined that liquidation of the Plan was imminent and the 2024 financial statements have been prepared using the liquidation basis of accounting. The 2023 financial statements were prepared using the accrual (ongoing) basis of accounting. The financial statements have been prepared in accordance with the accounting principles generally accepted in the United States of America ("GAAP")."

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the matching contributions from the Company were recorded in the year in which the employee contributions were withheld from compensation. As of July 24, 2024 and December 31, 2023, a credit loss reserve of \$168,023 and \$168,023 has been recorded, respectively.

**Payment of Benefits**

Benefits were recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Certain investment related expenses were paid using the Plan's assets and were either included in net appreciation or depreciation of fair value of investments or were allocated among participants in the Plan. Certain expenses relating to specific transactions were paid directly by the participant and were included in administrative expenses.

**Subsequent Events**

The Plan has evaluated events and transactions for potential recognition or disclosure through October 1, 2024, which is the date the financial statements are issued.

NOTE 3 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements, including investments held at July 24, 2024 (in liquidation) and December 31, 2023 (ongoing), and net appreciation/depreciation in fair value of investments, and interest and dividends for the period January 1, 2024 to July 24, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

#### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 - *Fair Value Measurement* are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission ("SEC"). These funds were required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

*Stable value collective trust fund:* A stable value fund that was composed primarily of benefit-responsive investment contracts that was valued using the NAV, provided by the administrator of the trust. The NAV was used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were shares of common collective trusts managed by Fidelity Management Trust Company and related affiliates, the trustee of the Plan, therefore, these transactions qualified as party-in-interest transactions. Plan recordkeeping, transaction processing, and investment management services were provided by Fidelity Management Trust Company and related affiliates, therefore, these transactions qualified as party-in-interest transactions. Fees incurred by the Plan for the investment management services were included in net appreciation or depreciation in fair value of the investment. The Company paid directly any other fees related to the Plan's operations.

#### NOTE 7 - PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. As disclosed in Note 1, the Plan Sponsor terminated the Plan on March 31, 2024, and the employer receivable has been deemed uncollectible and writing off in full as of July 24, 2024. All Plan assets were distributed to plan participants prior to July 24, 2024.

#### NOTE 8 - TAX STATUS

Effective February 22, 2022, the Plan adopted a pre-approved plan of Fidelity Management & Research Co. (FMR LLC). The pre-approved plan received an opinion letter from Internal Revenue Service ("IRS") dated June 30, 2020, that the pre-approved plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and was being operated in compliance with the applicable provisions of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 24, 2024 (in liquidation) and December 31, 2023 (ongoing), there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

#### NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks.
