Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Vermont State Employees Credit Union Capital Accumulation Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Vermont State Employees Credit Union Capital Accumulation Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the Plan merged into the New England Federal Credit Union Salary Savings Plan effective January 1, 2023. As a result, subsequent to the merger the Plan is no longer a going concern.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Vermont State Employees Credit Union Capital Accumulation Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of the Plan

The following brief description of the Vermont State Employees Credit Union Capital Accumulation Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

- (a) General - The Plan was a qualified 401(k) and profit sharing plan covering all employees of the Vermont State Employees Credit Union (the "Credit Union") and was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan originated on July 1, 1997. Any employee age 18 or older was eligible to participate; there was no service requirement and no waiting period.

Effective January 1, 2023, the Credit Union merged with New England Federal Credit Union. Employees of the Credit Union became eligible participants of the New England Federal Credit Union Salary Savings Plan. In addition, the Plan merged into the New England Federal Credit Union Salary Savings Plan during 2023 and ceased to exist as a standalone Plan. Total assets transferred into the Plan amounted to \$23,510,720.

- (b) Administrative Expense – Investment and certain recordkeeping fees were paid from the Plan assets. All other administrative expenses were paid for by the Credit Union.

- (c) Contributions - Contributions to the Plan were made by the participants and on a discretionary basis by the Credit Union. An individual participant could have elected to contribute between 1% - 25% of eligible compensation or a defined dollar amount not to exceed the Internal Revenue Service (IRS) limits. Participants directed their contribution into various investment options. Additional catch-up contributions were allowed for participants who reach the age of 50 before the end of the year. During 2022, the Credit Union matched 75% of the first 6% of employee deferrals for a maximum of 4.5% of an employee's eligible compensation in 2022. The Credit Union also made a safe harbor contribution equal to 3% of an employee's eligible compensation in 2022. In addition, the Credit Union made a profit sharing contribution in 2022, which is based on the following table:

- (d) Forfeitures - Forfeitures could be used to reduce any Credit Union contributions or Plan expenses. Total forfeitures used to reduce Credit Union contributions in 2022 were \$89,130. Forfeitures remaining at December 31, 2023 and 2022 were \$0.

- (e) Withdrawals and Benefits - Distributions from the Plan could have begun when a participant reaches age 62, but not earlier than April 1st of the year after the participant becomes 59 ½. Distributions were also allowed for death, disability, termination of employment, or hardship. A participant could have chosen an annuity or lump sum equal to the vested account balance.
- (f) Vesting - Participants were immediately vested with respect to their deferrals and employer safe harbor contributions. Employer discretionary contributions were subject to the following vesting schedule: Participants were 20% vested after two years of service; the vested portion increases to 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% after six years of service. A participant who died, retired at or after age 62, or who became permanently disabled, immediately became 100% vested in employer discretionary contributions.
- (g) Notes Receivable - A participant was permitted to borrow from their fund account of a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant could have no more than two loans outstanding at any time. Loans can be for no longer than a 5-year term, except for the purchase of a principal residence. Loans were repaid through payroll deductions. The interest rate on a loan was the prime rate listed in the Wall Street Journal plus 1% at the time each loan was disbursed.
- (h) Participant Accounts - Each participant's account was credited with the participant's contributions and their allocation of (a) the Credit Union's contributions and (b) Plan earnings. Plan earnings were allocated based on participants' account balances. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account. Each participant determined the investment strategy of their account as provided by the Plan.

(2) Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

- (a) Basis of Accounting - The financial statements are prepared on the accrual basis of accounting.
- (b) Investment Valuation and Income Recognition - Investments were stated at fair value, except for fully benefit-responsive investment contracts which were reported at contract value. If available, quoted market prices were used to value investments measured at fair value. Contract value was the relevant measurement attribute for that portion of the net assets available for plan benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

Summary of Significant Accounting Policies (continued)

- (c) Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (d) Risks and Uncertainties - The Plan invested in various investment instruments. Investment securities, in general, were exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities would occur in the near term and such changes could materially affect the amounts reported in the financial statements.
- (e) Payment of Benefits - Benefits were recorded when paid.
- (f) Notes Receivable from Participants - Notes receivable from participants were reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document.
- (g) Subsequent Events - The Plan evaluated subsequent events through September 18, 2024, the date the Plan's financial statements were available to be used.

(3) Income Taxes

The Plan is a prototype plan that has obtained a determination letter stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code. Generally, the plan administrator and the Plan may rely on the determination letter as to the form of the Plan qualifying under the Internal Revenue Code (except as otherwise noted in the determination letter). Additionally, the plan administrator believed that the Plan was currently being operated in compliance with the applicable requirements of the Internal Revenue Code and remains tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator had analyzed the tax positions taken by the Plan, and had concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax period in progress. The plan administrator believed it is no longer subject to income tax examinations for years before the year ended December 31, 2020.

(4) Information Certified by the Custodian

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the custodian of the Plan, certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2023 and 2022 and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2023 and 2022.

(5) Fair Value Measurements

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the closing price reported on the active market for identical assets for which the assets are traded.

Common collective trusts: If available, quoted market prices are used to value investments in the trust. The fair value of certain other investments, for which quoted market prices are not available, are valued based on yields currently available on comparable securities of issuers with similar credit ratings. There are no imposed redemption restrictions nor does the Plan have any contractual obligations to further invest in the trusts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan had a number of service providers. Such parties were considered parties-in-interest under ERISA.

(7) Investment Contract

The Plan had entered into a fully benefit-responsive investment contract. The custodian maintained the contributions in a general account. The account was credited with earnings on the underlying investments and changes for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest that is guaranteed by the Plan.

Because the guaranteed investment income contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. The guaranteed investment contract was presented on the face of net assets available for plan benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer all or a portion of their investment at contract value.

There were no reserves against contract value for credit risk of contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer. Such interest rates were reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or depletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value including: (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The Plan administrator did not believe that any events that would limit the Plan's ability to transact at contract value or cause a termination of the contract with plan participants are probable of occurring.

The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.
