**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Connecticut GI 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was a defined contribution plan established to provide retirement benefits for employees of Connecticut GI P.C. (the Company) who had at least 1 year of service and had reached the age of 21. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Merger**

As further discussed in Note 7, the assets of the Plan were transferred to another qualified defined contribution plan during 2024.

**Contributions**

Participants could contribute between 1% and 90% of compensation, as defined in the Plan, as pre-tax and/or Roth contributions. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Company did not make any nonelective or discretionary profit-sharing contributions for the period ended January 22, 2024. All contributions were subject to certain limitations imposed by the Plan and the Internal Revenue Code (the IRC).

**Participant Accounts**

Each participant's account was credited with the participant's contributions and Company contributions, and allocations of plan earnings and losses. Participant accounts were charged with an allocation of administrative expenses paid by the Plan. Allocations of Company contributions, investment income and administrative expenses were based on participants' compensation or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested accounts.

**Investment Options**

Participants could direct their contributions into any of the funds offered by the Plan, which were held at Vanguard Fiduciary Trust Company (Vanguard). These funds included a variety of investment options with various objectives and degrees of financial risk. In addition, the Plan offered a self-directed brokerage account in which participants could make investments that are not otherwise offered by the Plan. The investments in these self-directed brokerage accounts were held in trust by Vanguard.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Vesting**

Participants were immediately vested in their deferral and rollover contributions, including the earnings on those amounts. Vesting in the Company contributions portion of their accounts was based on years of continuous service. Participants were fully vested in employer contributions upon the completion of six years of service. Participants were also fully vested upon reaching normal retirement age, death or total disability.

**Notes Receivable from Participants**

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms ranged from one to five years, except for loans to purchase a primary residence, which could be offered over a term of up to ten years. The loans were secured by the balance in the participants' accounts and accrued interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator. Participants could only have one loan outstanding at any given time. Generally, principal and interest were paid ratably through payroll deductions.

**Payment of Benefits**

Upon retirement, disability, death, or termination of employment, the participant shall become entitled to the total value of his or her vested account. Distributions were paid in a lump sum or in installments over a number of years, based upon election of the participant or as defined in the Plan or the IRC. If a participant terminated employment for any reason and his or her vested account balance did not exceed \$1,000, the Plan administrator could distribute such amount in a lump-sum payment to the participant without consent of the participant. If the participant's balance was between \$1,000 and \$5,000, the Plan administrator could roll the amount into an individual retirement account on behalf of the participant without the consent of the participant. Account balances merged in from the Gastroenterology & Internal Medicine Associates LLC plan would be paid to participants in the form of a joint and survivor annuity, unless the participant elected otherwise.

The Plan also provided for in-service withdrawals by participants who had attained the age of 59½. In addition, upon financial hardship, a participant was entitled to the value of his or her deferral accounts, but not the earnings thereon, which was payable immediately in a lump-sum distribution.

**Forfeitures**

Forfeitures of discretionary matching contributions were used to reduce the Company's future matching contributions. Forfeited nonvested discretionary matching and profit-sharing accounts totaled \$-0- and \$76,672 at January 22, 2024 and December 31, 2023, respectively.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Revenue Sharing**

The Plan holds assets in a plan expense account which received deposits as a result of a revenue sharing arrangement with Vanguard. During 2023, deposits to the account totaled \$511, which are included in other income on the statement of changes in net assets available for benefits. For the period ended January 22, 2024, no revenue sharing credits were used to pay plan expenses. The revenue sharing account totaled \$-0- and \$5,327 as of January 22, 2024 and December 31, 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on the trade date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the period.

Other income represented income received from revenue sharing arrangements with Vanguard.

**Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants was recorded on the accrual basis. If a participant ceased to make loan repayments and the Plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits to participants were recorded when paid.

**Plan Expenses**

Certain expenses of maintaining the Plan were paid directly by the Company. Fees related to the administration of notes receivable from participants and distributions were charged directly to the participant's account and are included in administrative expenses. Investment-related expenses were included in net appreciation (depreciation) in fair value of investments.

**Risks and Uncertainties**

The Plan provided for various investment options. These investments were exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it was at least reasonably possible that changes in the values of investments would occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events**

Subsequent events were evaluated through October 23, 2024, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION BY THE QUALIFIED INSTITUTION**

Information presented in the accompanying statements and schedule as of January 22, 2024 and December 31, 2023, and for the period ended January 22, 2024 for investments, notes receivable from participants, investment income and interest income on notes receivable from participants was derived from information certified to be complete and accurate by Vanguard, the qualified institution, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

*Money Market and Mutual Funds:* Money market and mutual funds are valued at the quoted price of shares held by the Plan at year-end.

*Common and Collective Trust Funds:* Common and collective trust funds are composed primarily of fully benefit-responsive investment contracts and are valued at the net asset value of the units held of the collective trust. The net asset value is used as a practical expedient to estimate fair value.

There have been no changes in the methodologies used at January 22, 2024 and December 31, 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no investments held at fair value as of January 22, 2024.

There were no transfers between levels of investments during the period ended January 22, 2024.

Investments in common and collective trusts provide for daily liquidity and have no redemption features or other restrictions.

**NOTE 5 PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments were managed by affiliates of Vanguard. Vanguard is qualified institution as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Other parties-in-interest included recordkeepers and professional service firms who provide services to the Plan. Certain employees of the Company who participated in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants were also party-in-interest transactions. These party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.

**NOTE 6 INCOME TAX STATUS**

The Plan has adopted a preapproved plan document that received a favorable opinion letter from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN MERGER AND TRANSFER**

In January 2024, the Company authorized the merger and transfer of the Plan to The GI Alliance Management 401(k) Savings Plan (GI Alliance Plan). On January 22, 2024, the Plan's assets were liquidated from the trust and transferred to Fidelity Management Trust Company (Fidelity), the qualified institution of the GI Alliance Plan. The Company's 2023 employer nondiscretionary and discretionary profit-sharing contributions were deposited directly into Fidelity in 2024 and as such have been included as part of the transfer recorded during 2024.
