In 2019 when ADP processed the payroll and retirement plan for Alpha Caring Community Development Corporation, shortly afterwards, it was decided because the lack of funding to the plan, to close and terminate the retirement plan. As a follow-up in processing the form 5500-SF for 2019 and 2020, I was assured by ADP that they processed the proper forms and documents with the government agencies, that there was no need for me to process any further documents. I apologize about the delay in my response, as you can imagine things have stayed busy here.

I reviewed the notes for our conversation regarding the plan for confirmation.

From those notes, I see that the agreed upon plan was to waive the \$1500 termination fee, and 2 months of record keeping fees.

The request was submitted mid-January, which means the two months would have been January and February, therefore the March invoice was correct.

Since the plan is now terminated, no further fees will be charged to your account.

The next step is to liquidate the assets of the account.

Distribution requests are accompanied by a service charge, normally \$55.

Due to the recent measures taken in accordance with the CARES Act, you may be able to distribute these funds and avoid any further penalties, therefore limiting your expenses.
