### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Caris Healthcare, LP 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### (1) Description of plan

The following description of the Caris Healthcare, LP 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Effective January 1, 2024, the Plan was closed to new participants and no additional contributions were allowed. The Plan's participants then became eligible to participate in the National Healthcare Corporation 401(k) Plan ("NHC Plan") as of January 1, 2024. The Plan was merged into the NHC Plan and all participant account balances and Plan assets were transferred July 19, 2024.

#### (a) General

The Plan was a defined contribution plan which was adopted to provide retirement benefits for employees of Caris Healthcare, L.P. and subsidiaries (collectively, the "Plan Sponsor"). The Plan covered substantially all full-time employees who were age twenty-one or older (the "participants"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### (b) Contributions

Prior to January 1, 2024, participants were able to voluntarily make qualified retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants were also able to elect to make contributions on an after-tax basis in the form of Roth contributions. Additionally, participants were able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Participant contributions were permitted up to 100% of compensation not to exceed the maximum annual amount as determined by the IRC.

Prior to January 1, 2024, the Plan automatically enrolled all newly eligible employees at a deferral rate of 3%, unless the employee elected to not participate in the Plan or elected otherwise.

The Plan Sponsor provided a safe harbor matching contribution of 100% for the first 3% of compensation contributed by an employee and 50% for the next 2% of compensation contributed by the employee. The Plan also provided that the Plan Sponsor could make a discretionary profit sharing contribution each year; however, the Plan Sponsor made no profit sharing contributions during 2024 or 2023.

**(c) Participant accounts**

Each participant's account was credited with the Plan Sponsor's contributions as calculated above and the participant's contributions. Each participant account was credited or charged with the actual earnings (losses) of the investment options selected by the participant and an allocation of administrative expenses. Allocations of administrative expenses were based on account balances as defined in the plan agreement. Participants could change their investment options on a daily basis. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**(d) Vesting**

Participants were immediately vested in safe harbor matching contributions and their elective salary deferral plus actual earnings (losses) thereon. A participant was also 100% vested in profit sharing contributions after six years of credited service according to the following schedule:

Participants could also become 100% vested upon full or partial termination of the Plan, or in one of the following ways, if incurred while employed: (1) death, (2) disability, or (3) reaching normal retirement age of 59 1/2.

Participants became 100% vested with the merger of the Plan as described in Note (1).

**(e) Notes receivable from participants**

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their non-forfeitable account balance. The notes receivable from participants were secured by the balance in the participant's vested account and bore interest at fixed rates equal to the prime rate plus one percent, which was commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest were collected ratably through payroll deductions.

**(f) Payment of benefits**

On termination of service due to death, permanent disability, or retirement, a participant could elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant was entitled to receive only the vested interest in his or her account as a lump-sum distribution.

**(g) Forfeited accounts**

Forfeitures were created when participants terminated employment prior to becoming fully vested in the Plan Sponsor profit sharing contribution portion of their accounts and actual earnings (losses) thereon. Such forfeitures reduced the Plan Sponsor's contributions to the Plan or the administrative expenses of the Plan. At July 19, 2024 and December 31, 2023 and 2022, there were no forfeited nonvested accounts.

**(h) Hardship withdrawals**

The Plan did not permit hardship withdrawals.

**(i) Administrative expenses**

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to administrative, investment management services or recordkeeping paid from the assets of the Plan were charged to the participant accounts and were included in administrative expenses.

**(2) Summary of significant accounting policies**

**(a) Basis of accounting**

The financial statements of the Plan were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

(b) Investment valuation and income recognition

Investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividend income was recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the period and year.

(c) Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants were classified as distributions based upon the terms of the plan document.

(d) Payment of benefits

Benefits were recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after report date

The Plan Sponsor has evaluated events and transactions that occurred between July 19, 2024 and October 28, 2024, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments and notes receivable from participants reported and disclosed in the accompanying financial statements, including the fair value of investments held at July 19, 2024 and December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants for the period from January 1, 2024 through July 19, 2024 and for the year ended December 31, 2023, was obtained or derived from information supplied to the Plan Sponsor and certified as complete and accurate by The Trust Company of Tennessee ("TTCT").

### (4) Fair value measurements

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, fair value accounting standards establish a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity including quoted market prices in active markets for identical assets (Level 1), or significant other observable inputs (Level 2) and the reporting entity's own assumptions about market participant assumptions (Level 3). The Plan did not have any fair value measurements using significant unobservable inputs (Level 3) as of July 19, 2024 and December 31, 2023 and 2022.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets at fair value. There have been no changes in the methodology used at July 19, 2024 and December 31, 2023 and 2022.

- *Mutual funds*: Valued at the net asset value ("NAV") of shares held by the Plan at year end in an active market.

The method described above may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believed its valuation method was appropriate and consistent with other market participants, the use of a different methodology or assumption to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### (5) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the form of the non-standardized pre-approved profit sharing plan was acceptable under the applicable sections of the IRC. The Plan itself had not received a determination letter from the IRS stating that the Plan was qualified under Section 401(a) of the IRC. However, the plan administrator believed that the adopted non-standardized pre-approved profit sharing plan was designed and operated in compliance with the applicable requirements of the IRC and was therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor analyzed the tax positions taken by the Plan, and concluded that as of July 19, 2024 and December 31, 2023 and 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (6) Related party and party-in-interest transactions

As described in Note (1), the Plan paid expenses to various service providers which qualified as party-in-interest transactions under ERISA. The Plan also held notes receivable from participants, which also qualified as party-in-interest transactions.

### (7) Risks and uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and market risks.
