Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of K-M Industries Holding Co., Inc. Employee Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of K-M Industries Holding Co., Inc. Employee Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of K-M Industries Holding Co., Inc. approved a plan of liquidation on February 15, 2024, and management determined liquidation is imminent. As a result, K-M Industries Holding Co., Inc. Employee Retirement Savings Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2024 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of K-M Industries Holding Co., Inc. Employee Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the K-M Industries Holding Co., Inc. Employee Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General – The Plan was established on October 1, 1989, to provide retirement benefits for employees of K-M Industries Holding Co., Inc. (the Company). The Plan was a 401(k) salary deferral plan that covered substantially all employees of the Company, and was subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company was the Plan's sponsor and served as Plan administrator.

Plan termination – The Board of Directors of the Company resolved to terminate the Plan effective February 15, 2024 (Termination Date). As of the Termination Date Plan activity was frozen. After the Termination Date, no contributions, loan payments or new loans were allowed into or out of the Plan, and no distributions or rollovers were allowed subsequent to the Termination Date through April 12, 2024. Shortly after receipt of the determination letter, the Plan began the distribution process. Participant balances were distributed to participant IRA accounts or the participant's current employer's plan. All balances were distributed as of May 7, 2024. The disclosures below were applicable prior to the Termination Date.

Eligibility – Employees of the Company were eligible to participate after two months of service.

Contributions

Participant contributions – Each year, participants were able contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants were able to elect to make Roth contributions utilizing up to 75% of after-tax compensation. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were able to also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan had an auto-enrollment provision. Employees who did not opt out of the Plan within 30 days of their hire date would automatically make deferrals of 4% of pretax annual compensation.

Employer match and profit sharing contributions – The Company was able to elect to make discretionary matching and profit sharing contributions to the Plan. During the period from January 1, 2024 through May 7, 2024, the Company made matching contributions of 100% of employee contributions, up to \$1,000 annually for each participant, and the Company made no profit sharing contributions.

Contributions were subject to regulatory limitations.

Participant accounts – Each participant's account was credited with the participant's contributions and Company matching contributions as well as allocations of the Company's profit sharing contribution, if any, and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on account balances or specific participant transactions, as defined in the recordkeeping service agreement. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account. Participants directed the investment of their contributions into various investment options offered by the Plan.

Vesting – Participants were vested immediately in their contributions and employer contributions plus actual earnings thereon.

Notes receivable from participants – Participants were able to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and were secured by the balance in the participant's account. All loans had to be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case the loan would be repaid no later than 30 years. Under the terms of the Plan agreement, plan loans would bear a reasonable rate of interest determined by the Plan administrator. Principal and interest was paid ratably through payroll deductions.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant was able to elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant would receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan allowed for the automatic lump-sum distribution of participant account balances that do not exceed \$5,000. In addition, the Plan allowed for minimum required distributions and in-service withdrawals, such as rollover withdrawals and minimum age 59.5 and above withdrawals.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the liquidation basis of accounting for the period from January 1, 2024 through May 7, 2024 and the accrual method of accounting as of December 31, 2023.

Use of estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments were reported at fair value. The Plan's trustee, Fidelity Management Trust Company, certified the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price"), in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. The net appreciation in fair value of investments consisted of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Contributions – Contributions from participants and corresponding matching contributions were recorded in the year in which the employee contributions were withheld from compensation.

Notes receivable from participants – Notes receivable from participants was measured at amortized cost, which represented unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses had been recorded as of May 7, 2024 or December 31, 2023.

Payment of benefits – Benefits were recorded when paid.

Expenses – The Company has chosen to fund certain administrative costs of the Plan. The Plan assessed against an individual participant's account certain Plan expenses that are incurred by, or are attributable to, a particular participant based on use of a particular Plan service.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits, but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 28, 2024, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1), and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There had been no changes in the methodologies used at May 7, 2024 and December 31, 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV), and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust – Units held in common/collective trusts (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding.

NOTE 4 – TAX STATUS

The plan document is a prototype defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of May 7, 2024 and December 31, 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the period from January 1, 2024 through May 7, 2024.

NOTE 6 – PARTY IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan and, therefore, transactions with this entity qualify as exempt party-in-interest transactions.
