Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Romaine Electric Corporation 401(k) Retirement Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and April 30, 2023, and the related statement of changes in net assets available for benefits for the period from May 1, 2023 through December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Romaine Electric Corporation 401(k) Retirement Savings Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2023 and April 30, 2023, and for the period from May 1, 2023 through December 31, 2023 stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Romaine Electric Corporation 401(k) Retirement Savings Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE A.--DESCRIPTION OF PLAN

The following description of the Romaine Electric Corporation 401(k) Retirement Savings Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) plan established by Romaine Electric Corporation (the Company), effective May 1, 1990, and most recently amended and restated effective November 1, 2023. See also Notes C, L, and M. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees (except employees who are members of a union who bargained separately for retirement benefits during negotiations and leased employees) who have completed 90 days of service and are age eighteen or older are eligible to participate in the Plan. The entry date is the first day of the month coinciding with or next following the date the eligibility requirements are satisfied.

Contributions: Participants may contribute up to the maximum pretax amount as set by law on an annual basis, as defined in the Plan. Effective November 1, 2023 participant eligible deferrals may range from 1% to 90% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified retirement plans. Effective March 15, 2017, plan participants who became newly eligible or re-entered the plan will be automatically enrolled at 3% of compensation. Effective November 1, 2023, all participants who are eligible to make elective deferral contributions may designate all or any portion of their future deferrals as Roth elective deferral contributions. Prior to November 1, 2023, Roth contributions were not allowed.

The Company has a fixed matching contribution formula equal to 25% of the participant's deferral, not to exceed 10% of the participant's compensation. The employer matching contribution was \$59,900 for the period from May 1, 2023 through December 31, 2023, which was paid subsequent to year end.

The Company may also make a discretionary non-elective profit-sharing contribution to the Plan. The employee's share of the discretionary profit-sharing contribution, if any, will be allocated to the participant's account based on the ratio of the employee's compensation to the total compensation of all participants eligible for a share of the contribution. The allocation ordering procedure and the maximum amount allocated are described in the Plan document. The employer profit-sharing contribution was \$31,329 for the period from May 1, 2023 through December 31, 2023 and it was paid subsequent to year end.

Participants are eligible for employer matching contributions and discretionary profit-sharing contributions every December 31 (last day of Plan year), (previously April 30) if they are an active participant on that date (unless the participant died, becomes disabled, or retired during the Plan year) and have attained 1,000 or more hours of service in the Plan year. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions, allocation of employer match and discretionary profit-sharing contributions, Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant compensation, account balances or specific participant transactions, as applicable, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting: Participants are immediately vested in their rollover contributions and elective deferrals plus actual earnings thereon. Employees vest in the Company's matching and discretionary profit-sharing contributions immediately upon death or total and permanent disability, or otherwise as follows:

6 or more years	100%

Retirement: The normal retirement date is the first day of the month on or after the date the participant turns 65. Early retirement is not permitted.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum number of loans a participant may have outstanding at any one time is one loan. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. Interest rates are based on rates charged for similar types of loans by other lenders at the time of the loan. Effective November 1, 2023 interest rate is further defined as the prime rate plus 1%. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed thirty years. Principal and interest is paid through payroll deductions.

Payment of Benefits: Prior to November 1, 2023, on termination of service due to death, disability or retirement, the normal form of distribution shall be a single lump sum, or optional form of distribution including a) a fixed period installment, or b) a fixed payment installment. Effective November 1, 2023, on termination of service due to death, disability or retirement, the normal form of distribution shall be a single lump sum, substantially equal installments, or partial withdrawals provided the minimum withdrawal is \$500. Rollover contributions may be withdrawn at any time. In-service distributions are not allowed.

Payment of Benefits (Continued): For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or may continue to participate in the plan investments and benefits will be provided upon retirement or death. For terminated participants if the balance of the vested accounts is \$1,000 or less, payment will be made in a lump-sum without the participant's consent. If such balance is less than \$5,000, but greater than \$1,000, without other election, it will automatically be rolled over into an IRA established by the Company. Hardship and qualified reservist distributions are allowed in accordance with the provisions of the Plan.

Forfeitures: Forfeitures of terminated participants' non-vested account balances may be used to pay plan administrative expenses or reduce future employer matching contributions. The balance of unused non-vested account balances forfeited into the Plan as of December 31, 2023 and April 30, 2023 was \$12,197 and \$11,935, respectively.

Investment Options: Participants are allowed to direct their contributions and account balances in investment options among the investments offered under the Plan. The Plan sponsor periodically reviews the investment fund options available to participants and changes them as warranted. Participants may change their investments at any time.

Plan Expenses: Expenses of the Plan may be paid by the Company or the Plan. Certain expenses of maintaining the Plan are paid by the Company and not included in these financial statements. Fees relating to administration of notes receivable from participants and for certain withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses and revenue sharing fees are included in net appreciation (depreciation) in fair value of investments.

NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value, (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation utilizing information provided by investment advisor and custodian/trustee. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and April 30, 2023.

Payment of Benefits: Benefits are recorded when paid.

NOTE C.--INVESTMENT CONTRACT

Effective March 15, 2017, the Plan entered into an investment contract with Principal Trust Company (Principal). Principal maintains the assets of the Plan in guaranteed interest accounts and in investments in mutual funds. The guaranteed interest contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value.

As described in Note B, because the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the guaranteed interest accounts was \$49,438 and \$351,597 as of December 31, 2023 and April 30, 2023, respectively.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan that is declared quarterly. The crediting rate is 1.55% and 1.75% effective rate as of December 31, 2023 and April 30, 2023, respectively. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

NOTE C.--INVESTMENT CONTRACT (Continued)

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with Principal. Such events include termination of the contract, spin-offs, partial or total plan termination, or any other actions that will result in a 50 percent drop in funds, termination of service agreements with Principal or its affiliates, and termination of the group annuity contract. Upon occurrence of any of these events, a surrender charge, discontinuation of participation charge, or other withdrawal restrictions may apply. In the event of an employer initiated liquidation or transfer, this contract will be subject to either a 12 month advance notice or a 5% surrender charge at the option of the employer. The participant's accounts will not be affected by any such charges.

Effective November 1, 2023, the Plan terminated the contract with Principal and withdrawal restrictions of 12 months advance notice was initiated pursuant to the contract. See also Note L.

NOTE D.--CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and April 30, 2023, and net appreciation (depreciation) in fair value and contract value of investments, interest and dividend income, and interest income on notes receivable from participants, for the period from May 1, 2023 through December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company, the trustee and custodian of the Plan as of April 30, 2023 and for the period May 1, 2023 through December 31, 2023 and Reliance Trust Company (the trustee and custodian of the Plan) as of December 31, 2023 and for the period November 1, 2023 to December 31, 2023.

NOTE E.--FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and April 30, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Valued at NAV of units held by the Plan at year end. The NAV, as provided by the trustees and custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a collective trust is calculated based on a compilation of primarily observable market information. The number of units of the trust that are outstanding on the calculation date is derived from observable purchase and redemption activity in the trust.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE F.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in funds managed by the trustee and custodian, Principal Trust Company; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE G.--TAX STATUS

The Plan was amended and restated effective November 1, 2023 and adopted a non-standardized pre-approved profit-sharing/money purchase/CODA plan that received a favorable opinion letter from the Internal Revenue Service (IRS) on October 6, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

The Plan has been amended since receiving the letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

NOTE G.--TAX STATUS (Continued)

The plan administration has analyzed tax positions taken by the Plan and has concluded that as of December 31, 2023 and April 30, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H.--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan including employer contributions shall become fully vested and non-forfeitable.

NOTE I.--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE J.--OPERATIONAL ERRORS AND NONEXEMPT TRANSACTION

Employer Matching Contributions – year ended April 30, 2023

The Company initially submitted employer matching contributions of \$77,828 for the year ended April 30, 2023, but it was determined that this amount was calculated incorrectly as the compensation used for the allocation was not correct. This was corrected and the employer matching contribution for the year ended April 30, 2023 was re-calculated at \$82,208. The amount of \$4,380 was funded via forfeitures in 2024. Consistent with previous year reporting, the Form 5500 does not reflect the corrective contribution. See reconciliation of financial statements to Form 5500 at Note K. See also Note A.

Employer Matching Contributions – period from May 1, 2023 through December 31, 2023

During the period from May 1, 2023 through December 31, 2023, it was discovered that an error was made for one participant's elective deferral change request. The elective deferral change was not updated in the payroll system and was not properly included in the calculation of employer contributions. The error was discovered during the year and will be corrected with a qualified non-elective contribution (QNEC) to the affected participants account in order to remedy the error in accordance with the prescribed IRS and DOL methods during 2024.

Employer Discretionary Contributions (Profit Share) – year ended April 30, 2023

The Company submitted employer discretionary contributions (profit share) of \$36,392 for the year ended April 30, 2023, but it was determined that the allocation was calculated incorrectly as the compensation used for one employee was incorrect, therefore, the allocation of the declared contribution of \$36,392 was not correct. This was revised and the employer discretionary contributions (profit share) for the year ended April 30, 2023 was funded during the period from May 1, 2023 through December 31, 2023.

Late Remittances

As reported on the supplemental Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain plan contributions of \$13,332 for the period from May 1, 2023 through December 31, 2023 and \$66 for April 30, 2023 were not remitted to the trust within the time frame specified by the Department of Labor’s Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the period from May 1, 2023 through December 31, 2023 and year ended April 30, 2023. The Company corrected \$66 during the period from May 1, 2023 through December 31, 2023. The Company will make contributions to the affected participants’ accounts for excise tax and to compensate for potential lost earnings resulting from the delay in contributions for the nonexempt transactions during 2024 of \$13,332.

NOTE L.--CHANGE IN PROVIDERS

Pursuant to a trust termination agreement signed September 25, 2023, the contract with Principal was terminated, trust services ceased. As part of this termination, effective November 1, 2023, the Plan's assets, with the exception of \$49,438 of the Fixed Income Guaranteed Option Fund that remained with Principal Trust Company (Principal), were transferred from Principal to Reliance Trust Company, the successor trustee and custodian, and ADP Retirement Services, the new third party administrator. As part of this change, the Plan incurred a black-out period from October 1, 2023 through November 17, 2023. See also Note C.

NOTE M.--SUBSEQUENT EVENTS

Subsequent to year end effective April 22, 2024 the Plan was amended to update the special effective dates section to indicate provisions prior to this date apply prior to this date.

Subsequent to year end effective August 26, 2024 the Plan initiated amendment #2 to update the plan year to calendar year as well as to document the short plan year which began on May 1, 2023 and ended on December 31, 2023.

The Plan has evaluated subsequent events through October 15, 2024, the date the financial statements were available to be issued.
