This letter serves as explanation for late filing of the 2022 IRS Form 5500.

These returns are being filed after the filing due date, however, good cause for late filing does exist. The delay in filing is not due to lack of ordinary business care and prudence, but was instead the result of a change in service providers resulting in a misunderstanding about obtaining the necessary information to complete the filing in a timely manner. In 2022 we found it necessary to change service providers for our 401(k) Plan. The old plan was merged with a new plan and the previous administrator failed to produce a final 2022 Form 5500 showing the closing of the old plan. After receiving the notice from the IRS, our current administrator began the correction process and we are in the process of submitting the final 2022 form.

We feel that these unique factual circumstances constitute reasonable cause and hereby petition for waiver of any potential penalty or fees that might be associated with late filing.

No participant has been injured by the original oversight in filing the return, nor was there any willfulness involved in the oversight. The parties have demonstrated good faith and due diligence and have made every effort to complete the 5500 as soon as possible. There does exist reasonable cause for the late filing of this return, and we request that the Internal Revenue Service accept this letter as witness to our concern over the correcting of this oversight.
