To Whom it may concern,

I am writing this letter regarding my delay in filing a Form 5500 for my company, Trexler Communications in 2022. I am requesting that you kindly consider waving any potential penalties for this delay as I was unaware that the form wasn't filed.

For many years I was self-employed and had a 401K plan administered by Paychex. Each year, Paychex would help ensure that the form 5500 was properly filled out and filed. In September 2020, I left my company and began working for another organization due to the pandemic. I kept my 401K funds in the Paychex linked account simply out of ease. I eventually moved the funds in July 2022 and was unaware that I had to do anything further in terms of filing the Final 5500. And because I hadn't been working with Paychex for nearly two years, I didn't receive any notifications that the Final Form 5500 filing was due.

I apologize for my lack of awareness on that front, but I was caught up in my new job and not even thinking about the account.

As soon as I received notification from the IRS that the Final Form 5500 hadn't been filed, I moved quickly to get that handled.

So again, I respectfully ask that you waive any and all late fees or penalties as this was an honest oversight on my part.
