**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of AtkinsRealis US Retirement Savings Program (formerly SNC-Lavalin US Retirement Savings Program) (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

**A. General**

The Plan is a defined contribution plan that was established in 2002 by AtkinsRealis (formerly SNC-Lavalin Constructors, Inc.) and affiliated companies who have adopted the Plan (the “Company”) to provide benefits to eligible employees, as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**B. Eligibility**

The Plan specifically excludes collectively bargained employees in association with the Company, nonresident aliens with no US income, temporary and leased employees, and individuals employed by Atkins Caribe, LLP. There are no age or service requirements to enter the Plan.

**C. Participant Contributions**

Participants may elect to make pre-tax and/or Roth contributions to the Plan up to the maximum amount permitted under provisions of the Code. Participants of age 50 and older may make up additional catch-up contributions as permitted under the Code. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation. Newly hired employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled in the Plan at a pre-tax deferral rate of 3% of compensation.

Participants are also allowed to make rollover contributions of eligible amounts received from other tax-qualified employer sponsored retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s direction.

**D. Company Contributions**

The Plan provides for employer safe harbor matching contributions equal to 100% of the first 3% of compensation deferred by participants plus 50% of the next 2% of eligible compensation participants elect to defer. Employer discretionary nonelective contributions are also permitted under terms of the Plan. The Company did not make nonelective contributions for the 2023 Plan year.

**E. Participant Accounts**

Each participant’s account is credited with the participant’s contributions, rollovers, Plan earnings or losses and expenses and an allocation of Company contributions. Company matching contributions are allocated based on participant contributions. Company nonelective contributions, if any, are allocated as a uniform percentage of eligible employee compensation.

**E. Participant Accounts (Continued)**

Participants direct the investment of their accounts. The accounts of participants who do not make an affirmative investment election are invested in the Vanguard Target Retirement fund appropriate for a participant's age and projected retirement date.

**F. Vesting and Forfeitures**

Participants are immediately 100% vested in their accounts attributable to elective contributions, rollovers and Company safe harbor matching contributions. Participants vest 50% after 2 years of service and 100% after 3 years of service in accounts attributable to employer non-elective contributions. Vesting schedules that apply to certain participants are grandfathered such that terms effective January 1, 2016 are no less favorable than terms applied to participants prior to this time. Regardless of the vesting schedules, a participant will become fully vested upon death or total and permanent disability.

Forfeitures of terminated participants' non-vested accounts may be used to reduce Company contributions or to pay Plan administrative expenses. The Plan had forfeitures of \$392,019 and these were used to reduce Company contributions and pay Plan administrative expenses in 2023. The forfeiture balance was \$275,768 and \$593,506 as of December 31, 2023 and 2022, respectively.

**G. Payment of Benefits**

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability or attainment of age 59½, a participant or beneficiary may choose to maintain his or her account in the Plan or withdraw vested benefits in a lump sum. Under limited circumstances, the plan administrator may approve in-service withdrawals due to hardship. Benefits are recorded when paid.

**H. Notes Receivable from Participants**

Participant loans are permitted under the Plan. Loans are granted for a minimum of \$1,000 and may not exceed the lesser of \$50,000 or 50% of the participant's vested account balance. A loan is secured by a participant's vested account, bears interest at a reasonable rate determined by the administrator, and is repaid via payroll deductions. Notes are measured at the unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan. Notes receivable from participants at December 31, 2023 carry interest rates ranging from 3.25% to 9.50%.

**I. Expenses**

Investment fund operating expenses are incurred directly by the funds and are factored into each fund's value as a reduction in investment return. Certain administrative expenses including withdrawal and participant loan administration fees are charged directly to participants. Other costs incurred for administering the Plan may be paid by the Plan or the Company at the direction of the plan administrator.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The Plan's financial statements are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**D. Risks and Uncertainties**

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information relating to investments disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held at December 31, 2023 and 2022, and investment income for the year ended December 31, 2023, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee.

**NOTE 4 - INCOME TAX STATUS**

The Company adopted a volume submitter plan that has received a favorable opinion letter from the Internal Revenue Service stating that the form of the Plan meets requirements for tax-exempt status. The Company believes the Plan is designed and operated in accordance with and qualifies under applicable requirements of the Code and the trust, which forms a part of the Plan, is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - FAIR VALUE MEASUREMENTS**

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. Mutual funds are valued at closing market prices. Self-directed brokerage accounts include common stock and mutual funds valued at closing market prices and cash equivalents, government debt and corporate debt valued using matrices of trades in similar securities and third party pricing services. The following tables set forth Plan investments at December 31 based on the inputs used to value them:

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are nonforfeitable and will be determined as of the termination date.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investment funds are managed by affiliates of the trustees. Purchases and sales of these funds and payment of certain expenses described in Note 1-I relating to Plan administration and investment activity are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition party-in-interest transactions under ERISA.

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 15, 2024, the date the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
