Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1: DESCRIPTION OF PLAN

The following description of the Brightly Software, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. The Plan Sponsor was acquired by Siemens AG on August 3, 2022. Participants should refer to the plan document for a complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Company, and employees are eligible to participate in the Plan upon employment. The Company is the Plan Sponsor. Charles Schwab Trust Bank serves as the Plan’s trustee (the “Trustee”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Merger

On November 29, 2023, the Board of Directors of the Plan Sponsor elected to freeze the Plan, effective December 31, 2023, and to merge the Plan into the Siemens Savings Plan, effective February 1, 2024. During 2024, account balances totaling \$41,941,670 were transferred from the Brightly Software, Inc. 401(k) Plan to the Siemens Savings Plan.

Contributions

No contributions were made to the Plan with respect to compensation earned for periods on or after January 1, 2024.

Participants’ Accounts

Each participant’s account is credited with Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

The Plan provides for full and immediate vesting of participant contributions. The Plan was amended effective January 22, 2024, to provide for full and immediate vesting of the non-safe harbor matching contributions and non-safe harbor nonelective contributions for participants who were actively employed as of that date.

Forfeited Accounts

Forfeited accounts represent nonvested employer contributions of participants who have terminated their employment with the Company and are used to pay Plan administrative expenses. As of December 31, 2023, forfeited nonvested accounts totaled \$4,086. Forfeitures of \$4,087 were used to pay Plan administrative expenses during 2024 and forfeited nonvested accounts totaling \$26,483 were transferred from the Brightly Software, Inc. 401(k) Plan to the Siemens Savings Plan.

Payment of Benefits

Upon termination of service due to retirement, disability, or other reasons, a participant may elect to receive annual installments, partial payments, or a lump sum in the amount equal to the vested value of his or her account. Upon death, the Plan will pay the participant's account balance to the beneficiary in a lump sum.

A terminated employee with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. Distributions may be made at the participant's election prior to termination upon attainment of age 59½ or hardship, as defined by the plan document.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period from January 1, 2024 to February 29, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain trustee and recordkeeping fees and fees related to the administration of distributions to participants are charged directly to the participant's account. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 3: INVESTMENTS PREPARED AND CERTIFIED BY TRUSTEE

All investment information disclosed in the accompanying financial statements, including investments held as of December 31, 2023, and net appreciation in fair value of investments for the period from January 1, 2024 to February 29, 2024, was obtained or derived from information supplied to the plan administrator and certified to as complete and accurate by the Trustee.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Stable value fund - The stable value fund is a collective trust fund, the objective of which is to provide preservation of capital and relatively stable returns consistent with its comparatively low-risk profile. The stable value fund has several investment contract types in the fund. The fair value of the conventional guaranteed investment contracts included in the fund is determined using a discounted cash flow methodology in which the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end. Individual assets of the synthetic investment contracts may include domestic and foreign fixed-income securities and investments in insurance company commingled accounts or collective investment trusts. When available, the fair value of securities is based on quoted prices of identical assets in active markets. When quoted prices are not available, the first priority is to obtain prices from third-party pricing methodologies to confirm that they are utilizing observable market information. Their methodologies vary by asset class and include inputs such as estimated cash flows, benchmark yields, reported trades, broker quotes, credit quality, industry events, and economic events. The fair value of the wrap contracts included in the fund is determined using a market approach discounting methodology, which incorporates the difference between current market-level rates for contract-level wrap fees and the wrap fee being charged. The difference is calculated as a dollar value and discounted by the prevailing interpolated yield curve as of year-end. The fair value of the money market funds represents the price at which the fund believes it would be able to initiate a transaction. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner.

All Plan assets were merged into the Siemens Savings Plan as of February 29, 2024. The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2023:

NOTE 5: RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan made direct payments to the Trustee totaling \$5,137 for trustee, recordkeeping, and administrative services, which were not covered by revenue sharing. Fees incurred by the Plan for investment management services are included in net appreciation in the fair value of the investments, as they are paid through revenue sharing rather than a direct payment. The Company pays directly any other fees related to the Plan's operations.

NOTE 6: INCOME TAX STATUS

The Plan obtained its latest opinion letter dated September 21, 2020, in which the Internal Revenue Service stated that the Schwab Retirement Plan Services Non-Standardized Pre-Approved Profit Sharing Plan with cash or deferred arrangement, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state tax authorities.

NOTE 7: SUBSEQUENT EVENTS

The Plan Sponsor has evaluated subsequent events through the report date, the date the financial statements were available to be issued, and determined that no events have occurred that would require adjustment to or disclosure in these financial statements.
