**Note 1: Description of Plan**

The CBT Management LLC 401(k) Plan is a defined contribution plan that covers all eligible employees. The plan allows participants to defer a portion of their salary, with employer-matching contributions based on employee deferrals.

**Eligibility:**

Employees are eligible to participate after completing 90 days of service.

**Contributions:**

Employees may contribute up to the IRS limit of \$22,500 for the year 2023, with an additional catch-up contribution of \$7,500 allowed for participants aged 50 and older. The employer provides a 50% match on employee deferrals up to 4% of the employee's eligible compensation.

**Vesting:**

Participants are fully vested in their contributions and become 100% vested in employer-matching contributions after 3 years of service.

**Investment Income:**

Dividend income is recorded on the ex-dividend date. Interest income is recorded when earned. Gains and losses on investments are recognized both when realized and unrealized.

**Note 3: ADP Test Results and Corrective Actions**

The plan is subject to the Actual Deferral Percentage (ADP) Test to ensure that contributions by Highly Compensated Employees (HCEs) do not disproportionately exceed those made by Non-Highly Compensated Employees (NHCEs).

The plan failed the ADP test for the year 2023 due to excess contributions by Chad Brodsky, the only HCE.

Corrective actions were taken by refunding \$751.25 to Chad Brodsky on June 17, 2024. The refund was reported on Form 1099-R, and no Qualified Non-Elective Contributions (QNECs) were required for NHCEs.

**Note 4: Payment of Benefits**

Upon termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum payment. Benefits are recorded when paid.

**Note 5: Investment Valuation**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Note 6: Plan Performance**

All information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2023, and net appreciation in fair value of investments and interest and dividends, for the year ended December 31, 2023, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by the custodian of the Plan.

**Note 7: Forfeitures**

Forfeitures arise when participants terminate their employment before becoming fully vested in the employer's matching contributions. These forfeitures are reallocated according to the plan's rules.

For the year ended December 31, 2023, forfeitures totaling \$686.66 were applied to reduce plan expenses.

**Note 8: Tax Status**

The Plan has received a favorable determination letter from the IRS, stating that the Plan qualifies under Section 401(a) of the Internal Revenue Code and is therefore exempt from federal income taxes. The Plan Administrator believes that the Plan is operated in compliance with the applicable requirements of the Internal Revenue Code.
